#### INTRODUCTION

The See-Through is a direct-vent, sealed combustion gas fireplace designed for either indoor/indoor or indoor/outdoor residential applications (including screened porches and lanais). See "Minimum Clearances to Combustibles" on *Page 11*.

## NOTE: INDOOR/OUTDOOR INSTALLATIONS REQUIRE AN OUTDOOR INSTALLATION KIT (SOLD SEPARATELY).

These appliances are designed to operate on natural or propane gas. The system is switchable between standing and intermittent pilot modes.

External electrical power is required to operate these units. If the system operates on line voltage, four "AA" batteries (in receiver) can be used as a backup in case of a power outage.

#### GENERAL INFORMATION

## **WARNING**

Young children should be carefully supervised when they are in the same room as the appliance. Toddlers, young children and others may be susceptible to accidental contact burns. A physical barrier is recommended if there are at risk individuals in the house. To restrict access to a fireplace or stove, install an adjustable safety gate to keep toddlers, young children and other at risk individuals out of the room and away from hot surfaces.

These appliances are listed by PFS for installation in bedrooms, aftermarket mobile homes. and manufactured homes.

#### Misc. Codes/Standards

Installation must conform to local codes or, in the absence of local codes, with the National Fuel Gas Code, ANSI Z223.1/NFPA 54 - latest edition (in Canada, the current CAN/CSA-B149.1 installation code).

The appliance, when installed, must be electrically grounded and wired in accordance with local codes or, in the absence of local codes, with the National Electrical Code, ANSI/NFPA 70 - latest edition, or the Canadian Electrical Code. CSA C22.1 - latest edition.

Provide adequate clearances around air openings and adequate accessibility clearance for service and proper operation. Never obstruct the front or back openings of the appliance.

These appliances are designed to operate on natural or propane gas only. The use of other fuels or combination of fuels will degrade the performance of this system and may be dangerous.

The system is switchable between standing and intermittent pilot modes. External electrical power is required to operate these units. If the system operates on line voltage, four "AA" batteries (in receiver) can be used as a backup in case of a power outage.

These models come standard with a remotely modulated gas valve. The included transmitter remotely controls flame appearance and heat output (manual gas valve adjustment is not possible).

Test gauge connections are provided on the front of the electronic gas control valve (identified **IN** for the inlet and **OUT** for the manifold side).

The control valves have a 3/8" (10 mm) NPT thread inlet and outlet side of the valve. Refer to *Figure 1*.

Propane tanks are at pressures that will cause damage to valve components. Verify that the tanks have step-down regulators to reduce the pressure to safe levels.

These appliances must not be connected to a chimney or flue serving a separate solid fuel burning appliance.

These appliances must be isolated from the gas supply piping system (by closing their individual manual shut-off valve) during any pressure testing of the gas supply piping system at test pressures equal to or less than 1/2 psig (3.5 kPa).

These appliances and their individual shut-off valves must be disconnected from the gas supply piping system during any pressure testing of that system at pressures **greater than** 1/2 psig (3.5 kPa).

#### Orifice Sizes Sea Level To High Altitude (All Models)

These appliances are tested and approved for installation at elevations of 0–4500 feet (0–1372 meters) above sea level using the standard burner orifice sizes (marked with an asterisk [\*] in *Table 4*). For elevations above 4500 feet, contact your gas supplier or qualified service technician.

#### Deration

At higher elevations, the amount of BTU fuel value delivered must be reduced by either:

- using gas that has been derated by the gas company; or
- changing the burner orifice to a smaller size as regulated by the local authorities having jurisdiction and by the (USA) National Fuel Gas Code NFPA 54/ANSI Z223.1 - latest edition or, in Canada, the CAN/CSA-B149.1 codes - latest edition.

Install the appliance according to the regulations of the local authorities having jurisdiction and, in the USA, the National Fuel Gas Code NFPA

54 / ANSI Z223.1 - latest edition or , in Canada, the CAN/CSA-B149.1- latest edition.

NOTE: Flame appearance will diminish 4% per thousand feet.

## COMMONWEALTH OF MASSACHUSETTS REQUIREMENTS

These appliances are approved for installation in the US state of Massachusetts if the following additional requirements are met:

- Install this appliance in accordance with Massachusetts Rules and Regulations 248 C.M.R. Sections 4.00 through 8.00.
- Installation and repair must be done by a plumber or gas fitter licensed in the Commonwealth of Massachusetts.
- The flexible gas line connector used shall not exceed 36 inches (92 centimeters) in length..
- The individual manual shut-off must be a T-handle type valve.


#### **Massachusetts Horizontal Vent Requirements**

In the Commonwealth of Massachusetts, horizontal terminations installed less than seven (7) feet above the finished grade must comply with the following additional requirements::

- A hard-wired carbon monoxide detector with an alarm and battery back-up must be installed on the floor level where the gas fireplace is installed. The carbon monoxide detector must comply with NFPA 720, be ANSI/UL 2034 listed and be ISA certified.
- A metal or plastic identification plate must be permanently mounted to the exterior of the building at a minimum height of eight (8) feet above grade and be directly in line with the horizontal termination. The sign must read, in print size no less than one-half (1/2) inch in size, GAS VENT DIRECTLY BELOW. KEEP CLEAR OF ALL OBSTRUCTIONS.

#### New York City. New York (MEA)

Installation of these fireplaces is approved for installation in New York City, NY.



#### **COLD CLIMATE INSULATION**

For cold climate installations, seal all cracks around the appliance with noncombustible material and wherever cold air could enter the room. If the floor is above ground level, it is especially important to insulate outside chase cavity between studs and under the floor on which the appliance rests. Gas line holes and other openings should be caulked or stuffed with unfaced fiberglass insulation.

If the fireplace is being installed on a cement slab in cold climates, a sheet of plywood or other raised platform can be placed underneath to prevent cold transfer to the fireplace and into the room. It also helps to sheetrock inside surfaces and tape for maximum air tightness and caulk firestops.

## MANUFACTURED HOME REQUIREMENTS

This appliance may be installed in an aftermarket, permanently located, manufactured home and must be installed in accordance with the manufacturer's instructions and the Manufactured Home Construction and Safety Standard, Title 24 CFR, Part 3280, in the United States, or the Standard for Installation in Mobile Homes, CAN/CSA Z240 MH Series, in Canada.




Figure 2: Typical Installation/Locations

#### LOCATION

In selecting the location, the aesthetic and functional use of the appliance are primary concerns; however, vent system routing to the exterior and access to the fuel supply are also important.

CAUTION: Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies (Figure 2).




These instructions should be used as a guideline and do not supersede local codes in any way. Install venting according to local codes, these instructions, the current National Fuel Gas Code (ANSI-Z223.1) in the USA or the current standards of CAN/CSA-B149.1 in Canada.

#### **Vertical Vent Termination Clearances**

Terminate multiple vent terminations according to the installation codes listed above. Also see *Figure 3A*.

Terminate single vent caps relative to building components as shown in *Figure 3B*.



#### **Horizontal Vent Termination Clearances**




Figure 5—Horizontal vent termination clearances for buildings with combustible and noncumbustible exteriors

The horizontal vent termination must have a minimum of 3 in (76 mm) clearance to any overhead combustible projection of 2-1/2 in (64 mm) or less (see *Figure 4*). For projections exceeding 2-1/2 in (64 mm), see *Figure 4*. For additional vent location restrictions refer to *Figure 5 on Page 9*.

Note: Hearth extensions are not required with this appliance.


#### **Optional Indoor Hearth Extension**

Combustible indoor hearth material may only be installed at or below the base of the fireplace (see Figures 6 and 7).

Non-combustible indoor hearth material may be installed above the base of the fireplace and may butt against the front face of the fireplace (see Figures 6 and 7).

Also note the following:

- Combustible material may project beyond the sides of the fireplace opening, as long as it is within the shaded area shown in *Figure 10* on *Page 11*.
- Vertical installation clearances to combustible mantels vary according to the depth of the mantel (see Figure 9 on Page 11).
- Non-combustible mantels may be installed at any height above the appliance opening.




**NOTE:** A finish trim piece is shipped with your fireplace to extend the base 1/2" to be flush with the finish flanges on the side of the fireplace. This filler is shipped on top of the fireplace wrapped in foam. If desired this piece can be placed on the base of the fireplace. It is secured with bend tabs on either side. Lay the extension in front of the base then secure by bending tabs on each side over to secure to the base. While this piece is provided it is not required.

#### Optional Outdoor Hearth Extension

All outdoor hearth material (combustible and non-combustible) must be installed a **minimum of 6" (152 mm) below** the base of the fireplace (see *Figure 7*).

Also note the following:

- For vertical installation clearances to combustible outdoor mantels and overhangs, see *Page 34* and the instructions provided in the Outdoor Installation Kit (required for all outdoor installations; see *Page 36*).
- Non-combustible outdoor mantels and overhangs may be installed at any height above the appliance opening.

#### MINIMUM CLEARANCES TO COMBUSTIBLES

#### **Appliance and Vent Clearances**

The appliance is approved with zero clearance to combustible materials on both sides (as detailed in *Table 5*), with the following exceptions:

- When the unit is installed with one side flush with a wall, the wall on the other side of the unit must not extend beyond the front edge of the unit.
- In addition, when the unit is recessed, the side walls surrounding the
  unit must not extend beyond the front edge of the unit (see Figure 2

- ① 4" (102 mm) above any horizontal/inclined vent component.
- ② See **Step 1 ("FRAMING")** on **Page 12** for clearance requirements to nailing flanges on each side of unit and any adjacent screw heads.

The appliance should be mounted on a fully supported base extending the full width and depth of the unit. The appliance may be located on or near conventional construction materials; however, if installed on combustible materials, such as carpeting, vinyl tile, etc., a metal or wood barrier covering the entire bottom surface must be used.

#### Min. Height of Combustible Enclosure

To provide for the lowest possible combustible enclosure (or shelf) surface, the venting should be routed in a way to minimize obstructions to the space above the appliance. Do not insulate the space between the appliance and the area above it (see *Figure 8*).

#### Wall Finishes / Surrounds / Mantels


**Note:** Combustible wall finish materials and/or surround materials must not be allowed to encroach the area defined by the appliance front faces (black sheet metal). Never allow combustible materials to be positioned in front of or overlapping the appliance face. See **Pages 33 and 34**.


Non-combustible materials, such as surrounds and other appliance trim, may be installed on the appliance front face with these exceptions: they must not cover any portion of the removable glass panel.


Vertical installation clearances to combustible mantels vary according to the depth of the mantel (see *Figure 9*). Mantels constructed of noncombustible materials may be installed at any height above the appliance opening.

**Note:** Use high-temperature paint (rated 175°F or higher) on the underside of the mantel.

NOTE: Attic insulation shield (H3908, see Page 36) must be installed when blown or loose-fill insulation is used, and is required for all attic installations.







#### PRE-INSTALLATION STEPS

The appliance is shipped with all gas controls and components installed and pre-wired.

1. Remove the shipping carton, exposing the front glass door on the control side.

#### Barrier (see Notice, Page 27)

This fireplace comes with a barrier to reduce the likelihood of burns from touching hot glass. If the barrier is damaged, the fireplace should be turned off immediately and the fireplace must not be operated until a new, approved factory barrier for this unit is installed.

To remove barrier follow these steps.

- a.Lift barrier up by the frame at the top.
- b.Remove lower filler piece by pulling down off of the barrier.
- c.Lower barrier and push barrier to left to release right side.
- d.Pull the right side out of fireplace.
- e.Remove barrier.
- Using a Phillips screwdriver, unfasten two
   (2) screws located at the top of the glass frame (see Figure 50 on Page 31). Tilt the top of the glass frame away from the unit. Lift it carefully off the bottom door track and set the door aside, protecting it from inadvertent damage.

- Step 9. INSTALL VOLCANIC STONE, GLOWING EMBERS, AND LOGS (Page 28).
- Step 10. INSTALL GLASS DOORS, BARRIER, AND MODESTY PANEL (Page 31).
- Step 11. BURNER ADJUSTMENTS (*Page 32*): Adjust burner air shutter to ensure proper flame appearance.

FINISHING REQUIREMENTS (Page 33).

#### **DETAILED INSTALLATION STEPS**

#### Step 1. FRAMING


Frame these appliances as illustrated in *Figure* 12 on *Page* 13. All framing details must allow for a minimum clearance to combustible framing members as shown in *Table* 5 and *Figures* 8–10 on *Page* 11.

If the appliance is to be elevated above floor level, a solid continuous platform must be constructed below the appliance.

Headers may be in direct contact with the appliance top spacers but must not be supported by them or notched to fit around them. All construction above the appliance must be self-supporting, **DO NOT** use the appliance for structural support.

Secure the fireplace to the side framing members using the unit's nailing flanges — one top and bottom on each side of the fireplace front (see *Figure 13*). Use 8d nails or their equivalent.

Note: The nailing flanges, combustible members and screw heads in areas directly adjacent to the nailing flanges are EXEMPT from the 1/2-inch clearance to combustible requirements for the firebox outer wrapper. Combustible framing may be in direct contact with the nailing flanges and may be located closer than 1/2 inch from screw heads and the firebox wrapper in areas adjacent to the nailing flanges. Frame the opening to the exact dimensions specified in the framing details in these *Installation Instructions*.




#### Step 2. ROUTE GAS LINE


MOTICE: For indoor/outdoor installations, the CONTROL SIDE of the fireplace must be installed on the **INDOOR** side.

Route a 1/2" (13 mm) gas line along the inside of the right side framing as shown in Figures 14 and 15. Gas lines must be routed, constructed and made of materials that are in strict accordance with local codes and regulations.

All appliances are factory-equipped with a flexible gas line connector and 1/2-inch shutoff valve (see Step 6 on Page 26).

The incoming gas line should be piped into the valve compartment and connected in one of the two methods as shown in Figure 36 on Page 26.





#### **Proper Sizing of Gas Line**

Properly size and route the gas supply line from the supply regulator to the area where the appliance is to be installed per requirements outlined in the National Fuel Gas Code, NFPA 54 - latest edition (USA) or CAN/CSA-B149.1 - latest edition (Canada).

Never use galvanized or plastic pipe. Refer to Table 6 for proper sizing of the gas supply line, if black iron pipe is being used. Gas lines must be routed, constructed and made of materials that are in strict accordance with local codes and regulations.

#### IMPORTANT: It is critical that a licensed installer perform this step strictly per NFPA.

We recommend that a qualified, licensed plumber or gas fitter be hired to correctly size and route the gas supply line to the appliance. Installing a gas supply line from the fuel supply to the appliance involves numerous considerations of materials, protection, sizing, locations, controls, pressure, sediment, and more. Certainly no one unfamiliar and unqualified should attempt sizing or installing gas piping.

#### Notes:

- All appliances are factory-equipped with a flexible gas line connector and 1/2-inch shutoff valve (see Figure 36 on Page 26).
- See Massachusetts Requirements on Page 6 for additional requirements for installations in the state of Massachusetts in the USA.
- The gas supply line should not be connected to the appliance until Step 6 (Page 26).
- · A pipe joint compound rated for gas should be used on the threaded joints. Ensure propane-resistant compounds are used in propane applications. Be very careful that the pipe compound does not get inside the pipe.
- **Sediment Trap:** It is recommended to install a sediment trap in the supply line as close as possible to the appliance (see Figure 36 on Page 26). Appliances using propage should have a sediment trap at the base of the tank.
- · Check with local building official for local code requirements (such as whether belowgrade penetrations of the gas line allowed, etc.).

#### IMPORTANT NOTE REGARDING PROPANE INSTALLATIONS

Using a propane tank smaller than 100 lbs may create pressure loss and insufficient fuel delivery, which can cause sooting, severe delayed ignition, or other malfunctions (ref. NPFA 58).

Any damage as a result of insufficient tank size or other improper installation is NOT covered under the limited warranty.

#### Step 3. INSTALL VENT SYSTEM

#### **General Information**

These instructions should be used as a guideline and do not supersede local codes in any way. Install venting according to local codes, these instructions, the current National Fuel Gas Code (ANSI-Z223.1) in the USA or the current standards of CAN/ CSA-B149.1 in Canada.

Ensure clearances are in accordance with local installation codes and the requirements of the gas supplier.

Use only approved venting components. See "Approved Vent Components" on Page 4.

These fireplaces must be vented directly to the outside.

The vent system may not service multiple appliances and must never be connected to a flue serving a solid fuel burning appliance.

The vent pipe is tested to be run inside an enclosed wall (such as a chase). There is no requirement for inspection openings in the enclosing wall at any of the joints in the vent pipe.

#### Vent Restrictor Assembly and Installation

All vent systems require installation of a vent restrictor. A vent restrictor kit is provided with the fireplace (packaged inside the firebox) and includes one base, two wings, and four screws (see Figure 16A).

- 1. Assemble the vent restrictor components according to the type of termination and length of vent run, as shown in Figures 16B and 16C.
- **2.** Install the vent restrictor in the appliance top flue outlet, as shown in Figure 16D. The vent restrictor is held in place by friction


**Note:** When possible, install the vent restrictor through the top of the appliance vent outlet BEFORE installing the vent system. (It is possible to install the vent restrictor from inside the firebox after vent system installation; however, doing so requires removing the firebox baffle.)

#### **Vent Termination** (Vertical or Horizontal)

With the appliance secured in framing, determine whether to terminate the venting vertically (through the roof) or horizontally (through the wall).




Assembly for vertical termination with **6–10 ft** vertical runs:






Assembly for vertical termination with 11-40 ft vertical runs:





Assembly for vertical termination with 41-60 ft vertical runs:





#### Vertical (Roof) Termination Systems

This section includes configurations for vertical (roof) termination systems with either straight vertical venting (see *below* and *Page 20*) and offset vertical venting (see *Pages 18–20*). Secure Vent<sup>TM</sup> rigid vent pipe and termination components are shown in the figures.

The tables on **Page 20** summarize each system's minimum and maximum vertical and horizontal length values.


For vertical (roof) termination, the minimum vent height above the roof and/or adjacent walls is specified in ANSI Z223.1, latest edition (in Canada, the current CAN/CSA-B149.1 installation code) and by major building codes. Always consult your local codes for specific requirements. A general guide to follow is the Gas Vent Rule (see *Figure 3B on Page 8*).

## Vertical Termination System with Straight Vertical Venting

Note: If not already done, install the provided vent restrictor before proceeding (see Page 16).

Determine the number of straight vent sections required. Available straight vent sections (and their effective lengths) are listed in *Table 7*, below. See *Page 36* for all venting components.

Plan the vent lengths so a joint does not occur at the intersection of ceiling or roof joists. Refer to the "VENT SECTION LENGTHS" charts at right.


Analyze the vent routing and determine the quantities of vent sections and number of elbows required. Refer to **Vertical Termination System Figures and Tables** on *Page 20* to select the type of vertical installation desired. Vent sections are available in net lengths of 4-1/2" (114 mm), 10-1/2" (267 mm), 22-1/2" (572 mm), 34-1/2" (876 mm) and 46-1/2" (1181 mm). Refer to the **Vent Section Length Chart** on *Page 17* for an aid in selecting length combinations. Elbows are available in 90° and 45° configurations. See *Figure 21* on *Page 19* for the SV8E45 and SV8E90 elbow dimensional specifications.

Where required, a **telescopic vent section** (**SV8LA**) may be used to provide the installer with an option in installing in tight and confined spaces or where the vent run made up of fixed length pieces develops a joint in a undesirable location, or will not build up to the required length. The SV8LA Telescopic Vent Section has an effective length of from 1-1/2" (38 mm) to 6-3/4" (171 mm). The SV8LA is fitted with a dimpled end (identical to a normal vent section component) and a plain end with 3 pilot holes. Slip the dimpled end over the locking channel end of a standard SV8 vent component the required distance and secure with three screws.

Maintain a minimum 1" (25 mm) clearance to combustible materials for all vertical elements. Clearances for all horizontal elements are 4" (102 mm) on top, 1" (25 mm) on sides and 1" (25 mm) on the bottom.

#### A. Frame ceiling opening.


Use a plumb line from the ceiling above the appliance to locate center of the vertical run. Cut and/or frame an opening,  $13" \times 13"$  (330 mm x 330 mm) inside dimensions, about this center mark (*Figure 18*).



#### B. Attach vent components to appliance.

**Secure Vent™** SV8 direct-vent system components are unitized concentric pipe components featuring positive twist lock connections (*see Figure 19*).

All of the appliances covered in this document are fitted with collars having locking inclined channels. The dimpled end of the vent components fit over the appliance collar to create the positive twist-lock connection.



To attach a vent component to the appliance collar, align the dimpled end over the collar, adjusting the radial alignment until the four locking dimples are aligned with the inlet of the four inclined channels on the collar (*refer to Figure 19*). Push the vent component against the collar until it fully engages, then twist the component clockwise, running the dimples down and along the incline channels until they seat at the end of the channels.

The unitized design of the **Secure Vent** components will engage and seal both the inner and outer pipe without the need for sealant or screws. If desired, a #6 x 1/2" screw may be used at the joint, but it is not required, as the pipe will securely lock when twisted.

#### C. Attach vent components to each other.

Other vent sections may be added to the previously installed section in accordance with the requirements of the vertical vent figures and tables.

To add another vent component to a length of vent run, align the dimpled end over the inclined channel end of the previously installed section, adjusting the radial alignment until the four locking dimples are aligned with the inlets of the four incline channels of the previous section.

Push the vent component against the previous section until it fully engages, then twist the component clockwise, running the dimples down and along the incline channels until they seat at the end of the channels. This seating position is indicated by the alignment of the arrow and dimple as shown in Figure 19.

#### D. Install firestop/spacer at ceiling.

When using Secure Vent, use SV8BF firestop/ spacer at ceiling joists. If there is living space above the ceiling level, the firestop/spacer must be installed on the bottom side of the ceiling. If attic space is above the ceiling, the firestop/spacer must be installed on the top side of the joist.

Route the vent sections through the framed opening and secure the firestop/spacer with 8d nails or other appropriate fasteners at each corner. When running vertical chimney sections, remember to maintain 1" (25 mm) clearance to combustibles, framing members, and attic or ceiling insulation. Attic insulation shield (H3908) is required and may be used to help maintain the clearances indicated here. See installation accessories on *Page 36*. The gap between the vent pipe and a vertical firestop can be sealed with non-combustible caulking.


#### E. Support vertical vent run sections.

Note: Proper venting support is very important. The weight of the vent must not be supported by the fireplace in any degree.

Support the vertical portion of the venting system every 8 feet (2.4 m) above the fireplace vent outlet.

One method of support is conventional plumber's tape (not provided). Secure the plumber's tape to the framing members with nails or screws.

Loop the plumber's tape around the vent, securing the ends of the tape to the framing. If desired, use #6 x 1/2" sheet metal screws to secure the support straps to the vent pipe. See *Figure 20*.




## Vertical Termination System with Offset Vertical Venting (continued)

## F. Change vent direction to horizontal/inclined run.

At any transition to or from a horizontal/inclined run, install the elbows (**SV8E45**, **SV8E90**; see *Figure 21*) in the same manner as the straight vent sections.

The elbows feature a twist section to allow them to be routed about the center axis of their initial collar section, to align with the required direction of the next vent run element. Twist elbow sections in a clockwise direction only, to avoid the possibility of unlocking any previously connected vent section (see Figures 19 and 21).



## G. Continue installation of horizontal/inclined sections.


Continue with installation of the straight vent sections in horizontal/inclined run as described in **Step C**. Install support straps every 3 ft (914 mm) along horizontal/inclined vent runs using conventional plumber's tape (see *Page 21*, *Figure 28*).

NOTICE: It is important to install horizontal runs on a steady, (i.e., no "dips"), slightly positive incline of approximately 1/4 inch rise-per-foot (20 millimeters rise-per-meter) horizontal, in a direction away from the fireplace. (Slightly smaller rise-per-foot run ratios are acceptable.) Use a carpenter's level to measure from a constant surface, and adjust support straps as necessary.

Note: It is important to maintain the required clearances to combustibles: 1" (25 mm) at all sides for all vertical runs; and 4" (102 mm) at the top, 1" (25 mm) at sides, and 1" (25 mm) at the bottom for all horizontal/inclined runs.

#### H. Frame roof opening.


Figure 22: Roof Framing

Identify location for vent at the roof. Cut and/ or frame opening per Roof Framing Chart (see *Figure 22*).

#### I. Install roof flashing.

Extend the vent sections through the roof structure. Install the roof flashing over the vent section and position such that the vent column rises vertically (use carpenters level) (*Figure 23*). Nail along perimeter to secure flashing or adjust roofing to overlap the flashing edges at top and sides only and trim where necessary. Seal the top and both sides of the flashing with waterproof caulking.

#### J. Install storm collar.


Install the storm collar, supplied with the flashing, over the vent/flashing joint (see *Figure 23*). Loosen the storm collar screw. Slide collar down until it meets the top of the flashing. Tighten the adjusting screw. Apply non-combustible caulking or mastic around the circumference of the joint to provide a water tight seal.



#### K. Install vertical termination.

The final step involves installation of the vertical termination. Extend the vent sections to the height as shown in "Vertical Vent Termination Clearances" on *Page 8*.

The vertical termination (*Figure 24*) installs in the same manner as other **Secure Vent™** sections. Align the termination over the end of the previously installed section, adjusting the radial alignment until the four locking dimples of the termination are aligned with the inlets of the four incline channels of the last vent section. Push the termination down until it fully engages, then twist the termination clockwise, running the dimples down and along the incline channels until they seat at the end of the channels.



If the vent system extends more than 5 ft (1.5 m) above the roof flashing, stabilizers may be necessary.

Additional screws may be used at section joints for added stability.

Guide wires may be attached to the joint for additional support on multiple joint configurations.






**Note:** Two 45-degree elbows may be used in place of one 90-degree elbow. If using 45-degree elbows, follow the same rise-to-run ratios as shown for 90-degree elbows.

#### A NOTICE:

- Secure Vent Vertical Firestop/Spacer (SV8BF) must be used anywhere vent pipe passes through a combustible floor or ceiling. Secure Vent Horizontal Firestop/Spacer (SV8HF4) must be used anywhere vent pipe passes through a combustible wall.
- It is important to install horizontal runs on a steady, (i.e., no "dips"), slightly positive incline of approximately 1/4 inch rise-per-foot (20 millimeters rise-per-meter) horizontal, in a direction away from the fireplace. (Slightly smaller rise-per-foot run ratios are acceptable.) Use a carpenter's level to measure from a constant surface, and adjust support straps as necessary.







## Horizontal (Wall) Termination Systems

This section includes configurations for horizontal venting systems with horizonal termination (terminates through an outside wall) (see *Figures 31–33 on Pages 23–24*).

The tables on *Pages 23 and 24* summarize each system's minimum and maximum vertical and horizontal length values.

Note: Building codes limit or prohibit horizontal termination in specific areas. For location guidelines, see *Figure 5* on *Page 9*.

Secure Vent™ pipe applications are shown in the illustrations. Secure Vent SV8 direct-vent system components are unitized concentric pipe components featuring positive twist-lock connection (see *Figure 19 on Page 18*). The appliances covered in this document are fitted with collars having locking inclined channels. The dimpled end of the vent components fit over the appliance collar to create the positive twist-lock connection.

#### A. Plan the vent run.

Analyze the vent routing and determine the types and quantities of sections required. See *Page 17* for a list of available straight vent sections and their effective lengths (*Table 7*), as well as "VENT SECTION LENGTHS" charts. See *Page 36* for a list of all approved venting components.

Plan the vent lengths so that a joint does not occur at the intersection of ceiling or roof joists. Make allowances for elbows as indicated in *Figure 21 on Page 19*.

Maintain a minimum 1" (25 mm) clearance to combustibles on the vertical sections. Clearances for horizontal runs are 4" (102 mm) on top, 1" (25 mm) on sides, and 1" (25 mm) at the bottom.

#### B. Frame exterior wall opening.


Locate the center of the vent outlet on the exterior wall according to the dimensions shown in *Figure 12 on Page 13*. Cut and/or frame an opening 16" x 13" (406 mm x 330 mm) inside dimensions, with 10" above center and 7" below center.

#### C. Frame ceiling opening.

If the vertical route is to penetrate a ceiling, use plumb line to locate the center above the appliance. Cut and/or frame an opening, 13" x 13" (330 mm x 330 mm) inside dimensions, about this center (see *Figure 18* on *Page 18*).

#### D. Attach vent components to appliance.

To attach a vent component to the appliance collar, align the dimpled end over the collar, adjusting the radial alignment until the four locking dimples are aligned with the inlets of the four incline channels on the collar (see *Figure 19* on *Page 18*).



Push the vent component against the collar until it fully engages, then twist the component clockwise, running the dimples down and along the incline channels until they seat at the end of the channels. The unitized design of the **Secure Vent** components will engage and seal both the inner and outer pipe elements with the same procedure. Sealant and securing screws are not required.

#### E. Attach vent components to each other.

Other vent sections may be added to the previously installed section in accordance with the requirements of the vent tables. To add another vent component to a length of vent run, align the dimpled end of the component over the inclined channel end of the previously installed section, adjusting the radial alignment until the four locking dimples are aligned with the inlets of the four incline channels of the previous section. Push the vent component against the previous section until it fully engages, then twist the component clockwise running the dimples down and along the incline channels until they seat at the end of the channels. This seating position is indicated by the alignment of the arrow and dimple as shown in Figure 19 on Page 18.

#### F. Install firestop/spacer at ceiling.

When using Secure Vent, use SV8BF vertical firestop/spacer at ceiling joists. If there is living space above the ceiling level, the firestop/spacer must be installed on the bottom side of the ceiling. If attic space is above the ceiling, the firestop/spacer must be installed on the top side of the joist. Route the vent sections through the framed opening and secure the firestop/spacer with 8d nails or other appropriate fasteners at each corner.

Remember to maintain 1" (25 mm) clearance to combustibles, framing members, and attic or ceiling insulation when running vertical chimney sections.

#### G. Support the vertical run sections.

#### See Step E on Page 18.

On the vertical run, support the venting system every 8 ft (2.4 m) above the fireplace vent outlet with field provided support straps (Plumber's tape). Attach the straps to the vent pipe and secure to the framing members with nails or screws (see *Figure 20 on Page 18*).

#### H. Change vent direction.

At transition from or to a horizontal/inclined run, install the SV8E45 and SV8E90 elbows in the same manner as the straight vent sections. The elbows feature a twist section to allow them to be routed about the center axis of their initial collar section to align with the required direction of the next vent run element. Twist elbow sections in a clockwise direction only so as to avoid the possibility of unlocking any of the previously connected vent sections (see Figure 19 on Page 18).

## I. Continue installation of horizontal/inclined sections.

Continue with the installation of the straight vent sections in horizontal/inclined run as described in **Step E**. Install support straps every 3 feet (1914 mm) along horizontal/inclined vent runs using conventional plumber's tape.

See Figure 28.

NOTICE: It is important to install horizontal runs on a steady, (i.e., no "dips"), slightly positive incline of approximately 1/4 inch rise-per-foot (20 millimeters rise-per-meter) horizontal, in a direction away from the fireplace. (Slightly smaller rise-per-foot run ratios are acceptable.) Use a carpenter's level to measure from a constant surface, and adjust support straps as necessary.

It is important to maintain the required clearances to combustibles: 1"(25 mm) at all sides for all vertical runs; and 4" (102 mm) at the top, 1" (25 mm) at sides, and 1" (25 mm) at the bottom for all horizontal/inclined runs.

Use a carpenter's level to measure from a constant surface and adjust the support straps as necessary.

#### J. Assemble vent run to exterior wall.

If not previously measured, locate the center of the vent at the exterior wall. Prepare an opening as described in **Step B** (previous page). Assemble the vent system to point where the terminus of the last section is within 5 in. (127 mm) to 8-1/2 in. (216 mm) inboard of the exterior surface to which the termination is to be attached, see **Figure 30** (below) and **Table 8** (Page 23).

If the terminus of the last section is not within this distance, use the **telescopic vent section** (**SV8LA**) as the last vent section. For wall thicknesses greater than that shown in *Figure 30*, refer to *Table 8 on Page 23*. This table lists the additional venting components needed (in addition to the termination and adaptor) for a particular range of wall thicknesses.

#### K. Attach termination adaptor.

Attach the adaptor (adaptor - SV8RCH - provided with the termination) to the vent section or telescoping vent section), or elbow as shown in *Figure 29* in the same manner as any SV vent component (refer to *Step E*, *previous page*).


#### L. Install Firestop/Spacer at exterior wall.


When using the square termination, install Secure Vent<sup>TM</sup> **Firestop/Spacer** (**SV8HF4**) over the opening at the exterior side of the framing, long side up, with the 4-inch spacer clearance at the top as shown in *Figure 29*, and nail into place.

#### M. Install the Square Termination (SV8HTS4).

For the last step, from outside the exterior wall, slide the collars of the termination onto the adaptor (the outer over the outer and the inner inside the inner) until the termination seats against the exterior wall surface to which it will be attached. Orient the housing of the termination with the arrow pointed upwards. Secure the termination to the exterior wall. The horizontal termination must not be recessed into the exterior wall or siding by more than the 1-1/4" (32 mm) as shown in *Figure 30*.

IMPORTANT: The vent termination is hot while in operation and for a period of time following the use of the fireplace. Young children should be carefully supervised when they are in the same area as a hot termination.





Horizontal terminations have been designed to perform in a wide range of weather conditions. Our terminations meet or exceed industry standards.

When selecting the locations of your horizontal terminations, do not place the termination where water from eaves and adjoining rooflines may create a heavy flow of cascading water onto the termination cap. If the cap must be placed where the possibility of cascading water exists, it is the responsibility of the builder to direct the water away from the termination cap by using gutters or other means.

Take care to carefully follow these installation instructions for the termination, including the use of silicone caulking where required.

See Table 8 as an aid in venting component selection for a particular range of exterior wall thicknesses.







#### Step 4. FIELD WIRING

CAUTION: Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation.

#### **A** CAUTION

Ground supply lead must be connected to the wire attached to the green ground screw located on the outlet box. See *Figures 34* and 35. Failure to do so will result in a potential safety hazard. The appliance must be electrically grounded in accordance with local codes or, in the absence of local codes, the National Electrical Code, ANSI/NFPA 70-latest edition.


#### Electronic Wiring


(See Figures 34 and 35)

Note: The electronic appliance must be connected to the main power supply.

- 1. Route a 3-wire, 120 Vac, 60 Hz, 1ph power supply to the appliance junction box.
- 2. Remove the electrical inlet cover plate from the side of the unit by removing the plate's securing screws (see Figure 13, Page 14).
- Remove the cover plate's knockout and then feed the power supply wire through the knockout opening and into the unit junction hox
- 4. Connect the black power supply wire to the **power outlet's** red pigtail lead and the white

- power supply wire to the **common** terminal of the outlet as shown in *Figures 34 and 35*.
- 5. Connect the ground supply wire to the pigtail lead attached to outlet's green ground
- **6.** Appliance-mounted ON/OFF burner control switch (rocker switch) is factory installed.
- 7. After wiring is complete, replace the cover plate.





# Step 5. REMOVE BARRIER AND GLASS DOOR ASSEMBLY (ON CONTROL SIDE)

#### Barrier (see Notice, Page 28)

This fireplace comes with a barrier to reduce the likelihood of burns from touching hot glass. If the barrier is damaged, the fireplace should be turned off immediately and the fireplace must not be operated until a new, approved factory barrier for this unit is installed.

**NOTE**: It will be nexcessary to remove the barrier filler trim piece. Upon reinstall, insure that the tabs on the barrier filler are engaged with the slots in the base of the fireplace.

To remove barrier follow these steps.

- 1.Lift barrier up by the frame at the top.
- 2.Remove lower filler piece by pulling down off of the barrier.
- 3.Lower barrier and push barrier to left to release right side.
- 4. Pull the right side out of fireplace.
- 5. Remove barrier.

#### **Glass Door Assembly**

If not already done, remove the glass door assembly on the control side of the fireplace (see *Page 32*).

#### Step 6. CONNECT GAS LINE

All codes require a shut-off valve mounted in the supply line. The orientation of the shut-off valve should face the front. *Figure 36* illustrates two methods for connecting the gas supply. A Sediment Trap is recommended to prevent moisture and debris in gas line from damaging the valve.

The flex-line method is acceptable in the U.S.A where local codes permit; however, Canadian requirements vary depending on local codes. See *Figure 36* for flex-line description. The flex-line is rated for both natural and propane gas. A manual shut off valve is also provided with the flex-line.


The gas control valve is located on the right side of the unit.

When using solid gas line connector, access the valve by removing the glass door assembly on the control side (see *Page 31*) and the access plate (see *Figure 37*).

The electronic control valve has a 3/8" (10 mm) NPT thread gas supply inlet.

Bring the shutoff valve on the end of the flex-line over to the hard pipe and tighten with wrenches from above through the firebox opening.

Secure all joints tightly using appropriate tools and sealing compounds (ensure propaneresistant compounds are used in propane applications). Seal around gas line to prevent cold air leakage. Use sealants approved by local codes for the application.



## Test All Connections for Gas Leaks (Factory and Field)




Never use an open flame to check for leaks.

Turn on gas supply and test for gas leaks using a gas leak test solution (also referred to as bubble leak solution).

**Note:** Using a soapy water solution is an effective leak test solution but it is not recommended, because the soap residue that is left on the pipes/fittings can result in corrosion over time.

- A. Light the appliance. See the lighting instructions label in the fireplace control compartment or *Care and Operation Instructions*.
- B. Brush all joints and connections with the gas leak test solution to check for leaks. If bubbles are formed, or gas odor is detected, turn the receiver or remote control to the OFF position. Either tighten or refasten the leaking connection; then retest as described above.
- C. When the gas lines are tested and leak-free, be sure to rinse off the leak testing solution.

Note: The gas supply line must be installed in accordance with building codes by a qualified installer approved and/or licensed as required by the locality. In the Commonwealth of Massachusetts, installation must be performed by a licensed plumber or gas fitter.

## Step 7. INSTALL FIREBOX LINER PANELS

Install the ceramic or porcelain firebox liner panels per the instructions provided in the kit.

NOTICE: Liner panels must be installed before operating fireplace.

## Step 8. VERIFY APPLIANCE OPERATION

Turn on the burner, then observe the individual tongues of flame on the burner.

Make sure all ports are open and producing flame evenly across the burner.

If any ports are blocked (or partially blocked), clean out the ports.

With the gas line installed, run initial system checkout before closing up the front of the unit. Follow the pilot lighting instructions provided in the *Care and Operation Instructions*.

Note: Lighting instructions also can be found on the lighting label tied to the bracket above the gas valve. To access the tag, reach into the right side opening (see Figure 37 on Page 26).


When first lighting the appliance, it will take a few minutes for the line to purge itself of air. Once purging is complete, the pilot and burner will light and operate as indicated on *Page 32*. Subsequent lighting of the appliance will not require such purging.

Inspect the pilot flame (remove logs, if necessary, handling carefully).

#### **Appliance Checkout**


To light the burner, refer to the lighting instructions in the *Care and Operation Instructions* or the lighting label tied to the bracket above the gas valve (behind the right panel).

Make sure the igniter lights the pilot. The pilot flame should engulf the flame sensor, as shown in *Figure 38*.

## Step 9. INSTALL VOLCANIC STONE, GLOWING EMBERS, AND LOGS

- **9-1.** Remove mesh pull screens, modesty panel, and glass door assembly from one side of fireplace. See *Page 31*.
- **9-2.** Locate materials (log set, bag of glowing embers, and bags of volcanic stone).

**Note: LOGS ARE FRAGILE!** Handle with care to prevent breakage.

9-3. Install volcanic stone. Place some of the volcanic stone on the firebox floor around the grate (the entire bag of volcanic stone will NOT be used).

Note: Do NOT place volcanic stone on burner.

9-4. Prepare and install glowing embers.




Figure 39: Preparation of Glowing Ember Material





Figure 40: Placement of Glowing Ember Pieces

**Note:** This appliance is provided with enough glowing ember material for <u>several</u> applications. Do NOT use the entire contents of a new bag at one time.

a) Separate some of the glowing ember material into pieces about the size and thickness of a dime (see *Figure 39*). Keep the pieces fluffed up, not matted.



b) Distribute the dime-sized pieces over the surface of the burner, in the areas shown in *Figures 40 and 41*.

**Note:** To prevent flame impingement and soot, do not use more ember material than necessary.

c) For best glowing effect, replace ember material annually.

**Note:** Use only catalog number H8312 Glowing Embers with this fireplace.

## **A** WARNING

- DO NOT attempt to install the logs until the appliance installation has been completed, the gas line connected and tested for leaks, and the initial burner operation has been checked out.
- Logs get very hot and will remain hot up to one hour after gas supply is turned off. Handle only when logs are cool. Turn off all electricity to the appliance before you install volcanic stone, embers and logs.
- The size and position of the log set was engineered to give the appliance a safe, reliable and attractive flame pattern. Any attempt to use a different log set in the fireplace will void the warranty and will result in incomplete combustion, sooting, and poor flame quality.
- This appliance is not designed to burn wood. Any attempt to do so could cause irreparable damage to the appliance and prove hazardous to your safety.
- If logs are not installed according to the log installation instructions, flame impingement and improper combustion could occur and result in soot and/or excessive production of carbon monoxide (CO), a colorless, odorless, toxic gas.



## Step 10. INSTALL GLASS DOORS, AND MODESTY PANEL

#### **A** WARNING

HOT GLASS WILL CAUSE BURNS.
DO NOT TOUCH GLASS UNTIL COOLED.

- Install only when fireplace is OFF and COLD.
- Fireplace surfaces get EXTREMELY HOT!
- The glass on the front of the fireplace reaches EXTREMELY HIGH temperatures and can cause severe burns if touched. Even after the gas is turned off, fireplace surfaces remain extremely hot.

#### **A** CAUTION

## RISK OF PERSONAL INJURY OR PROPERTY DAMAGE.

- Do NOT abuse glass doors by striking or slamming shut
- Never operate fireplace with glass door assemblies removed.

These direct-vent appliances are designed to operate only when both glass door assemblies are installed. Generally, the glass door assemblies should not be removed, except when access to components within the firebox is required.

- Securely tighten door latch screws when reinstalling glass door assemblies to prevent doors from falling out.
- Handle glass door assemblies with extreme care. Replace damaged glass door assemblies with approved replacement assemblies only.

The door assemblies on this fireplace contain ceramic glass. Handle with care to prevent damage. If the door frame or glass on either assembly becomes damaged, replace the entire glass door assembly with a manufacturer-approved replacement assembly only. Do not attempt to substitute any materials used on door assemblies or replace cracked or broken glass with any other materials.

- Only doors certified with the appliance shall be used.

## Installing Glass Doors, and Modesty Panel

(see Figure 50)

Note: These instructions do <u>NOT</u> apply to the <u>Outer Glass Door</u> provided in the Outdoor Kit (for indoor/outdoor installations).

- 1) Install one of the glass doors, as follows:
  - Retrieve the glass door. Visually inspect the gasket on the back of the frame. Gasket surface must be clean, free of irregularities, and seated firmly.
  - b) Position the door in front of the firebox opening, with the top of the door held away from the fireplace (see *Figure 50*).
  - c) Lower the bottom of the door assembly onto the bottom door track, engaging and centering it in the base channel, and then gently swing the door up.
  - d) Using a #3 Phillips screwdriver, fasten the door frame to the door latches with the two (2) latch screws. The latches should pull forward to engage the door frame.

## Note: Securely tighten latch screws when reinstalling glass door assembly.

- 2) Install the modesty panel on the top flange of the glass door, as follows:
  - a) Grasp the modesty panel with both hands (with the open hem facing down).
  - Engage it with the top flange of the glass door frame by pushing it all the way down. Make sure the installed modesty panel is firmly in place.

#### Removing Glass Doors, Barrier, and Modesty Panel (see *Figure 50*)

#### 1) Remove Barrier (see Notice, Page 29)

This fireplace comes with a barrier to reduce the likelihood of burns from touching hot glass. If the barrier is damaged, the fireplace should be turned off immediately and the fireplace must not be operated until a new, approved factory barrier for this unit is installed.

To remove barrier follow these steps.

- a.Lift barrier up by the frame at the top.
- b.Remove lower filler piece by pulling down off of the barrier.
- c.Lower barrier and push barrier to left to release right side.
- d.Pull the right side out of fireplace.
- e.Remove barrier.
- f. Install the new, approved factory barrier with flat side of barrier toward firebox (if appropriate)
- Remove the modesty panel from the top flange of the glass door by firmly pulling up on it with both hands until it is disengaged.
- 3) Remove one of the glass doors, as follows:
  - a) See Figure 50. While holding the top of the glass door frame in place, use a #3 Phillips screwdriver to remove the two (2) screws securing the door frame to the two (2) door latches.
  - b) Carefully tilt the top of the glass door frame away from the unit (as shown in *Figure 50*), and then lift the door assembly up and out of the lower track.
  - c) Carefully place the glass door assembly on a padded surface in a safe location to prevent damage.

#### Step 11. BURNER ADJUSTMENTS

#### Flame Appearance and Sooting

Proper flame appearance is a flame that is blue at the base and becomes yellowish-orange in the body of the flame. When the appliance is first lit, the entire flame may be blue and will gradually turn yellowish-orange during the first 30 minutes of operation. After 30 minutes of operation, if the flame is blue, or if the flame is orange with evidence of sooting (black tip), the air shutter opening may need to be adjusted.

If the air shutter opening is closed too far, sooting may develop. Sooting is indicated by black puffs developing at the tips of very long orange flames. Sooting results in black deposits forming on the logs, appliance inside surfaces and on exterior surfaces adjacent to the vent termination.

Sooting is caused by incomplete combustion in the flames and lack of combustion air entering the air shutter opening. To achieve a warm yellowish-orange flame with an orange body that does not soot, the shutter opening must be adjusted between these two extremes.

#### **Air Shutter Adjustment Guidelines**

- If there is smoke or soot present, first check the log set positioning to ensure that the flames are not impinging on any of the logs.
   If the log set is properly positioned and a sooting condition still exists, then the air shutter opening should be increased.
- The more offsets in the vent system, the larger the air shutter opening will need to be.
- An appliance operated with the air shutter opened too far, may have flames that appear blue and transparent. These weak, blue and transparent flames are termed anemic.
- Propane models may exhibit flames which candle or appear stringy. If this is present and persists, adjust the air shutter to a more OPEN position, then operate the appliance for a few more minutes to ensure that the flame normalizes and the flames do not appear sooty.

The following chart is provided to aid you in achieving the correct air shutter adjustment for your installation.

Air Shutter Adjustment Guidelines:				
Amount of Primary Air	Air Shutter Adjustment			
If air shutter is closed too far	Flame will be orange	Air shutter gap should be increased		
If air shutter is open too far	Flame will be blue	Air shutter gap should be decreased

- Air shutter adjustment should only be performed by a qualified professional service technician.
- Soot will be produced if the air shutter is closed too much. Any damage due to carboning resulting from improperly setting the air shutter is <u>not covered</u> under the warranty.

- Light the appliance (follow lighting procedure in Care and Operation Instructions or on lighting label in control compartment).
- Allow the burner to operate for at least 30 minutes while continuously observing the flame to ensure that the proper flame appearance has been achieved (see *Figures* 51 and 52).




Figure 51: Burner Flame Appearance — Control Side

- 3. Adjust the air shutter using the lever on the lower right side of the firebox (*Figure 51*).
  - For more OPEN air shutter, slide lever to the RIGHT.
  - For more CLOSED air shutter, slide lever to the LEFT.

A minimum shutter setting is designed into the venturi by four 1/16" tabs.

- If the flame appears weak or sooty (as described on the previous page), adjust the air shutter until proper flame appearance is achieved.
- If flame stays lowered blue, incrementally adjust the air shutter to a more CLOSED position until proper flame appearance is achieved.

**Note:** See **Figures 51 and 52** for proper burner flame appearance.


Figure 56: Exterior Clearances

#### OUTDOOR BARRIER INSTALLATION INSTRUCTIONS

Note: This procedure requires two people.

- Step 1. If the fireplace is on, turn it OFF. Allow it to cool completely.

  BEFORE CONTINUING, FIREPLACE MUST BE OFF AND COLD!
- Step 2. Remove the two existing screws from the top of the Front Glass Panel.

Note: After removing screws, one person must hold the glass panel in place (to prevent it from falling forward and breaking), while another person completes the installation.

- Step 3. Insert the back lip of each Mounting Bracket (without the hole) under the bottom edge of the Glass Panel.
- Step 4. Attach one Spring Nut Clip (with straight edge facing front and down) to the front lip of each Mounting Bracket, and then align the holes.
- Step 5. Slide the openings in the bottom edge of the Outdoor Barrier over the Spring Nut Clips.
- Step 6. Align the holes in the top of the Outdoor Barrier with the holes in the top of the Front Glass Panel. Use a Phillips screwdriver to replace the two screws previously removed.

Align the holes in the lower front of the Outdoor Barrier with the holes in the Clips and Brackets. Use a Phillips screwdriver to install the two supplied Washer Screws.

#### Step 12. ATTACHING SAFETY-IN-OPERATION WARNINGS

It is the installer's responsibility to ensure these warnings are properly affixed during installation. These warning labels are a critical step in informing consumers of safe operation of this appliance.

## ATTACHING SAFETY-IN-OPERATION WARNINGS

It is required that the set of safety instruction labels that have been furnished with the fireplace be affixed to the operation and control points of the fireplace. If unknown, affix the English language label.
- Locate the remote control transmitter and clean it thoroughly to remove any dust and oils. Affix the label to the surface of handheld transmitter (*Figure B*). Choose the language primarily spoken in the home. If unknown, affix the English language label.
- If you are unable to locate the labels, please call Innovative Hearth Products or your nearest Innovative Hearth Products dealer to receive additional safety instruction labels free of charge.



If they are not affixed at these spots, locate the multi-lingual adhesive labels provided with these instructions and proceed as follows:

- Locate the wall receiver that controls the fireplace (verify the switch operates the fireplace by turning it on and off). Clean the wall receiver plate thoroughly to remove any dust and oils. Affix the label to the surface of the plate of the wall receiver that controls the fireplace (*Figure A*). Choose the language primarily spoken in the home.
- Locate the remote control transmitter and clean it thoroughly to remove any dust and oils. Affix the label to the surface of handheld transmitter (Figure B). Choose the language primarily spoken in the home.



### APPLIANCE INSTALLATION, SERVICE, AND MAINTENANCE NOTICES

IMPORTANT: Improper installation, adjustment, alteration, service, or maintenance can cause injury or property damage. Refer to this manual. For assistance or additional information, consult a qualified installer, service agency or the gas supplier.

Only trim kit(s) supplied by the manufacturer shall be used in the installation of this appliance.

Draft relief openings must not be covered or blocked.

These appliances must not be connected to a chimney or flue serving a separate solid fuel burning appliance.

Any change to this appliance and/or its operating controls is dangerous. Improper installation or use of this appliance can cause serious injury or death from fire, burns, explosion or carbon monoxide poisoning.

CARBON MONOXIDE POISONING: Early signs of carbon monoxide poisoning are similar to the flu with headaches, dizziness and/or nausea. If you have these signs, obtain fresh air immediately. Turn off the gas supply to the appliance and have it serviced by a qualified professional, as it may not be operating correctly. Some people are more affected by carbon monoxide than others, including pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

Do not operate appliance with the glass front removed, cracked, or broken.

These fireplaces are vented gas appliances. Do not burn wood or other material in these appliances.

This appliance is only for use with the type of gas indicated on rating plate. This appliance is not convertible for use with other gases, unless a certified kit is used.

These appliances are designed to operate on natural gas or propane gas only. The use of other fuels or combinations of fuels will degrade the performance of this system and may be dangerous.

Provide adequate clearances around air openings and adequate accessibility clearance for service and proper operation. Never obstruct the front openings of the appliance.

Do not use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control that has been under water.

These fireplaces are designed as supplemental heaters. Therefore, it is advisable to have an alternate primary heat source when installed in a dwelling.

### WARRANTY INFORMATION

Your gas appliance is covered by a limited twenty-year warranty. You will find a copy of the warranty accompanying this manual. Please read the warranty to be familiar with its coverage.

Retain this manual. File it with your other documents for future reference.

Failure to comply with the installation and operating instructions provided will result in an improperly installed and operating appliance, voiding its warranty.

Do not attempt to alter or modify the construction of the appliance or its components. Any modification or alteration may void the warranty, certification, and listings of this unit.

### GENERAL INFORMATION

The fireplace models covered in this manual are direct-vent, sealed combustion, gas fireplaces designed for residential application. Direct-vent appliances operate with the combustion chamber completely isolated from the indoor environment.

All air for combustion is brought in from the outside, and exhaust gases are vented through the same direct-vent, coaxial (intake/exhaust) vent system.

These appliances are designed to operate on natural or propane gas. The system is switchable between standing and intermittent pilot modes. External electrical power is required to operate these units. If the system operates on line voltage, four (4) "AA" batteries (in receiver) can be used as a backup in case of a power outage.

These models come standard with a remotely modulated gas valve. The included transmitter remotely controls flame appearance and heat output (manual gas valve adjustment is not possible).

These appliances comply with National Safety Standards and are tested and listed by PFS (Report No. F14-107) to ANSI Z21.88 (in Canada, CSA-2.33), and CAN/CGA-2.17-M91 (CSA P4.1) in both USA and Canada, as vented gas fireplace.

The installation must conform to local codes or, in the absence of local codes, with the National Fuel Gas Code, ANSI Z223.1/NFPA 54 - latest edition, or the Natural Gas and Propane Installation Code, CAN/CSA-B149.1 - latest edition. The appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the National Electrical Code, ANSI/NFPA 70 - latest edition, or the Canadian Electrical Code, CSA C22.1 - latest edition.

Test gauge connections are provided on the front of the gas control valve, identified IN for the inlet and OUT for the manifold side (see *Figure 57* on *Page 40*). The control valve has a 3/8" (10 mm) NPT thread inlet and outlet side of the valve.

These appliances must be isolated from the gas supply piping system (by closing their individual manual shut-off valve) during any pressure testing of the gas supply piping system at test pressures equal to or **less than** 1/2 psig (3.5 kPa).

These appliances and their individual shut-off valves must be disconnected from the gas supply piping system during any pressure testing of that system at pressures **greater than** 1/2 psig (3.5 kPa).

### Orifice Sizes: Sea Level to High Altitude (All Models)

These appliances are tested and approved for installations at elevations of 0–4500 feet (0–1372 meters) above sea level using the standard burner orifice sizes (marked with an asterisk [\*] in *Table 12*).

At the time of installation, it must be determined if the appliance needs to be derated. Contact your local gas supplier for deration requirements for your area.

### Deration

At higher elevations, the amount of BTU fuel value delivered must be reduced by either using gas that has been derated by the gas company or by changing the burner orifice to a smaller size as regulated by the local authorities having jurisdiction and by the (USA) National Fuel Gas Code NFPA 54/ANSI Z223.1 - latest edition or, in Canada, the CAN/CSA-B149.1 codes - latest edition.

### **Burn-in Period**

During the first few fires of this appliance there will be some odor due to the curing of the paint and burning off of lubricants used in the manufacturing process. Depending on your use, the burn-in period may take a few hours or a few days.

KEEP YOUR HOUSE WELL VENTILATED DURING THE CURING PROCESS. THE ODOR AND HAZE EMITTED DURING THE CURING PROCESS CAN BE QUITE NOTICEABLE AND MAY SET OFF A SMOKE DETECTOR.

### **NOTICE:**

A white film may develop on the glass enclosure panel during the first few fires as part of the burn-in process.

The first few times you use the fireplace, clean the glass after each use (AFTER THE GLASS HAS COMPLETELY COOLED); otherwise, the white film will bake onto the glass and become difficult to remove.

### OPERATION AND CARE OF YOUR APPLIANCE

# **WARNING**

Young children should be carefully supervised when they are in the same room as the appliance. Toddlers, young children and others may be susceptible to accidental contact burns. A physical barrier is recommended if there are at risk individuals in the house. To restrict access to a fireplace or stove, install an adjustable safety gate to keep toddlers, young children and other at risk individuals out of the room and away from hot surfaces.




### **Remote Control System**

The Remote and Receiver allows you to command the functions of your fireplace from the comfort of your chair. It is configured to control the On/Off primary burner operation and flame levels (through six levels) and provide On/Off and Smart control of this appliance.

The receiver connects directly to the gas valve, stepper motor with and umbilical cord wiring harness (see wiring diagram on *Page 51*).

The Receiver is powered by 4 AA type batteries, located within.

The Receiver accepts commands via radio frequency from the Transmitter and does not require line-of-sight operation.

The Receiver three position slider switch can be set to one of three positions: ON (Manual Override), REMOTE (Remote Control), or OFF.

### Initializing the System for the First Time

Install the 4 AA batteries into the receiver battery bay (behind the wall switch plate).

**Note:** Install the batteries into the battery bay as indicated on the battery cover. Ensure that batteries are installed with proper polarity (+/-).

Place the three position slider switch in the "Remote" position (see Figure 59, next page). Using the end of a paper clip, or other similar object, insert the end of the paper clip into the hole marked "PRG" on the Receiver front cover. The Receiver will "beep" three (3) times to indicate that it is ready to synchronize with a Transmitter.

Install the 3 AAA type batteries in the Transmitter battery bay, located on the base of the Transmitter. With the batteries already installed in the Transmitter, push the ON button. The Receiver will "beep" four times to indicate the Transmitter's command is accepted and sets to the particular code of that Transmitter. The system is now initialized.

### **Low Battery Power Detection**

The life span of the Receiver batteries depends on various factors: quality of the batteries used, the number of ignitions of the appliance, the number of changes to the room temperature set point, etc.

When the Receiver batteries are low, no "beep" will be emitted from the Receiver when it receives an ON/OFF command from the Transmitter. This is an alert for a low battery condition for the Receiver. When the batteries are replaced the "beep" will be emitted from the Receiver when the ON/OFF key is pressed (See "Initializing the System for the First Time," at left).

When the transmitter batteries are low, a battery icon will appear on the LCD display of the transmitter before all battery power is lost. When the batteries are replaced this icon will disappear.

### **WARNING**

Fire Hazard. Can cause severe injury or death. The receiver causes ignition of the appliance. The appliance can turn on suddenly. Keep away from the appliance burner when operating the remote system or activating manual bypass of the remote system.

CAUTION: Property damage hazard. Excessive heat can cause property damage. The appliance can stay lit for many hours. Turn off the appliance if it is not going to be attended for any length of time. Always place the Transmitter where children can not reach it.

### **Temperature Indicator Display**

With the system in the "OFF" position, press the Room Temperature Key and the Mode Key at the same time (see Figure 60, next page). Look at the LCD screen on the Transmitter to verify that a C or F is visible to the right of the Room Temperature display (see Figure 61, next page).

### **Turn On The Appliance**

With the receiver switch in the "Remote" position, press the ON/OFF Key on the Transmitter. The Transmitter display will show all active Icons on the screen. At the same time, the Receiver connects to the gas valve coil and the appliance main burner turns on. A single "beep" from the Receiver will confirm reception of the command.

### **Turn Off The Appliance**

Press the ON/OFF Key on the Transmitter. The Transmitter LCD display will only show the room temperature and Icon. At the same time, the Receiver disconnects the gas valve coil and the appliance burner turns off. A single "beep" from the Receiver confirms reception of the command.

### Remote Flame Control

The system has six (6) flame levels. See *Figure 62 (next page)* for an example. With the system on, and the flame level at the maximum in the appliance, pressing the Down Arrow Key once will reduce the flame height by one step until the flame is turned off.

The Up Arrow Key will increase the flame height each time it is pressed. If the Up Arrow Key is pressed while the system is on but the flame is off, the flame will come on in the high position (see *Figure 63, next page*). A single "beep will confirm reception of the command.

### **Key Lock**


This function will lock the keys to avoid unsupervised operation To activate this function, press the MODE and UP keys at the same time. To de-activate this function, press MODE and UP Keys at the same time.

### Intermittent/Standing Pilot Mode


This fireplace can be switched from intermittent ignition to a standing pilot simply by toggling the switch located in the control compartment (refer to Figure 57 on Page 41). To save energy, switch to intermittent mode. To have a standing pilot which will help startup in the winter by warming the flue and the glass, switch to standing pilot. The standing pilot mode is indicated by a pilot that comes on and remains lit when the fireplace is off.


### Manual Bypass Of The Remote System


If the batteries of the Receiver or Transmitter are low or depleted, the appliance can be turned on manually by sliding the three position slider switch to the ON position. This will bypass the remote control feature of the system and the appliance main burner will come on if the gas valve is in the "On" position.











### MAINTENANCE

### (See Maintenance Schedule, *Page 56*)

Refer to the maintenance schedule for maintenance tasks, procedures, frequency and by whom they should be performed. Always verify proper operation of the appliance after servicina.

Turn off gas and electrical power to the fireplace and allow it to cool before cleaning or servicing the appliance.

**CAUTION:** Wear gloves and safety glasses for protection while doing required maintenance.

### **Inspect Venting System**

The appliance and venting system should be thoroughly inspected before initial use and at least annually by a qualified service technician (inspection should include ensuring that exhaust or intake passages are unobstructed and vent components are properly assembled and not damaged). Homeowner must contact a qualified service technician at once if any abnormal condition is observed.

If the venting system is disassembled for any reason, a qualified service technician should follow vent installation instructions for proper reassembly and proper sealing of the venting system components. However, more frequent periodic inspections and cleanings should be performed by the homeowner.

### **Glass Cleaning**

(For detailed glass door assembly removal/ installation instructions, see Page 44.)

Note: Clean glass after first two weeks of

operation (after burn-in period is over) and then only when necessary and ONLY WHEN THE APPLIANCE IS COOL. Wipe surface with clean, dampened, soft cloth, Follow with dry, soft towel as desired. Take care not to scratch the glass surface.

### IMPORTANT: Do not use abrasive cleaners on glass. Never clean the glass when it is hot.

Clean the glass periodically, to remove any buildup caused by the following:

- Filmy coating (during initial use after installation). Initial curing of the high temperature paint and burning off of lubricants used in the manufacturing process may result in a filmy coating on the glass.
- Dusty or dirty buildup. It is normal for condensation and fog to form on the inside of the glass when first starting the appliance. This condensation and fog will usually disappear within a few minutes; however, over time the moisture can cause lint, dust, and other airborne particles to cling to the glass surface.
- White coating. A white coating may form on the glass as a result of impurities and minerals in the fuel.

It is recommended that the glass be cleaned two or three times during each heating season, depending on the circumstances. The following cleaning solutions are approved for use to clean the glass:

- · Non-ammonia based household cleaner
- 50% white vinegar and 50% water
- · Gas fireplace/stove glass cleaner

### Barrier (see Notice, Page 26)

NOTE: Make sure fireplace is OFF and unit is COLD before removing barrier

To remove barrier follow these steps.

- 1.Lift barrier up by the frame at the top.
- 2. Remove lower filler piece by pulling down off of the barrier.
- 3.Lower barrier and push barrier to left to release right side.
- 4. Pull the right side out of fireplace.
- 5.Remove screen.
- 6. Install the new, approved factory barrier with flat side of screen toward firebox.

### **Inspect Glass Gasket**

Visually inspect the gasket on the backside of the glass enclosure panels. The gasket surface must be clean, free of irregularities and seated firmly.

### **Clean Control Compartment**

Keep control compartment clean by vacuuming or brushing at least twice a year. More frequent cleaning may be required due to excessive lint from carpeting, bedding materials, etc. It is important that control compartments, burners and circulating air passageways of the appliance be kept clean.

### Clean Logs and Burner

Carefully remove the logs (use care when handling the fiber logs, as they become quite fragile after curing). Vacuum out any foreign matter (lint, carbon, etc.) on the burner. Ensure the burner ports are "open." Remove any carbon deposits from the under side of the logs using a vacuum cleaner, or a soft bristled brush (i.e. paint brush).

**Note:** Improper positioning of logs can create carbon build-up and will alter the performance of the appliance.

### Replacing Logs

If the logs become damaged by accident or improper handling and need replacement, use only the proper replacement logs from manufacturer (see Pages 51, 58, and 59 for ordering information).

### Reinstall Embers, Volcanic Stone, and Logs

Carefully follow placement instructions on Pages 46-48). All logs should fit onto corresponding pins and/or log stoppers. This will ensure a proper flame and safe combustion.

### **Inspect Wiring**

Refer to wiring diagram on Page 51.

CAUTION: Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation. Verify proper operation after servicing.

Inspect and clean all wire connections. Ensure that there is no melting or damage. Inspection should include:

### **Inspect Burner Flame Appearance**

Ensure that the burner flame appearance resembles the flame shown in Figures 76 and 77 and as described in Flame Appearance and Sooting on Page 49. The homeowner must contact a qualified service technician at once if any abnormal condition is observed.

### Small Area Paint Touch-up

Only use a factory supplied paint kit for touchups. Paint is available at your local Innovative Hearth Products dealer. Never attempt to paint a hot fireplace.

If the surface later becomes stained or marred, it may be lightly sanded and touched up with spray paint.

# REMOVAL AND INSTALLATION OF GLASS DOORS, MESH PULL SCREENS, AND MODESTY PANEL

# **A** WARNING

HOT GLASS WILL CAUSE BURNS.
DO NOT TOUCH GLASS UNTIL COOLED.

- Install only when fireplace is OFF and COLD.
- Fireplace surfaces get EXTREMELY HOT!
- The glass on the front of the fireplace reaches EXTREMELY HIGH temperatures and can cause severe burns if touched. Even after the gas is turned off, fireplace surfaces remain extremely hot.

- Do NOT abuse glass doors by striking or slamming shut
- Never operate fireplace with glass door assemblies removed.

These direct-vent appliances are designed to operate only when both glass door assemblies are installed. Generally, the glass door assemblies should not be removed, except when access to components within the firebox is required.

- Securely tighten door latch screws when reinstalling glass door assemblies to prevent doors from falling out.
- Handle glass door assemblies with extreme care. Replace damaged glass door assemblies with approved replacement assemblies only.

The door assemblies on this fireplace contain ceramic glass. Handle with care to prevent damage. If the door frame or glass on either assembly becomes damaged, replace the entire glass door assembly with a manufacturer-approved replacement assembly only. Do not attempt to substitute any materials used on door assemblies or replace cracked or broken glass with any other materials.



# Removing Glass Doors, Barrier, and Modesty Panel (see Figure 8)

- 1) Remove the barrier as follows:
  - a) Lift barrier up by the frame at the top.
  - b) Remove lower filler piece by pulling down
  - c) Lower barrier and push barrier to left to release right side.
  - d) Pull the right side out of fireplace.
  - e) Remove barrier.
- Remove the modesty panel from the top flange of the glass door by firmly pulling up on it with both hands until it is disengaged.
- 3) Remove one of the glass doors, as follows:
  - a) See Figure 8. While holding the top of the glass door frame in place, use a #3 Phillips screwdriver to remove the two (2) screws securing the door frame to the two (2) door latches.
  - b) Carefully tilt the top of the glass door frame away from the unit (as shown in *Figure 8*), and then lift the door assembly up and out of the lower track.



 c) Carefully place the glass door assembly on a padded surface in a safe location to prevent damage.

Do not operate appliance with the glass front removed, cracked or broken.

Installing Glass Doors, Barrier, and Modesty Panel (see *Figure 8*)

Note: These instructions do <u>NOT</u> apply to the <u>Outer Glass Door</u> provided in the Outdoor Kit (for indoor/outdoor installations).

- Only doors certified with the appliance shall be used.

- 1) Install one of the glass doors, as follows:
  - a) Retrieve the glass door. Visually inspect the gasket on the back of the frame.

  - c) Lower the bottom of the door assembly onto the bottom door track, engaging and centering it in the base channel, and then gently swing the door up.
  - d) Using a #3 Phillips screwdriver, fasten the door frame to the door latches with the two (2) latch screws. The latches should pull forward to engage the door frame.

# Note: Securely tighten latch screws when reinstalling glass door assembly.

- 2) Install the modesty panel on the top flange of the glass door, as follows:
  - a) Grasp the modesty panel with both hands (with the open hem facing down).
  - b) Engage it with the top flange of the glass door frame by pushing it all the way down. Make sure the installed modesty panel is firmly in place.

# PLACEMENT OF VOLCANIC STONE, GLOWING EMBERS, AND LOGS

- Remove glass door and mesh pull screens from one side of fireplace only (see *Page 12*).
- Locate materials (log set, bag of glowing embers, and bags of volcanic stone).

**Note:** LOGS ARE FRAGILE! Handle with care to prevent breakage.

Install volcanic stone. Place some of the volcanic stone on the firebox floor around the grate (the entire bag of volcanic stone will NOT be used).

Note: Do NOT place volcanic stone on burner.

4. Prepare and install glowing embers.

**Note:** This appliance is provided with enough glowing ember material for <u>several</u> applications. Do NOT use the entire contents of a new bag at one time.

a) Separate some of the glowing ember material into pieces about the size and thickness of a dime (see Figure 9). Keep the pieces fluffed up, not matted.

A

IMPORTANT! Ember pieces must be as SMALL and THIN as a dime.

b) Distribute the dime-sized pieces over the surface of the burner, in the areas shown in *Figures 10 and 11*.

**Note:** To prevent flame impingement and soot, do not use more ember material than necessary.

c) For best glowing effect, replace ember material annually.

**Note:** Use only catalog number H8312 Glowing Embers with this fireplace.

# WARNING

- DO NOT attempt to install the logs until the appliance installation has been completed, the gas line connected and tested for leaks, and the initial burner operation has been checked out.
- Logs get very hot and will remain hot up to one hour after gas supply is turned off. Handle only when logs are cool. Turn off all electricity to the appliance before you install volcanic stone, embers and logs.
- The size and position of the log set was engineered to give the appliance a safe, reliable and attractive flame pattern. Any attempt to use a different log set in the fireplace will void the warranty and will result in incomplete combustion, sooting, and poor flame quality.
- This appliance is not designed to burn wood. Any attempt to do so could cause irreparable damage to the appliance and prove hazardous to your safety.
- If logs are not installed according to the log installation instructions, flame impingement and improper combustion could occur and result in soot and/or excessive production of carbon monoxide (CO), a colorless, odorless, toxic gas.




Figure 65: Preparation of Glowing Ember Material





Figure 66: Placement of Glowing Ember Pieces



# BURNER ADJUSTMENTS (QUALIFIED TECHNICIANS ONLY)

### Flame Appearance and Sooting

Proper flame appearance is a flame that is blue at the base and becomes yellowish-orange in the body of the flame. When the appliance is first lit, the entire flame may be blue and will gradually turn yellowish-orange during the first 30 minutes of operation. After 30 minutes of operation, if the flame is blue, or if the flame is orange with evidence of sooting (black tip), the air shutter opening may need to be adjusted.

If the air shutter opening is closed too far, sooting may develop. Sooting is indicated by black puffs developing at the tips of very long orange flames. Sooting results in black deposits forming on the logs, appliance inside surfaces and on exterior surfaces adjacent to the vent termination.


Sooting is caused by incomplete combustion in the flames and lack of combustion air entering the air shutter opening. To achieve a warm yellowish-orange flame with an orange body that does not soot, the shutter opening must be adjusted between these two extremes.

### Burner Air Shutter Adjustment Guidelines

- If there is smoke or soot present, first check the log set positioning to ensure that the flames are not impinging on any of the logs.
   If the log set is properly positioned and a sooting condition still exists, then the air shutter opening should be increased.
- The more offsets in the vent system, the larger the air shutter opening will need to be.
- An appliance operated with the air shutter opened too far, may have flames that appear blue and transparent. These weak, blue and transparent flames are termed anemic.
- Propane models may exhibit flames which candle or appear stringy. If this is present and persists, adjust the air shutter to a more OPEN position, then operate the appliance for a few more minutes to ensure that the flame normalizes and the flames do not appear sooty.

The following chart is provided to aid you in achieving the correct air shutter adjustment for your installation.

Air Shutter Adjustment Guidelines:			
Amount of Primary Air	Flame Color	Air Shutter Adjustment	
If air shutter is closed too far	Flame will be orange	Air shutter gap should be increased	
If air shutter is open too far	Flame will be blue	Air shutter gap should be decreased

- 2. Allow the burner to operate for at least 30 minutes while continuously observing the flame to ensure that the proper flame appearance has been achieved (see *Figures* 76 and 77).
- **3.** Adjust the air shutter using the Air Shutter Adjustment Lever on the lower right side of the firebox (see *Figure 76*).
  - For more OPEN air shutter, slide lever to the RIGHT.
  - For more CLOSED air shutter, slide lever to the LEFT.


A minimum shutter setting is designed into the venturi by four 1/16"-inch tabs.

- If the flame appears weak or sooty (as described on the previous page), adjust the air shutter until proper flame appearance is achieved.
- If flame stays lowered blue, incrementally adjust the air shutter to a more CLOSED position until proper flame appearance is achieved.

**Note:** See **Figures 20 and 21** for proper burner flame appearance.

### **Electronic Appliance Checkout**

To light the burner, refer to the lighting instructions on *Page 73*. Ensure the igniter lights the pilot. The pilot flame should engulf the flame sensor as shown in *Figure 78*.


#### Electronic Gas Control Valve - SIT Proflame







#### THE WARRANTY

Innovative Hearth Products ("IHP") 20 Year Limited Warranty warrants your Superior™ Brand gas fireplace, Stove or Insert ("Product") to be free from defects in materials and workmanship at the time of manufacture. The Product body and firebox carry the 20 Year Limited Warranty. Ceramic glass carries the 20 Year Limited Warranty thermal breakage only. After installation, if covered components manufactured by IHP are found to be defective in materials or workmanship during the 20 Year Limited Warranty period and while the Product remains at the site of the original installation, IHP will, at its option, repair or replace the covered components. If repair or replacement is not commercially practical, IHP will, at its option, refund the purchase price or wholesale price of the IHP product, whichever is applicable. IHP will also pay IHP prevailing labor rates, as determined in its sole discretion, incurred in repairing or replacing such components for up to five years. THERE ARE EXCLUSIONS AND LIMITATIONS to this 20 Year Limited Warranty as described herein.

#### **COVERAGE COMMENCEMENT DATE**

Warranty coverage begins on the date of installation. In the case of new home construction, warranty coverage begins on the date of first occupancy of the dwelling or six months after the sale of the Product by an independent IHP dealer/distributor, whichever occurs earlier. The warranty shall commence no later than 24 months following the date of product shipment from IHP, regardless of the installation or occupancy date.

#### **EXCLUSIONS AND LIMITATIONS**

This 20 Year Limited Warranty applies only if the Product is installed in the United States or Canada and only if operated and maintained in accordance with the printed instructions accompanying the Product and in compliance with all applicable installation and building codes and good trade practices.

This warranty is non-transferable and extends to the original owner only. The Product must be purchased through a listed supplier of IHP and proof of purchase must be provided. The Product body and firebox carry the 20 Year Limited Warranty from the date of installation. Vent components, trim components and paint are excluded from this 20 Year Limited Warranty. The following do not carry the 20 Year Limited Warranty but are warranted as follows:

Burner - Repair or replacement for one year from the date of installation

Gas components – Repair or replacement for one year from the date of installation Gaskets – Repair or replacement for one year from the date of installation

Logs - Replacement for one year from the date of installation against thermal breakage only

Optional blowers & remote controls – Repair or replacement for one year from the date of installation Optional glass doors – Repair or replacement for 90 days from the date of installation

Tempered glass - Replacement for one year from the date of installation

Labor coverage - Prevailing IHP labor rates apply for the warranty period of the component

Parts not otherwise listed carry a 90 day warranty from the date of installation.

### Whenever practicable, IHP will provide replacement parts, if available, for a period of 10 years from the last date of manufacture of the Product.

IHP will not be responsible for: (a) damages caused by normal wear and tear, accident, riot, fire, flood or acts of God; (b) damages caused by abuse, negligence, misuse, or unauthorized alteration or repair of the Product affecting its stability or performance (The Product must be subjected to normal use. The Product is designed to burn either natural or propane gas only. Burning conventional fuels such as wood, coal or any other solid fuel will cause damage to the Product, will produce excessive temperatures and could result in a fire hazard.); (c) damages caused by failing to provide proper maintenance and service in accordance with the instructions provided with the Product; (d) damages, repairs or inefficiency resulting from faulty installation or application of the Product.

IHP is not responsible for inadequate fireplace system draft caused by air conditioning and heating systems, mechanical ventilation systems, or general construction conditions which may generate negative pressure in the room in which the appliance is installed. Additionally IHP assumes no responsibility for drafting conditions caused by venting configurations, adjoining trees or buildings, adverse wind conditions or unusual environmental factors and conditions that affect the operation of the unit.

This 20 Year Limited Warranty covers only parts and labor as provided herein. In no case shall IHP be responsible for materials, components or construction, which are not manufactured or supplied by IHP or for the labor necessary to install, repair or remove such materials, components or construction. Additional utility bills incurred due to any malfunction or defect in equipment are not covered by this warranty. All replacement or repair components will be shipped F.O.B. from the nearest stocking IHP factory.

### LIMITATION ON LIABILITY

Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. The provisions of this 20 Year Limited Warranty are in addition to and not a modification of or subtraction from any statutory warranties and other rights and remedies provided by law.

### INVESTIGATION OF CLAIMS AGAINST WARRANTY

IHP reserves the right to investigate any and all claims against this 20 Year Limited Warranty and to decide, in its sole discretion, upon the method of settlement.

To receive the benefits and advantages described in this 20 Year Limited Warranty, the appliance must be installed and repaired by a licensed contractor approved by IHP.

Contact IHP at the address provided herein to obtain a listing of approved dealers/distributors. IHP shall in no event be responsible for any warranty work done by a contractor that is not approved without first obtaining IHP's prior written consent.

### **HOW TO REGISTER A CLAIM AGAINST WARRANTY**

In order for any claim under this warranty to be valid, you must contact the IHP dealer/distributor from which you purchased the product. If you cannot locate the dealer/distributor, then you must notify IHP in writing. IHP must be notified of the claimed defect in writing within 90 days of the date of failure.
