INTRODUCTION

The See-Through Power Vent is a direct-vent, sealed combustion gas fireplace designed for either **indoor/indoor** or **indoor/outdoor** residential applications (including screened porches and lanais).

NOTE: INDOOR/OUTDOOR INSTALLATIONS REQUIRE AN OUTDOOR INSTALLATION KIT (SOLD SEPARATELY).

These appliances are designed to operate on natural gas. The system is switchable between standing and intermittent pilot modes.

External electrical power is required to operate these units.

Approved Vent Components

These fireplaces are designed, tested and listed for operation and installation with the following vent components only:

- Secure Vent® Direct-Vent System Components,
- Secure Flex® Flexible Vent Components, and
- Z-FLEX® Model GA Venting Systems listed to UL1777 and ULCS635 manufactured by Flexmaster Canada Limited.

Use only the correct size venting (4-1/2" inner and 7-1/2" outer).

These approved vent system components are labeled for identification. DO NOT use any other manufacturer's vent components with these fireplaces.

GENERAL INFORMATION

WARNING

Young children should be carefully supervised when they are in the same room as the appliance. Toddlers, young children and others may be susceptible to accidental contact burns. 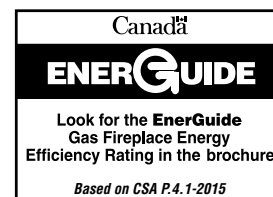

These appliances are listed by PFS TECO for installation in bedrooms, aftermarket mobile homes, and manufactured homes.

Misc. Codes/Standards

Installation must conform to local codes or, in the absence of local codes, with the *National Fuel Gas Code, ANSI Z223.1/NFPA 54 - latest edition* (in Canada, the current CAN/CGA-B149.1 installation code).

The appliance, when installed, must be electrically grounded and wired in accordance with local codes or, in the absence of local codes, with the *National Electrical Code, ANSI/NFPA 70 - latest edition*, or the *Canadian Electrical Code, CSA C22.1 - latest edition*.

Provide adequate clearances around air openings and adequate accessibility clearance for service and proper operation. Never obstruct the front or back openings of the appliance.

These appliances are designed to operate on natural gas only. The use of other fuels or combination of fuels will degrade the performance of this system and may be dangerous.

The system is switchable between standing and intermittent pilot modes. External electrical power is required to operate these units.

These models come standard with a remotely modulated gas valve. The included transmitter remotely controls flame appearance and heat output (manual gas valve adjustment is not possible).

Inputs and Efficiencies

Appliance BTU inputs are listed in **Table 1A**. Appliance efficiencies are listed in **Table 1B**.

Test gauge connections are provided on the front of the electronic gas control valve (identified **IN** for the inlet and **OUT** for the manifold side).

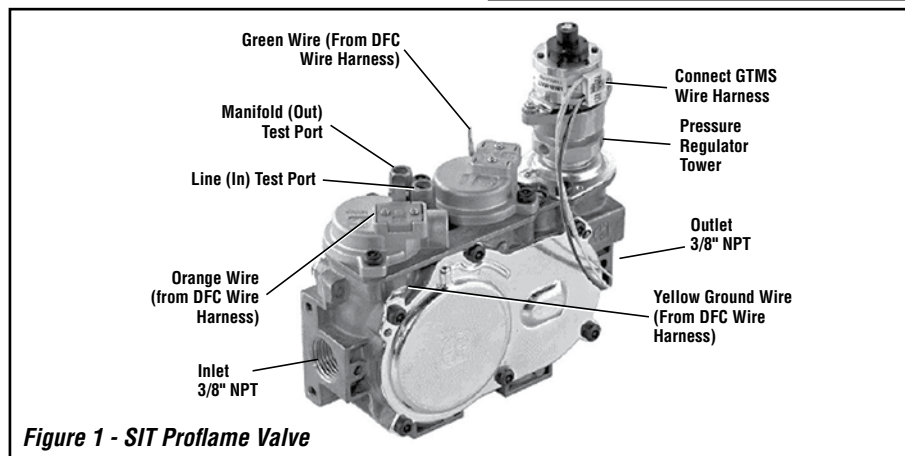


Figure 1 - SIT Proflame Valve

The control valves have a 3/8" (10 mm) NPT thread inlet and outlet side of the valve. Refer to **Figure 1**.

These appliances must not be connected to a chimney or flue serving a separate solid fuel burning appliance.

The appliance and its appliance main gas valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures **in excess of** 1/2 psi (3.5 kPa).

The appliance must be isolated from the gas supply piping system by closing its equipment shutoff valve during any pressure testing of the gas supply piping system at test pressures **equal to or less than** 1/2 psi (3.5 kPa).

PURGE CYCLE - This is a power-vented fireplace that requires household electrical power to operate. When the fireplace is turned OFF, the exhaust blower will continue to operate for up to two minutes, to purge exhaust gases from the venting system. This system will not operate during a power outage.

Orifice Sizes

Sea Level To High Altitude (All Models)

These appliances are tested and approved for installation at elevations of 0–4500 feet (0–1372 meters) above sea level using the standard burner orifice sizes listed in **Table 4**. For elevations above 4500 feet, contact your gas supplier or qualified service technician.

Deration

At higher elevations, the amount of BTU fuel value delivered must be reduced by either:

- using gas that has been derated by the gas company; or
- changing the burner orifice to a smaller size as regulated by the local authorities having jurisdiction and by the (USA) National Fuel Gas Code NFPA 54/ANSI Z223.1 - latest edition or, in Canada, the CAN/CGA-B149.1 codes - latest edition.

Install the appliance according to the regulations of the local authorities having jurisdiction and, in the USA, the National Fuel Gas Code NFPA 54 / ANSI Z223.1 - latest edition or, in Canada, the CAN/CGA-B149.1 - latest edition.

NOTE: Flame appearance will diminish 4% per 1,000 feet.

COMMONWEALTH OF MASSACHUSETTS REQUIREMENTS

These appliances are approved for installation in the US state of Massachusetts if the following additional requirements are met:

- Install this appliance in accordance with Massachusetts Rules and Regulations 248 C.M.R. Sections 4.00 through 8.00.
- Installation and repair must be done by a plumber or gas fitter licensed in the Commonwealth of Massachusetts.
- The flexible gas line connector used shall not exceed 36 inches (92 centimeters) in length..
- The individual manual shut-off must be a T-handle type valve.

Massachusetts Horizontal Vent Requirements

In the Commonwealth of Massachusetts, horizontal terminations installed less than seven (7) feet above the finished grade must comply with the following additional requirements::

- A hard-wired carbon monoxide detector with an alarm and battery back-up must be installed on the floor level where the gas fireplace is installed. The carbon monoxide detector must comply with NFPA 720, be ANSI/UL 2034 listed and be ISA certified.
- A metal or plastic identification plate must be permanently mounted to the exterior of the building at a minimum height of eight (8) feet above grade and be directly in line with the horizontal termination. The sign must read, in print size no less than one-half (1/2) inch in size, **GAS VENT DIRECTLY BELOW. KEEP CLEAR OF ALL OBSTRUCTIONS.**

COLD CLIMATE INSULATION

For cold climate installations, seal all cracks around the appliance with noncombustible material and wherever cold air could enter the room. If the floor is above ground level, it is especially important to insulate outside chase cavity between studs and under the floor on which the appliance rests. Gas line holes and other openings should be caulked or stuffed with unfaced fiberglass insulation.

If the fireplace is being installed on a cement slab in cold climates, a sheet of plywood or other raised platform can be placed underneath to prevent cold transfer to the fireplace and into the room. It also helps to sheetrock inside surfaces and tape for maximum air tightness and caulk firestops.

MANUFACTURED HOME REQUIREMENTS

This appliance may be installed in an aftermarket, permanently located, manufactured home and must be installed in accordance with the manufacturer's instructions.

LOCATION

In selecting the location, the aesthetic and functional use of the appliance are primary concerns; however, vent system routing to the exterior and access to the fuel supply are also important.

CAUTION: Due to high temperatures, the appliance should be located out of traffic and away from furniture and draperies (Figure 2).

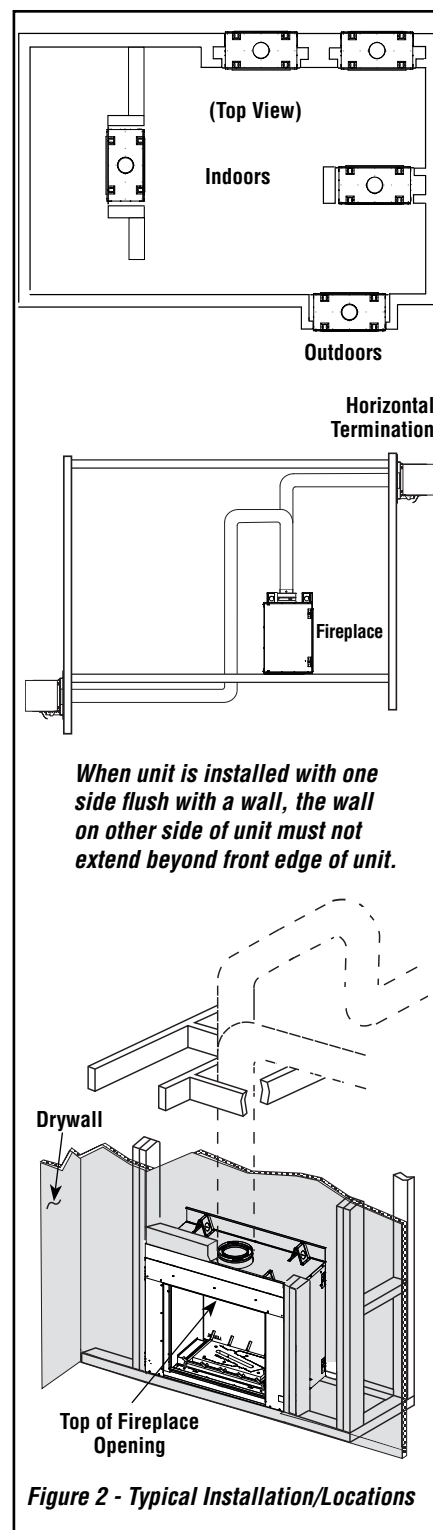

The location also should be free of electrical, plumbing, or other heating/air conditioning ducting.

These direct-vent appliances are uniquely suited for installations requiring a utility shelf positioned above the fireplace. Utility shelves like these are commonly used for locating television sets and decorative plants.

The minimum height from the base of the appliance to the underside of combustible materials used to construct a utility shelf in this fashion is shown in **Figure 7 on Page 11.**

Be aware that this is a heat-producing appliance. Objects placed above the unit are exposed to elevated temperatures.



Do not insulate the space between the appliance and the area above it.

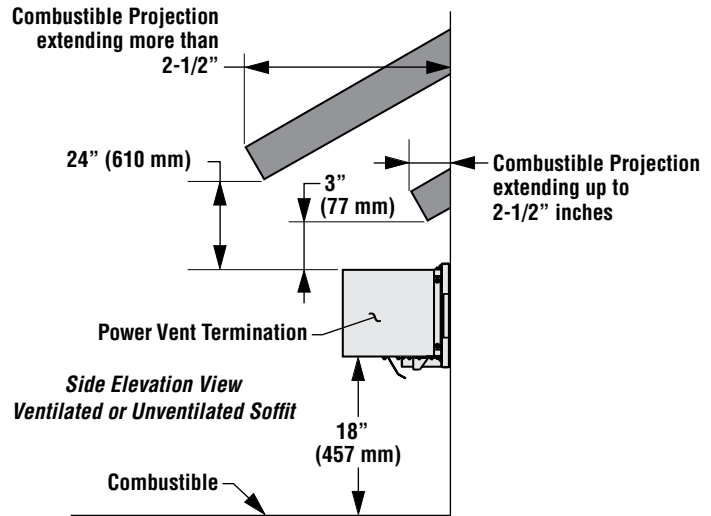
The appliance should be mounted on a fully supported base extending the full width and depth of the unit. The appliance may be located on or near conventional construction materials. However, if installed on combustible materials, (such as carpeting or vinyl tile), a metal or wood barrier covering the entire bottom surface must be used.

VENT TERMINATION CLEARANCES

These instructions should be used as a guideline and do not supersede local codes in any way. Install venting according to local codes, these instructions, the current National Fuel Gas Code (ANSI-Z223.1) in the USA or the current standards of CAN/CGA-B149.1 in Canada. When planning your vent run refer to the table in *Figure 22 on Page 19*.

Horizontal Vent Termination Clearances

The horizontal vent termination must have a minimum of 3" (77 mm) clearance to any overhead combustible projection of 2-1/2" (64 mm) or less (see *Figure 3*). For projections exceeding 2-1/2" (64 mm), see *Figure 3*. For additional vent location restrictions refer to *Figure 4 on Page 9*.

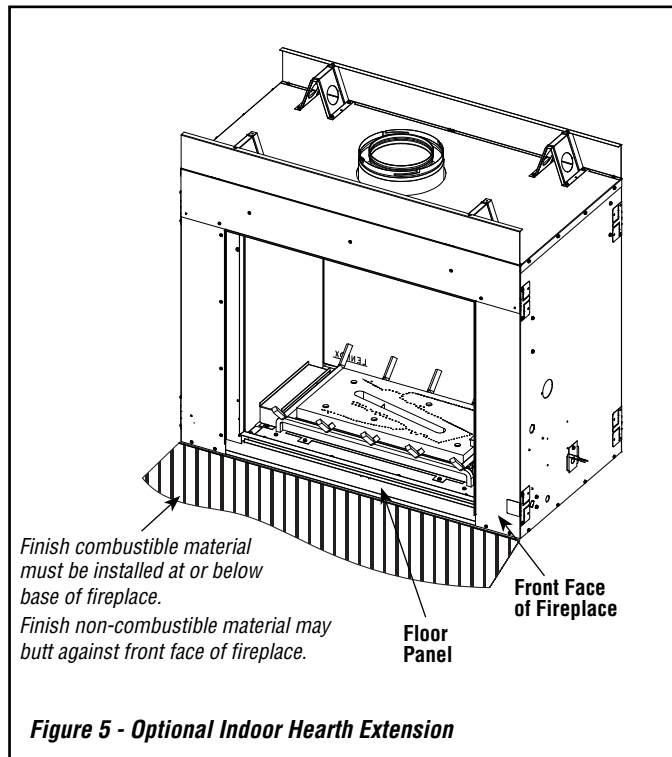
Optional Indoor Hearth Extension

Combustible indoor hearth material may only be installed **at or below** the base of the fireplace (see **Figures 5 and 6**).

Non-combustible indoor hearth material may be installed above the base of the fireplace and may butt against the front face of the fireplace (see **Figures 5 and 6**).

Also note the following:

- Combustible material may project beyond the sides of the fireplace opening, as long as it is within the shaded area shown in **Figure 9 on Page 11**.
- Vertical installation clearances to combustible mantels vary according to the depth of the mantel (see **Figure 8 on Page 11**).
- Non-combustible mantels may be installed at any height above the appliance opening.

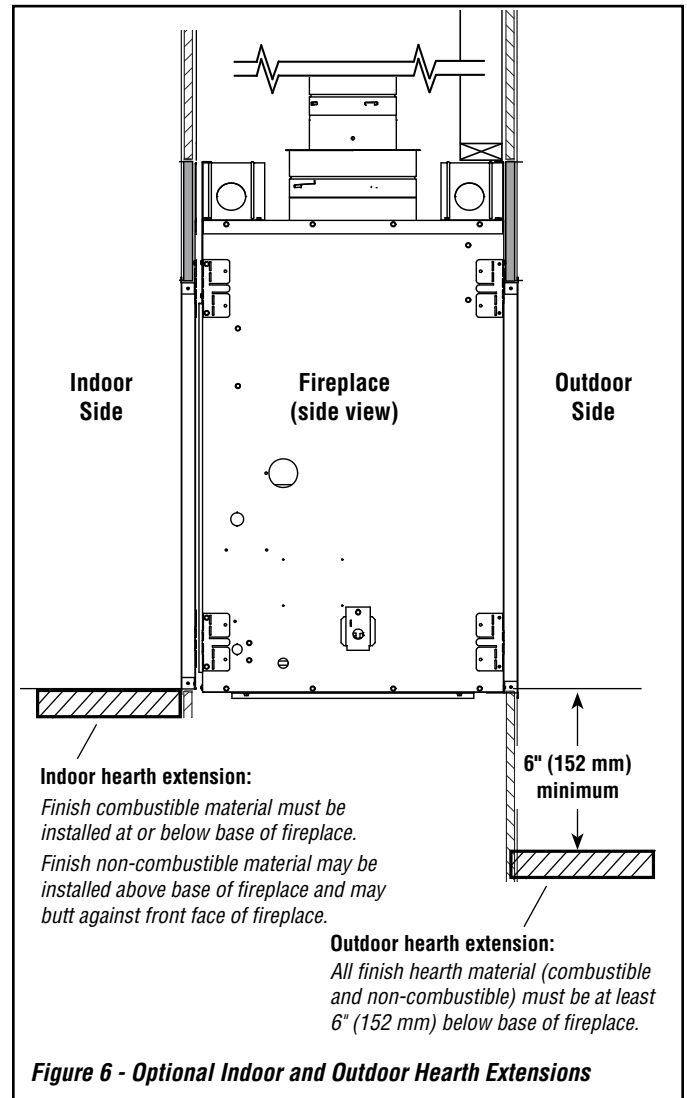


Optional Outdoor Hearth Extension

All outdoor hearth material (combustible and non-combustible) must be installed a **minimum of 6" (152 mm)** below the base of the fireplace (see **Figure 6**).

Also note the following:

- For vertical installation clearances to combustible outdoor mantels and overhangs, see **Page 33** and the instructions provided in the Outdoor Installation Kit (required for all outdoor installations; see **Page 46**).
- Non-combustible outdoor mantels and overhangs may be installed at any height above the appliance opening.



MINIMUM CLEARANCES TO COMBUSTIBLES

Appliance and Vent Clearances

The appliance is approved with zero clearance to combustible materials on both sides (as detailed in **Table 5**), with the following exceptions:

- When the unit is installed with one side flush with a wall, the wall on the other side of the unit must not extend beyond the front edge of the unit.
- In addition, when the unit is recessed, the side walls surrounding the unit must not extend beyond the front edge of the unit (see **Figure 2** on **Page 7**).

- ① 3" (77 mm) above any horizontal/inclined vent component.
- ② See **Step 1 ("FRAMING")** on **Page 12** for clearance requirements to the nailing flanges on each side of the unit and any adjacent screw heads.

The appliance should be mounted on a fully supported base extending the full width and depth of the unit. The appliance may be located on or near conventional construction materials; however, if installed on combustible materials, such as carpeting, vinyl tile, etc., a metal or wood barrier covering the entire bottom surface must be used.

Min. Height of Combustible Enclosure

To provide for the lowest possible combustible enclosure (or shelf) surface, the venting should be routed in a way to minimize obstructions to the space above the appliance. Do not insulate the space between the appliance and the area above it (see **Figure 7**).

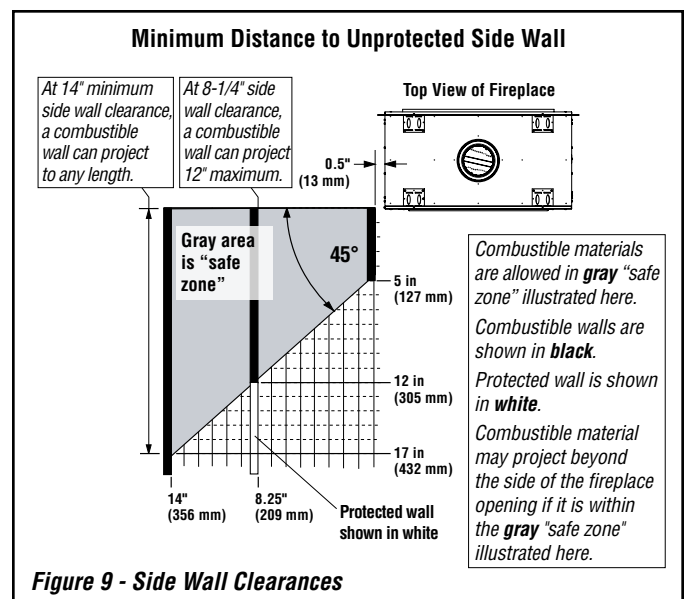
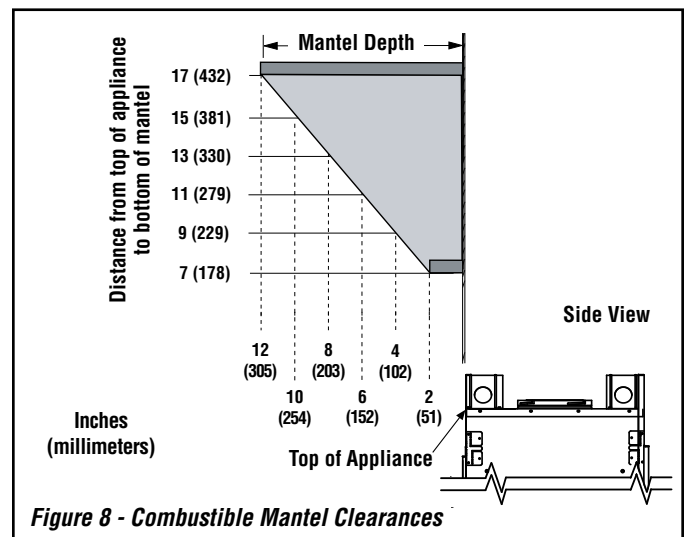
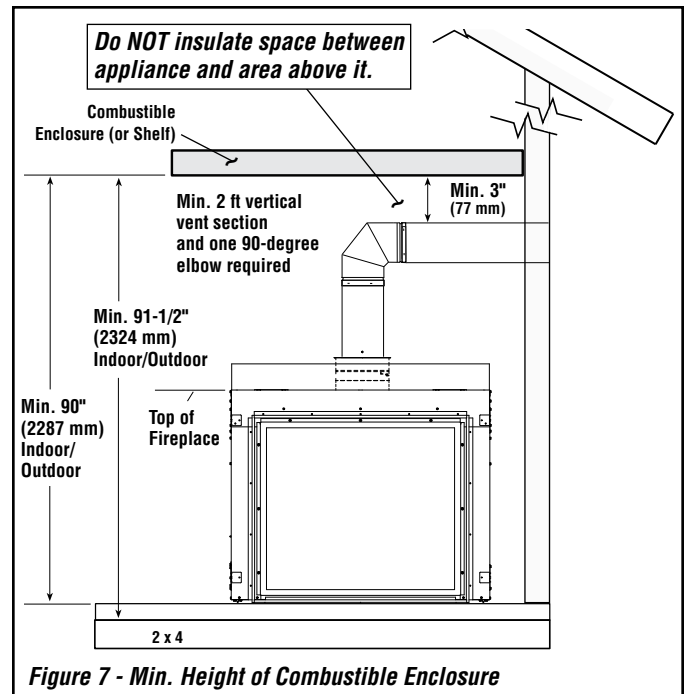
Wall Finishes / Surrounds / Mantels

NOTE: Combustible wall finish materials and/or surround materials must not be allowed to encroach the area defined by the appliance front faces (black sheet metal). Never allow combustible materials to be positioned in front of or overlapping the appliance face. See **Pages 32 and 33**.

Non-combustible materials, such as surrounds and other appliance trim, may be installed on the appliance front face only if they do NOT cover any portion of the removable glass panel.

Vertical installation clearances to combustible mantels vary according to the depth of the mantel. See **Figure 8**. Mantels constructed of non-combustible materials may be installed at any height above the appliance opening.

NOTE: To avoid heat-related finish damage, we recommend the use of high-temperature paint (rated 175°F or higher) on the underside of the mantel.



PRE-INSTALLATION STEPS

The appliance is shipped with all gas controls and components installed and pre-wired.

1. Remove the shipping carton, exposing the front glass door on the control side.

Barrier (see Notice, Page 36)

This fireplace comes with a barrier to reduce the likelihood of burns from touching hot glass. If the barrier is damaged, the fireplace should be turned off immediately and the fireplace must not be operated until a new, approved factory barrier for this unit is installed.

To remove barrier follow these steps.

- a. Lift barrier up by the frame at the top.
- b. Remove lower filler piece by pulling down off of the barrier.
- c. Lower barrier and push barrier to left to release right side.
- d. Pull the right side out of fireplace.
- e. Remove barrier.

2. Using a Phillips screwdriver, unfasten two (2) screws located at the top of the glass frame (see Figure 50 on Page 30). Tilt the top of the glass frame away from the unit. Lift it carefully off the bottom door track and set the door aside, protecting it from inadvertent damage.

- FINISHING REQUIREMENTS (Page 32).**

DETAILED INSTALLATION STEPS

Step 1. FRAMING

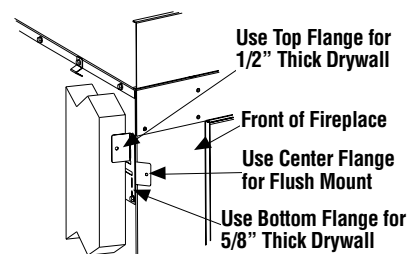
Frame these appliances as illustrated on **Page 13**. All framing details must allow for a minimum clearance to combustible framing members as shown on **Page 11**.

If the appliance is to be elevated above floor level, a solid continuous platform must be constructed below the appliance.

Headers may be in direct contact with the appliance top spacers, but must not be supported by them or notched to fit around them. All construction above the appliance must be self-supporting; **DO NOT** use the appliance for structural support.

Secure the fireplace to the side framing members using the unit's nailing flanges - one top and bottom on each side of the fireplace front (see **Figure 10**). Use 8d nails or their equivalent.

NOTE: The nailing flanges, combustible members and screw heads in areas directly adjacent to the nailing flanges are EXEMPT from the 1/2" clearance to combustible requirements for the firebox outer wrapper. Combustible framing may be in direct contact with the nailing flanges and may be located closer than 1/2 inch from screw heads and the firebox wrapper in areas adjacent to the nailing flanges. Frame the opening to the exact dimensions specified in the framing details of the **Installation Instructions**.

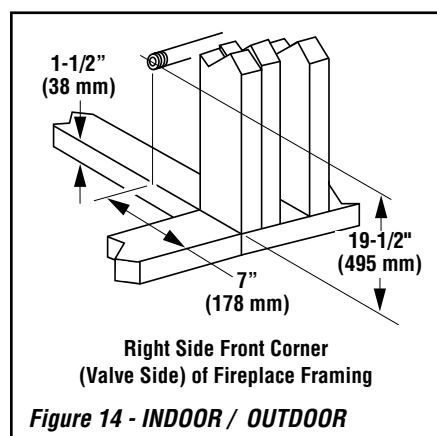
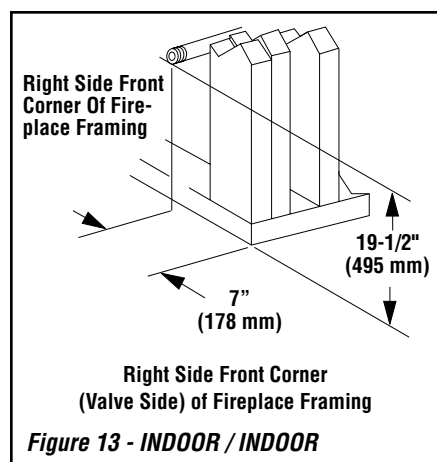
Step 2. ROUTE GAS LINE

⚠ NOTICE: For indoor/outdoor installations, the **CONTROL SIDE** of the fireplace must be installed on the **INDOOR** side.

Route a 1/2" (13 mm) gas line along the inside of the right side framing as shown in **Figures 13 and 14**. Gas lines must be routed, constructed and made of materials that are in strict accordance with local codes and regulations.

All appliances are factory-equipped with a flexible gas line connector and 1/2 inch shutoff valve (**see Step 6 on Page 26**).

The incoming gas line should be piped into the valve compartment and connected in one of the two methods as shown in **Figure 37** on **Page 26**.

Proper Sizing of Gas Line

Properly size and route the gas supply line from the supply regulator to the area where the appliance is to be installed per requirements outlined in the National Fuel Gas Code, NFPA 54 - latest edition (USA) or CAN/CGA-B149.1 - latest edition (Canada).

IMPORTANT: It is critical that a licensed installer perform this step strictly per NFPA.

Never use galvanized or plastic pipe. Refer to **Table 6** for proper sizing of the gas supply line, if black iron pipe is being used. Gas lines must be routed, constructed and made of materials that are in strict accordance with local codes and regulations. We recommend that a qualified individual such as a plumber or gas fitter be hired to correctly size and route the gas supply line to the appliance. Installing a gas supply line from the fuel supply to the appliance involves numerous considerations of materials, protection, sizing, locations, controls, pressure, sediment, and more. Certainly no one unfamiliar and unqualified should attempt sizing or installing gas piping.

NOTE:

- All appliances are factory-equipped with a flexible gas line connector and 1/2 inch shutoff valve (**see Figure 37** on **Page 26**).
- See **Massachusetts Requirements** on **Page 7** for additional requirements for installations in the state of Massachusetts in the USA.
- The gas supply line should not be connected to the appliance until **Step 6 (Page 26)**.
- A pipe joint compound rated for gas should be used on the threaded joints. Be very careful that the pipe compound does not get inside the pipe.
- It is recommended to install a sediment trap in the supply line as close as possible to the appliance (**see Figure 37** on **Page 26**).
- Check with local building official for local code requirements (i.e. are below grade penetrations of the gas line allowed?, etc).

Step 3. INSTALL VENT SYSTEM

General Information

These instructions should be used as a guide-line and do not supersede local codes in any way. Install venting according to local codes, these instructions, the current National Fuel Gas Code (ANSI-Z223.1) in the USA or the current standards of CAN/CGA-B149.1 and -B149.2 in Canada.

These fireplaces are designed, tested and listed for operation and installation with, and only with, Secure Vent® (SV4.5) Direct-Vent System Components, manufactured by Security Chimneys International. These approved vent system components are labeled for identification. DO NOT use any other manufacturer's vent components with these appliances.

Ensure clearances are in accordance with local installation codes and the requirements of the gas supplier.

Use only approved venting components. See **Approved Vent Components** on **Page 4**.

These fireplaces must be vented directly to the outside.

The vent system may not service multiple appliances, and must never be connected to a flue serving a solid fuel burning appliance. The vent pipe is tested to be run inside an enclosed wall (such as a chase). There is no requirement for inspection openings in the enclosing wall at any of the joints in the vent pipe.

Venting System

With the appliance secured in framing, determine vent routing and identify the exterior termination location. The following sections describe horizontal (exterior wall) vent applications. A list of approved venting components is shown on **Page 35**.

Vent Restrictor

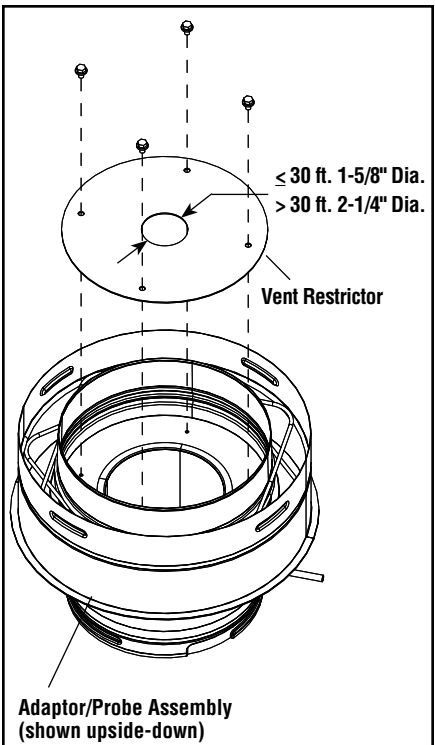
The adaptor/probe assembly for this appliance has a pre-installed vent restrictor with a 1-3/4" hole in the center (see **Figure 15**). This pre-installed vent restrictor is **not** for use with any venting configuration for this fireplace model and must be replaced with one of the two provided vent restrictors, as described below.

Vent Restrictor Size Guidelines

- For venting systems **30 ft in length or less**, replace the factory installed vent restrictor with the provided vent restrictor with a **1-5/8" dia. hole**.
- For venting systems **greater than 30 ft in length**, replace the factory installed vent restrictor with the provided vent restrictor with a **2-1/4" dia. hole**.

Vent Restrictor Installation Instructions

Install the appropriate vent restrictor (as described above) into the adaptor/probe assembly per the instructions in **Figure 15**.

- Turn the adaptor/probe assembly upside-down, as shown.
- Remove the four screws securing the vent restrictor in place. Lift out the vent restrictor.
- Install the appropriate vent restrictor, using the four screws previously removed. See "Vent Restrictor Size Guidelines," above.

Power Vent Components

Locate the fireplace as per the instructions in this manual. Make the following modifications to add the components used with the Power Vent Kits. This kit can only be used in conjunction with "Direct-Vent" series electronic fireplaces. This installation must conform with local codes or, in the absence of local codes, with the Natural Fuel Gas Code, ANSI Z223.1/ NFPA 54, or the Natural Gas and Propane Installation Code, CAN/CGA B149.1.

CAUTION: This Power Vent Kit cannot be used with Millivolt appliances. Use kit only with the Electronically controlled fireplaces listed for its use as shown in this document.

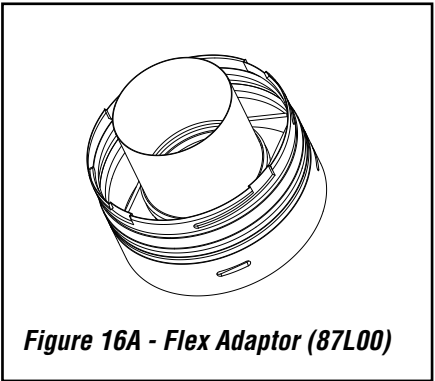


Figure 16A - Flex Adaptor (87L00)

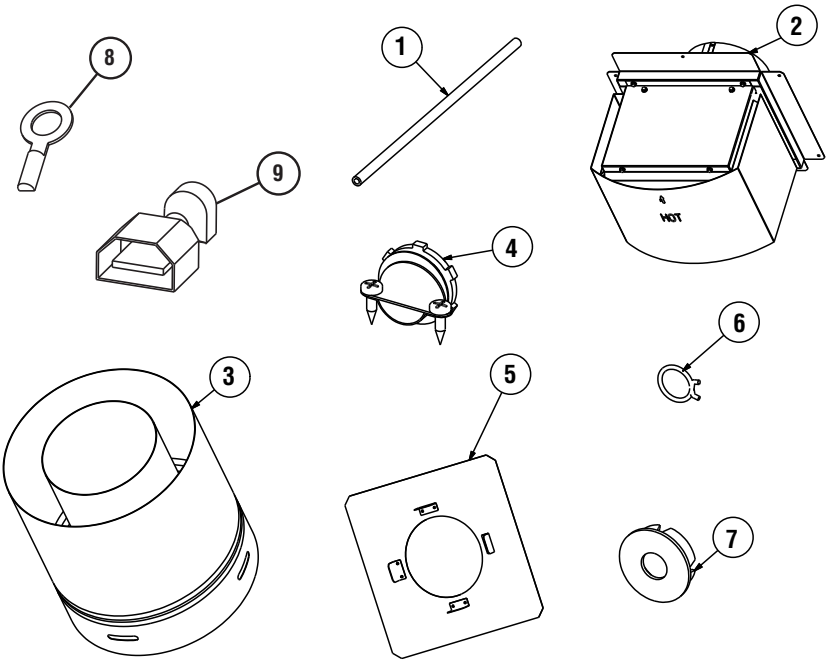


Figure 16B - Power Vent Kit Components

VENT SECTION LENGTHS

Determine the number of straight vent sections required. 4-1/2" (114 mm), 10-1/2" (267 mm), 22-1/2" (572 mm), 34-1/2" (876 mm) and 46-1/2" (1181 mm) net section lengths are available. Refer to the Vent Section Length Chart.

Vertical (Offset) Installation

Analyze the vent routing and determine the quantities of vent sections and number of elbows required. Refer to **Figures 21 and 22 on Page 19** showing vent run requirements to aid in selecting the type of vertical installation desired. Vent sections are available in net lengths of 4-1/2" (114 mm), 10-1/2" (267 mm), 22-1/2" (572 mm), 34-1/2" (876 mm) and 46-1/2" (1181 mm). Refer to the **Vent Section Length Chart** for an aid in selecting length combinations. Elbows are available in 90° and 45° configurations. Refer to **Figure 20 on Page 18** for the SV4.5 E45 and SV4.5 E90 elbow dimensional specifications.

Where required, a **telescopic vent section (SV4.5LA)** may be used to provide the installer with an option in installing in tight and confined spaces or where the vent run made up of fixed length pieces develops a joint in a undesirable location, or will not build up to the required length. The SV4.5LA Telescopic Vent Section has an effective length of from 1-1/2" (38 mm) to 6-3/4" (171 mm). The SV4.5LA is fitted with a dimpled end (identical to a normal vent section component) and a plain end with 3 pilot holes. Slip the dimpled end over the locking channel end of a standard SV4.5 vent component the required distance and secure with three screws.

Maintain a minimum 1" (26 mm) clearance to combustible materials for all vertical elements. Clearances for all horizontal elements are 3" (77 mm) on top, 1" (26 mm) on sides and 1" (26 mm) on the bottom.

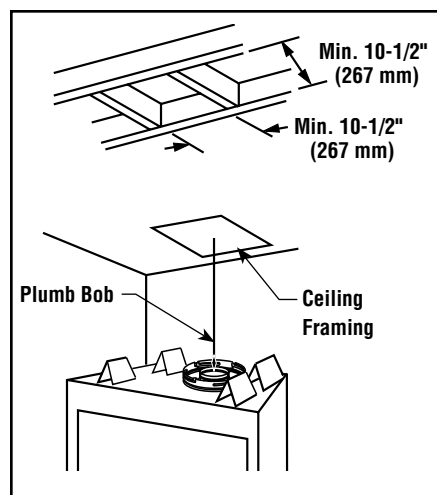


Figure 17 - Ceiling Opening Framing

A. Frame ceiling opening. Use a plumb line from the ceiling above the appliance to locate center of the vertical run. Cut and/or frame an opening, 10-1/2" x 10-1/2" (267 mm x 267 mm) inside dimensions, about this center mark (**Figure 17**).

B. Attach adaptor (with probe) to appliance collar. Secure Vent® SV4.5 direct-vent system components are unitized concentric pipe components featuring positive twist lock connections (see **Figure 18**).

All of the appliances covered in this document are fitted with collars having locking inclined channels. The dimpled end of the adaptor fits over the appliance collar to create the positive twist lock connection.

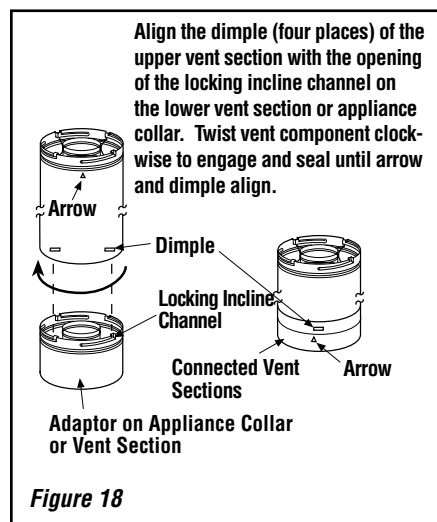

To attach a vent component to the adaptor on appliance collar, align the dimpled end over the adaptor collar, adjusting the radial alignment until the four locking dimples are aligned with the inlet of the four inclined channels on the collar (refer to **Figure 18**). Push the vent component against the collar until it fully engages, then twist the component clockwise, running the dimples down and along the incline channels until they seat at the end of the channels.

The unitized design of the **Secure Vent** components will engage and seal both the inner and outer pipe without the need for sealant or screws. If desired a #6 x 1/2" screw may be used at the joint, but it is not required as the pipe will securely lock when twisted.

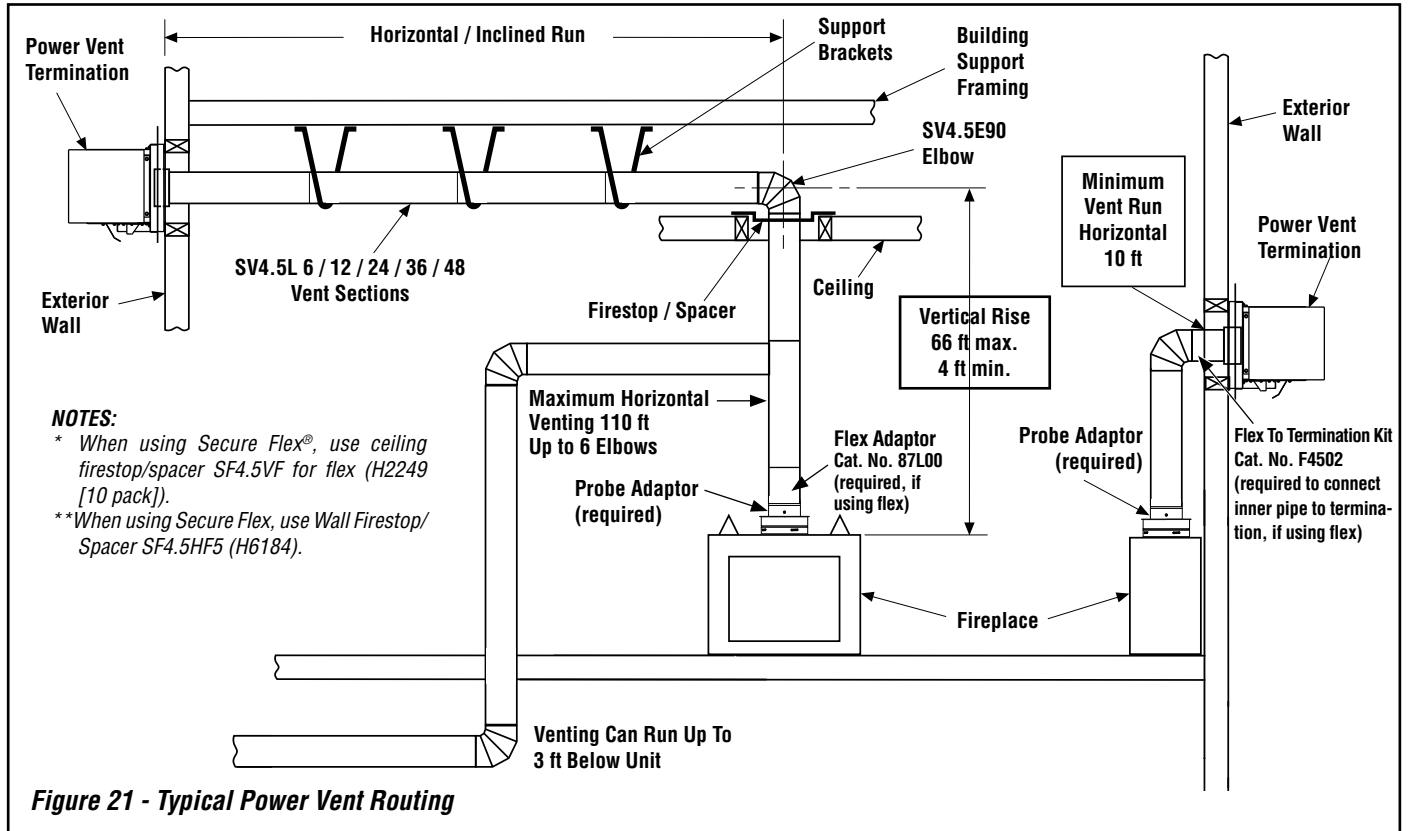


Figure 21 - Typical Power Vent Routing

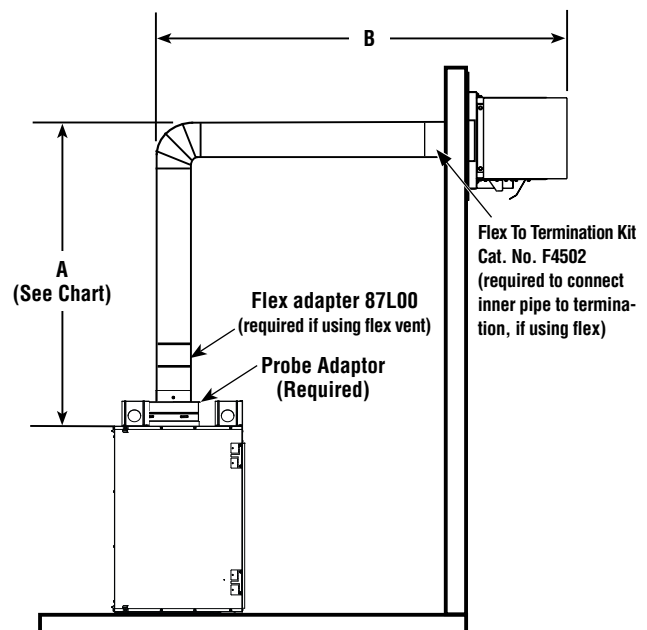


Figure 22 - Power Vent Routing with Probe Adaptor

C. Attach vent components to each other. Other vent sections may be added to the previously installed section in accordance with the requirements shown in **Figures 21 and 22 on Page 19**.

To add another vent component to a length of vent run, align the dimpled end over the inclined channel end of the previously installed section, adjusting the radial alignment until the four locking dimples are aligned with the inlets of the four incline channels of the previous section.

Push the vent component against the previous section until it fully engages, then twist the component clockwise running the dimples down and along the incline channels until they seat at the end of the channels. **This seating position is indicated by the alignment of the arrow and dimple as shown in Figure 18.**

D. Install firestop/spacer at ceiling. When using Secure Vent, use SV4.5VF firestop/spacer at ceiling joists. If there is living space above the ceiling level, the firestop/spacer must be installed on the bottom side of the ceiling. If attic space is above the ceiling, the firestop/spacer must be installed on the top side of the joist. Route the vent sections through the framed opening and secure the firestop/spacer with 8d nails or other appropriate fasteners at each corner. **Remember to maintain 1" (26 mm) clearance to combustibles, framing members, and attic or ceiling insulation when running vertical chimney sections. Attic insulation shield (H3907) is required and may be used to help maintain the clearances indicated here. See on Page 35. The gap between the vent pipe and a vertical firestop can be sealed with non-combustible caulking.**

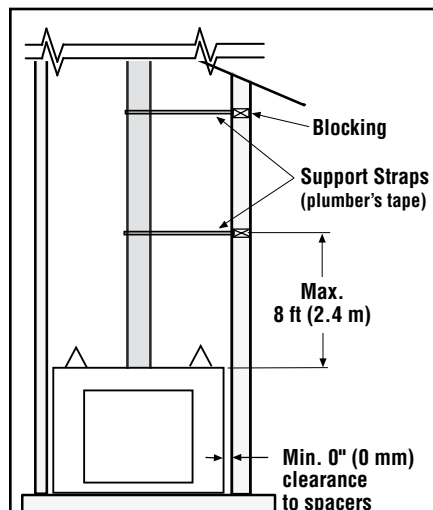

E. Support the vertical vent run sections.

NOTE: Proper venting support is very important. The weight of the vent must not be supported by the fireplace in any degree.

Support the vertical portion of the venting system every 8 feet (2.4 m) above the fireplace vent outlet. One method of support is by utilizing field provided support straps (conventional plumber's tape). Secure the plumber's tape to the framing members with nails or screws. Strap the tape around the vent, securing the ends of the tape to the framing. If desired, sheet metal screws #6 x 1/2" length may be used to secure the support straps to the vent pipe (see **Figure 19**).

F. Change vent direction to horizontal/inclined run. At transition from or to a horizontal/inclined run, install the SV4.5 E45 and SV4.5 E90 elbows in the same manner as the straight vent sections. The elbows feature a twist section to allow them to be routed about the center axis of their initial collar section to align with the required direction of the next vent run element. **Twist elbow sections in a clockwise direction only so as to avoid the possibility of unlocking any of the previously connected vent sections (see Figures 18 and 20).**

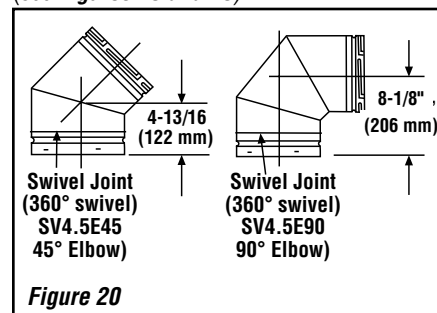

G. Continue installation of horizontal/inclined sections. Continue with the installation of the straight vent sections in horizontal/inclined run as described in **Step C**. Install support straps every 3' (914 mm) along horizontal/inclined vent runs using conventional plumber's tape (see **Page 19, Figure 21**).

⚠ NOTICE: It is important to install horizontal runs on a **steady, (i.e., no "dips"), slightly positive incline of approximately 1/4" rise-per-foot (20 millimeters rise-per-meter) horizontal, in a direction away from the fireplace.** (Slightly smaller rise-per-foot run ratios are acceptable). Use a carpenter's level to measure from a constant surface, and adjust support straps as necessary.

It is important to maintain the required clearances to combustibles: 1" (26 mm) at all sides for all vertical runs; and 3" (77 mm) at the top, 1" (26 mm) at sides, and 1" (26 mm) at the bottom for all horizontal/inclined runs.

VENT FIGURES

NOTE:

- Secure Vent® components (rigid vent pipe and terminal) are shown in the figures.
- Two 45 degree elbows may be used in place of one 90 degree elbow.
- SV4.5VF (Secure Vent) firestop/spacer must be used anytime vent pipe passes through a combustible floor or ceiling. SV4.5HF (Secure Vent) firestop/spacer must be used anytime vent pipe passes through a combustible wall.

⚠ NOTICE: It is important to install horizontal runs on a steady, (i.e., no “dips”), slightly positive incline of approximately 1/4” rise-per-foot (20 millimeters rise-per-meter) horizontal, in a direction away from the fireplace. (Slightly smaller rise-per-foot run ratios are acceptable). Use a carpenter’s level to measure from a constant surface, and adjust support straps as necessary.

HORIZONTAL (OUTSIDE WALL) TERMINATION SYSTEM

See **Figures 21 and 22 on Page 19** illustrating the various horizontal venting configurations that are possible for use with these appliances. The table in **Figure 22 on Page 19** shows each system's minimum and maximum vertical and horizontal length values that can be used to design and install the vent components in a variety of applications.

The horizontal vent system terminates through an outside wall. Building Codes limit or prohibit terminating in specific areas. Refer to **Figure 3 on Page 8** for location guidelines.

Secure Vent® SV4.5 direct-vent system components are unitized concentric pipe components featuring positive twist lock connection, (refer to **Figure 18 on Page 18**). All of the appliances covered in this document are fitted with collars having locking inclined channels. The dimpled end of the vent components fit over the appliance collar to create the positive twist lock connection.

A. Plan the vent run.

Analyze the vent routing and determine the types and quantities of sections required 4-1/2" (114 mm), 10-1/2" (267 mm), 22-1/2" (572 mm), 34-1/2" (876 mm) and 46-1/2" (1181 mm) net section lengths are available. Make allowances for elbows as indicated in **Figure 20 on Page 18**.

Maintain a minimum 1" (26 mm) clearance to combustibles on the vertical sections. Clearances for the horizontal runs are; 3" (77 mm) on top, 1" (26 mm) on sides, and 1" (26 mm) at the bottom.

B. Frame exterior wall opening.

Locate the center of the vent outlet on the exterior wall according to the dimensions shown in **Figure 11 on Page 13**.

Cut and/or frame an opening, 10-1/2" x 12-1/8" (267 mm x 308 mm) inside dimensions, with 7-1/2" above center and 5-5/8" below center.

C. Frame ceiling opening.

If the vertical route is to penetrate a ceiling, use plumb line to locate the center above the appliance. Cut and/or frame an opening, 10-1/2" x 10-1/2" (267 mm x 267 mm) inside dimensions, about this center (refer to **Figure 17 on Page 18**).

D. Attach vent components to appliance.

To attach a vent component to the appliance collar, align the dimpled end over the collar, adjusting the radial alignment until the four locking dimples are aligned with the inlets of the four incline channels on the collar (refer to **Figure 18 on Page 18**).

Push the vent component against the collar until it fully engages, then twist the component clockwise, running the dimples down and along the incline channels until they seat at the end of the channels. The unitized design of the **Secure Vent** components will engage and seal both the inner and outer pipe elements with the same procedure. Sealant and securing screws are not required.

E. Attach vent components to each other.

Other vent sections may be added to the previously installed section in accordance with the requirements of the vent tables. To add another vent component to a length of vent run, align the dimpled end of the component over the inclined channel end of the previously installed section, adjusting the radial alignment until the four locking dimples are aligned with the inlets of the four incline channels of the previous section. Push the vent component against the previous section until it fully engages, then twist the component clockwise running the dimples down and along the incline channels until they seat at the end of the channels. **This seating position is indicated by the alignment of the arrow and dimple as shown in Figure 18 on Page 18.**

F. Install firestop/spacer at ceiling.

When using **Secure Vent**, use SV4.5VF firestop/spacer at ceiling joists. If there is living space above the ceiling level, the firestop/spacer must be installed on the bottom side of the ceiling. If attic space is above the ceiling, the firestop/spacer must be installed on the top side of the joist. Route the vent sections through the framed opening and secure the firestop/spacer with 8d nails or other appropriate fasteners at each corner.

Remember to maintain 1" (26 mm) clearance to combustibles, framing members, and attic or ceiling insulation when running vertical chimney sections.

G. Support the vertical run sections.

On the vertical run, support the venting system every 8 feet (2.4m) above the fireplace vent outlet with field provided support straps (Plumber's tape). Attach the straps to the vent pipe and secure to the framing members with nails or screws. See **Figure 19 on Page 18**.

H. Change vent direction.

At transition from or to a horizontal/inclined run, install the SV4.5E45 and SV4.5E90 elbows in the same manner as the straight vent sections. The elbows feature a twist section to allow them to be routed about the center axis of their initial collar section to align with the required direction of the next vent run element. **Twist elbow sections in a clockwise direction only so as to avoid the possibility of unlocking any of the previously connected vent sections (see Figures 18 and 20 on Page 18).**

I. Continue installation of horizontal/inclined sections.

Continue with the installation of the straight vent sections in horizontal/inclined run as described in **Step E**. Install support straps every 3 feet (914 mm) along horizontal/inclined vent runs using conventional plumber's tape.

See **Figure 21 on Page 19**.

⚠ NOTICE: It is important to install horizontal runs on a steady, (i.e., no "dips"), slightly positive incline of approximately 1/4" rise-per-foot (20 millimeters rise-per-meter) horizontal, in a direction away from the fireplace. (Slightly smaller rise-per-foot run ratios are acceptable). Use a carpenter's level to measure from a constant surface, and adjust support straps as necessary.

Installing Power Vent Termination

J. Assemble vent run to exterior wall.

If not previously measured, locate the center of the vent on the exterior wall. Prepare an opening as described in this manual. Assemble the vent system to a point where the terminus of the last section is within 8 inches of the outside wall surface where the power vent is to be mounted (refer to **Figure 24 on Page 21**).

If the terminus of the last section is not within this distance, use the **telescopic vent section SV4.5LA**, as the last vent section. For wall thicknesses greater than that shown in **Figure 24 on Page 21**, refer to **Table 8 (Page 21)** for the additional venting components needed (in addition to the termination and adaptor) for a particular range of wall thicknesses.

K. Attach termination adaptor.

Attach the adaptor (SV4.5RCH, provided with the power vent kit) to the vent section telescoping vent section, or elbow, as shown in **Figures 23 and 24 on Page 21** in the same manner as any SV4.5 vent component.

L. Install Firestop/Spacer at exterior wall.

Install SV4.5HF Firestop/Spacer, provided with the power vent kit, over the opening at the **exterior** side of the framing, long side up, with the 3 inch spacer clearance at the top as shown in **Figure 23**, and nail into place.

(The Firestop/Spacer may also be installed over the opening at the interior side of the framing).

M. Install the Power Vent termination.

For the last step, from outside the exterior wall, slide the collars of the termination onto the adaptor (the outer inside the outer and the inner outside the inner) until the termination seats against the exterior wall surface to which it will be attached. Orient the housing of the termination with the arrow pointed upwards. Secure the termination to the exterior wall. **The termination must not be recessed into the exterior wall or siding** by more than the 1-1/4" (32 mm) as shown in **Figure 24**.

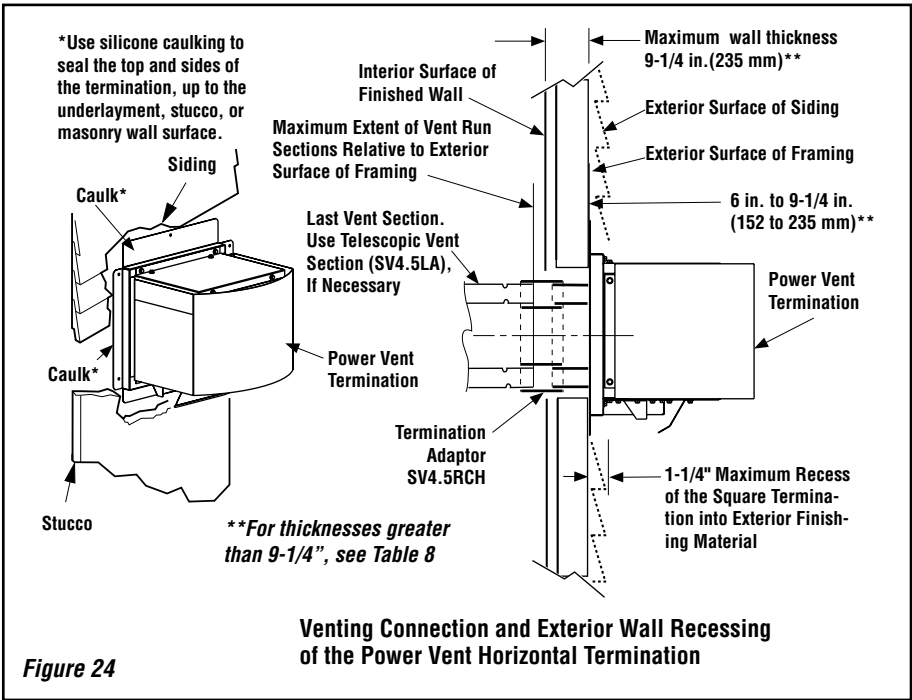
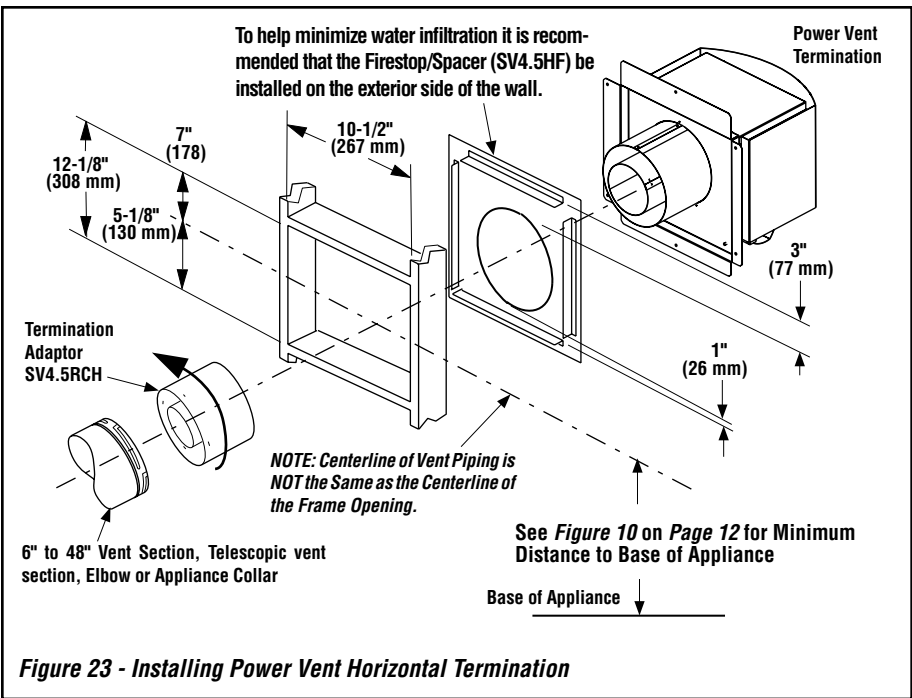
The Power Vent termination has been designed to perform in a wide range of weather conditions. Our terminations meet or exceed industry standards.

When selecting the location of your termination, do not place the termination where water from eaves and adjoining roof lines may create a heavy flow of cascading water onto the terminations. If the termination must be placed where the possibility of cascading water exists, it is the responsibility of the builder to direct the water away from the termination cap by using gutters or other means.

Take care to carefully follow the Installation Instructions for the termination, including the use of silicone caulking where required.

See Table 8 as an aid in venting component selection for a particular range of exterior wall thicknesses.

IMPORTANT: The vent termination is hot while in operation and for a period of time following the use of the fireplace. Young children should be carefully supervised when they are in the same area as a hot termination.

VERTICAL OR HORIZONTAL VENTING USING SECURE FLEX® KITS AND COMPONENTS

When **Secure Flex**® kits are used in a rear flue, horizontal termination installation, at least 1 ft of vertical rise is required.

Secure Flex venting kits and components may be used in any other vent installation where rigid **Secure Vent**® (SV4.5) direct-vent components can be used. All restrictions, clearances and allowances pertaining to rigid vent also apply to flexible vent. Do NOT modify **Secure Flex** kits. **Secure Flex** kits can be installed on the end of a **Secure Vent** (SV4.5) rigid vent run, provided that doing so does not violate any of the venting length, height, routing, horizontal to vertical ratio requirements, or clearance considerations detailed in this manual. When combined, a rigid vent should not be installed between two flexible vents.

Secure Flex kits come with an included adaptor that can be installed on the fireplace collar or the inclined channel end of the last **Secure Vent** (SV4.5) vent section in a rigid system in the exact same fashion as any other **Secure Vent** section. Align the dimpled end of the adaptor over the previously installed section or fireplace collar, adjusting the radial alignment until the four locking dimples of the adaptor are aligned with the inlets of the four incline channels of the last vent section or collar. Push on the adaptor until it is fully engaged, then twist the adaptor clockwise running the dimples down and along the incline channels until they seat at the end of the channels.

1. Install the Inner Flex Pipe.

- Install the small gear clamp loosely around the inner flexible vent, then push it back out of the way.
- Apply a bead of Mill-Pac Black (700 °F) high temperature sealant (P/N 10K81) to the inner adaptor collar, approximately 1/2" from the end.

c. Pull and extend the inner flexible vent.

d. Slide the inner flex vent over the adaptor collar at least 1-3/4".

NOTE: Ensure the flex vent is free from damage or tears.

e. Slide the gear clamp down and tighten it fully to secure the flexible vent to the adaptor inner collar approximately 3/4" from the end of the flex.

f. Install three (3) sheet metal screws 120° apart through the flexible vent and into the adaptor collar just below the gear clamp to provide additional security to the connection.

2. Install the outer Flex Pipe.

a. Install the large gear clamp loosely around the outer flexible vent pipe, then push it back out of the way.

b. Apply a bead of Mill-Pac Black (700 °F) high temperature sealant (P/N 10K81) to the outer adaptor collar. Cover to the grooves of the collar that extend approximately 1" from the end and to the flat surface, approximately 1-3/8" from the end.

Apply ONLY MIL-PAC BLACK HIGH TEMPERATURE SEALANT (P/N 10K81) to the outside surface of both collars of the adaptor (fill the grooves of the outer collar to be covered by the flexible pipe) and slide the flexible vent over the inner and outer adaptor collars

NOTE: Outer vent pipe is pulled away to show inner vent pipe details.

c. Pull and extend the outer flexible vent.

d. Slide the outer flexible vent over the adaptor collar. Ensure the flexible vent completely engages the adaptor collar 1-3/4" from the end, and that it is free from damage or tears.

e. Slide the gear clamp down and tighten it fully to secure the flexible vent to the adaptor outer collar approximately 3/4" from the end of the flexible vent.

f. Install three (3) sheet metal screws 120° apart through the flexible vent and into the adaptor collar just below the gear clamp to provide additional security to the connection.

3. Route the flexible vent.

NOTE: Ensure that the flexible vent is properly routed to provide the required clearance. Do NOT allow the flexible vent to bend in a radius tighter than 5" (127 mm) (Figure 26).

Place the internal flexible vent spacers evenly and avoid kinking the inner vent. Support horizontal sections of flexible vent with metal straps at 2 ft (0.61 m) intervals.

4. Install firestop/spacers at ceiling and wall penetrations.

- SF4.5VF firestop/spacer for ceilings
- SF4.5HF firestop/spacer for walls

NOTE: See the appropriate sections and figures shown throughout the venting section for installation requirements.

5. Attach the flexible vent to the termination.

NOTE: **Secure Flex**® components can be purchased separately and attached to bulk lengths of **Secure Flex** flexible vent cut to size at the job site. Attach the flexible vent to the **Secure Flex** terminations as it was attached to the adaptor (Figure 25).

NOTE: Attach **Secure Flex** vent to **Secure Flex** terminations only. Do NOT substitute **Secure Vent** terminations or **Secure Vent** adaptor for **Secure Flex** components. **Secure Flex** termination and adaptor collars are a different circumference than **Secure Vent** collars. **Secure Flex** vent has an longer center tube to improve ease-of-installation.

Step 4. FIELD WIRING

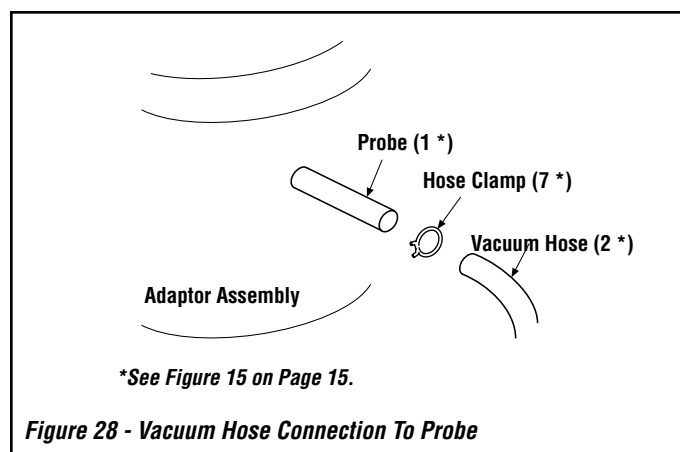
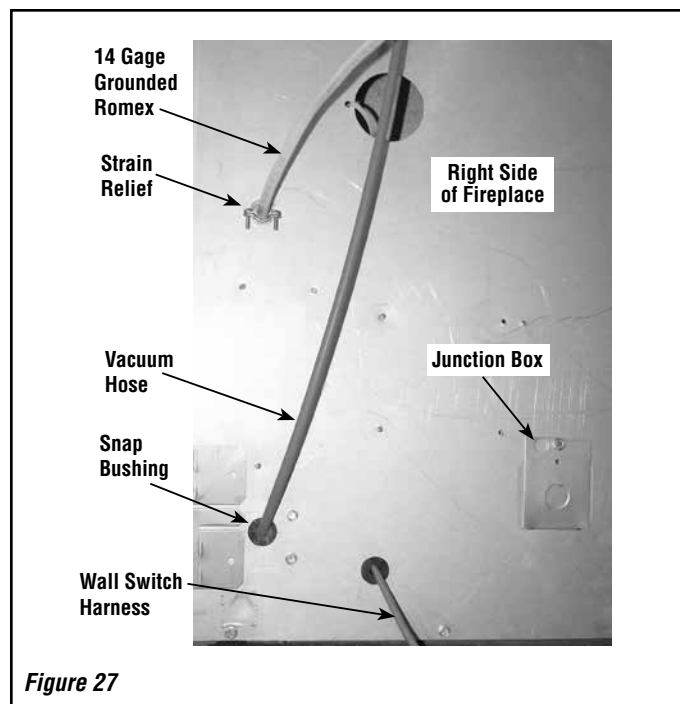
CAUTION: Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation.

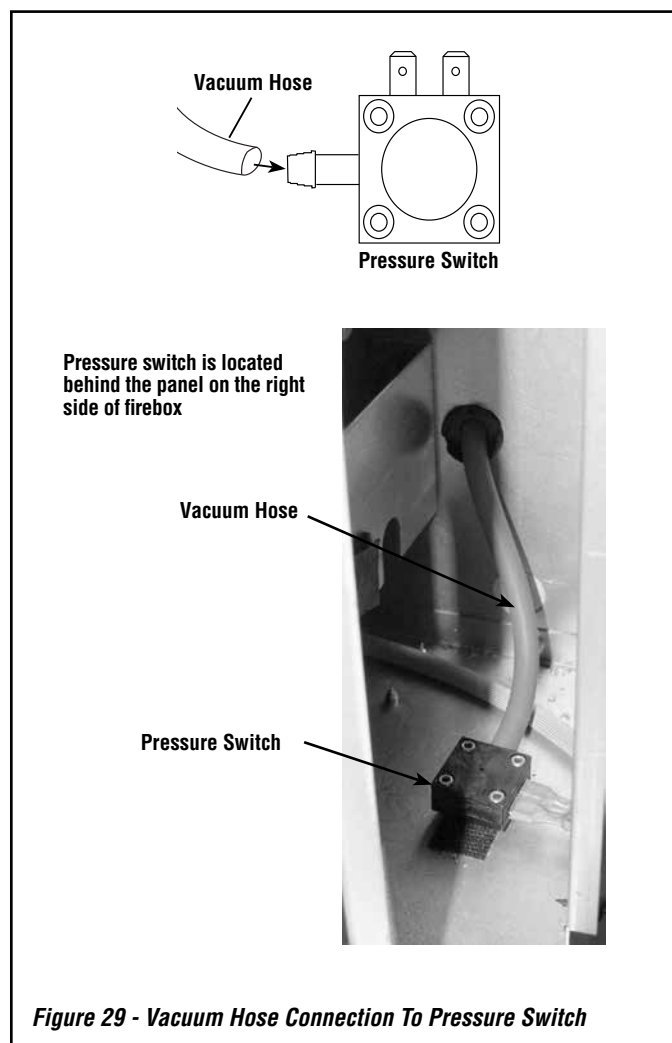
CAUTION: Ground supply lead must be connected to the wire attached to the green ground screw located on the outlet box. See *Figures 34 and 35 on Page 25*. Failure to do so will result in a potential safety hazard. The appliance must be electrically grounded in accordance with local codes or, in the absence of local codes, the National Electrical Code, ANSI/NFPA 70-latest edition (In Canada, the current CSA C22.1 Canadian Electrical Code).



Route Wiring

NOTE: Electrical wiring must be performed by a qualified electrician.

- Install the strain relief in the hole provided on the right side of fireplace for the electrical wiring (*refer to Figure 27*).
- **Standard Instruction** (For use when access to the termination is difficult because of height or other reasons).

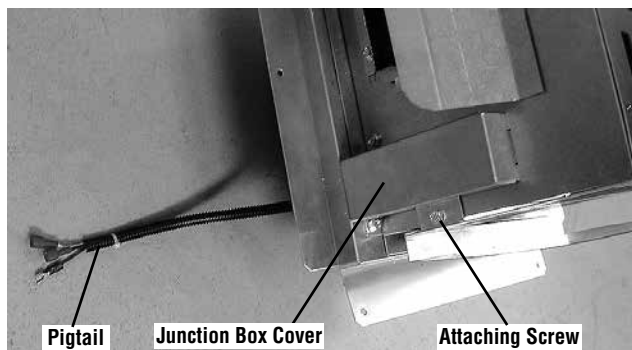


Figure 30 - Bottom of Termination

- Locate a locally procured electrical junction box within reach of the termination wiring pigtail (*refer to Figure 30 on Page 24*) and route the pigtail to the junction box as the termination is installed.
- Route 14 gauge AWG grounded Romex wiring (not provided) from the fireplace to the just installed junction box close to the termination. Ensure the wiring is safety plated to prevent damage by framing nails and finish drywall screws. Route the wire into the lower control compartment and cut to length before installing the terminals. Install provided wiring hardware on the ends of the Romex wire.

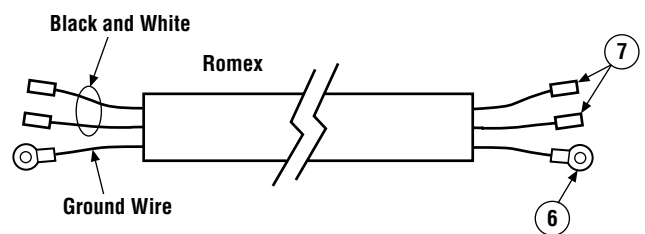


Figure 31 - Romex

- Refer to *Figure 31 on Page 24* and install the electrical hardware on the ends of the Romex wiring. Male terminals on the Black and White wires, and ring terminals on the ground wire.
- Using standard electrical practices and the terminals provided, connect the three wires of the Romex cable to the termination pigtail within the Electrical junction box. Ensure ground.
- The fireplace end of the Romex will be addressed in **Connecting The Power Vent To The Fireplace Control System**.



Wiring: Fireplace (See Figures 34 and 35 on Page 25)

NOTE: These electronic appliances must be connected to the main power supply. The gas valve is set in place and pre-wired at the factory.

1. Route a 3-wire 120Vac 60Hz 1ph power supply to the appliance junction box.
2. Remove the electrical inlet cover plate from the side of the unit by removing the plate's securing screws (see Figure 12 on Page 14).
3. Remove the cover plate's knockout and then feed the power supply wire through the knockout opening and into the unit junction box.
4. Connect the black power supply wire to the **power outlet's** red pigtail lead and the white power supply wire to the **common** terminal of the outlet as shown in Figures 33 and 34.
5. Connect the ground supply wire to the pigtail lead attached to outlet's green ground screw.
6. After the wiring is complete, replace the cover plate.

Wiring: Power Vent Termination

Alternate Instructions (For use when access to the termination is easy and a secondary electrical junction box installation is not desired).

- Remove the junction box cover from the termination by removing the attaching screw (refer to Figure 30).
- Loosen the strain relief on the termination shown in Figure 30. Pull the pigtail in and shorten it to fit within the junction box cover.
- Route 14 gauge AWG grounded Romex wiring (not provided) from fireplace to the J-Box at the termination. Ensure the wiring is safety plated to prevent damage by framing nails and finish drywall screws. Route the wire into the lower control compartment and cut to length before installing the terminals. Install provided wiring hardware on the fireplace end of the Romex wire.
- Refer to Figure 34 on Page 25 and install the electrical hardware on the fireplace end of the Romex wiring. Male terminals (#10) on the Black and White wires, and ring terminals (#9) on the ground wire. The termination end of the Romex will be connected to the termination with wire nuts (not provided).
- Refer to Figure 33 to connect the three wires of the Romex cable to the termination. Ensure the ground ring terminal is grounded beneath a structural screw as shown. Attach the junction box cover to the termination with the screw previously removed.
- The fireplace end of the Romex will be addressed in **Connecting The Power Vent To The Fireplace Control System**.

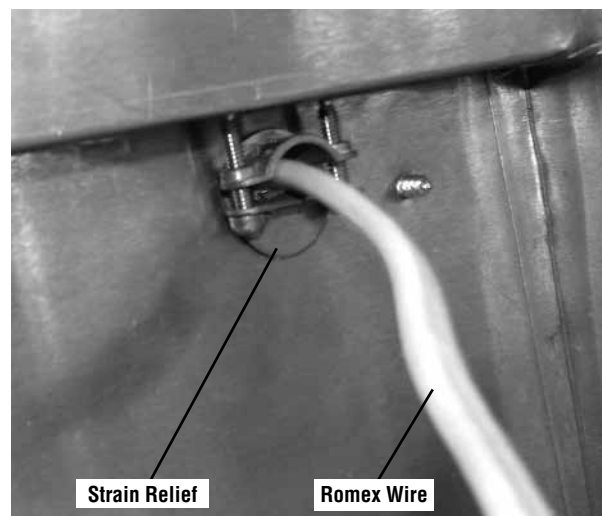


Figure 32 - Back Of Termination

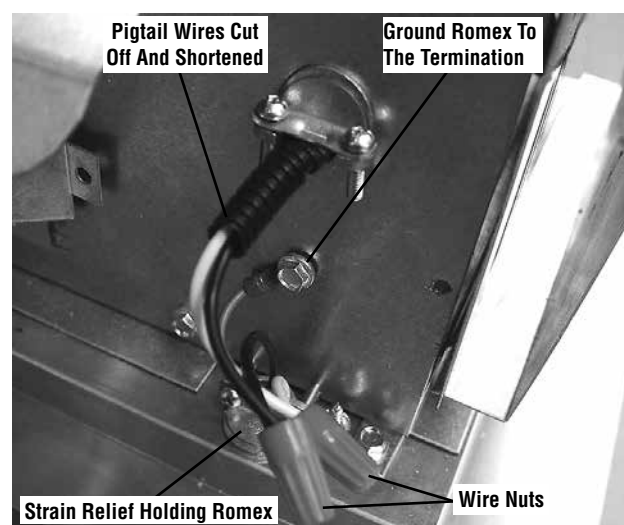
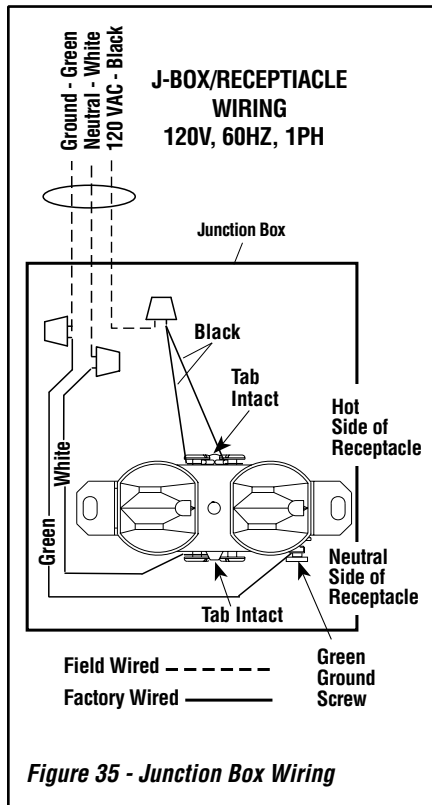
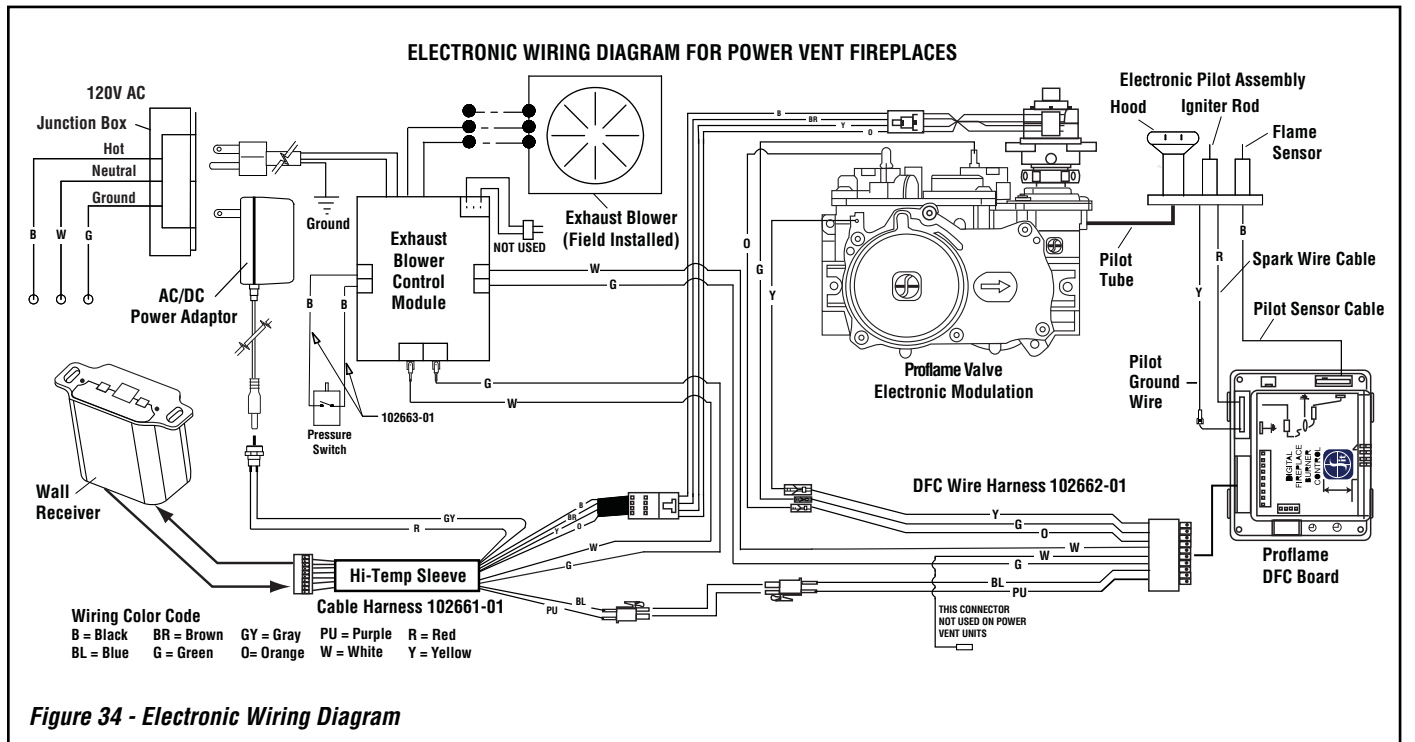


Figure 33 - Junction Box Cover Removed



Step 5. REMOVE GLASS DOOR ASSEMBLY (ON CONTROL SIDE)

! WARNING

- Handle this glass with extreme care! Glass is susceptible to damage – Do not scratch or handle roughly while reinstalling the glass door frame.
- Do not attempt to substitute the materials used on this door, or replace cracked or broken glass with any materials other than those provided by the appliance manufacturer.
- The glass door of this appliance must only be replaced as a complete unit as provided by the manufacturer. Do not attempt to replace broken, cracked or chipped glass separately.

Remove Barrier (see Notice, Page 36)

This fireplace comes with a barrier to reduce the likelihood of burns from touching hot glass. If the barrier is damaged, the fireplace should be turned off immediately and the fireplace must not be operated until a new, approved factory barrier for this unit is installed.

NOTE: It will be necessary to remove the barrier filler trim piece. Upon reinstall, insure that the tabs on the barrier filler are engaged with the slots in the base of the fireplace.

To remove barrier follow these steps.

1. Lift barrier up by the frame at the top.
2. Remove lower filler piece by pulling down off of the barrier.
3. Lower barrier and push barrier to left to release right side.
4. Pull the right side out of fireplace.
5. Remove barrier.

Glass Door Assembly

If not already done, remove the glass door assembly on the control side of the fireplace (see **Page 30**).

Step 6. CONNECT GAS LINE

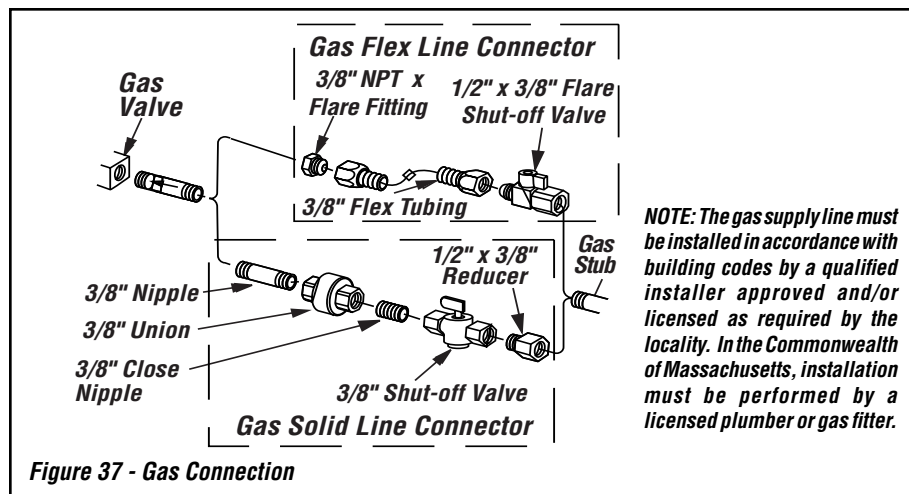


Figure 37 - Gas Connection

All codes require a shut-off valve mounted in the supply line. The orientation of the shut-off valve should face the front. **Figure 37** illustrates two methods for connecting the gas supply. A Sediment Trap is recommended to prevent moisture and debris in gas line from damaging the valve.

The flex-line method is acceptable in the U.S.A. where local codes permit, however, Canadian requirements vary depending on locality. Installation must be in compliance with local codes. These appliances are equipped with a gas flex-line for use in connecting the unit to the gas line.

See **Figure 37** for flex-line description. The flex-line is rated for both natural and propane gas.

A manual shut off valve is also provided with the flex-line. The gas control valve is located on the right side of the unit.

When using solid gas line connector, access the valve by removing the front door assembly on the control side and the access plate (**refer to Figure 36**).

The electronic control valve has a 3/8" (10 mm) NPT thread gas supply inlet.

Secure all joints tightly using appropriate tools and sealing compounds. It is recommended to seal around the gas line to prevent cold air leakage.

Bring the shutoff valve on the end of the flex-line over to the hard pipe and tighten with wrenches from above through the firebox opening.

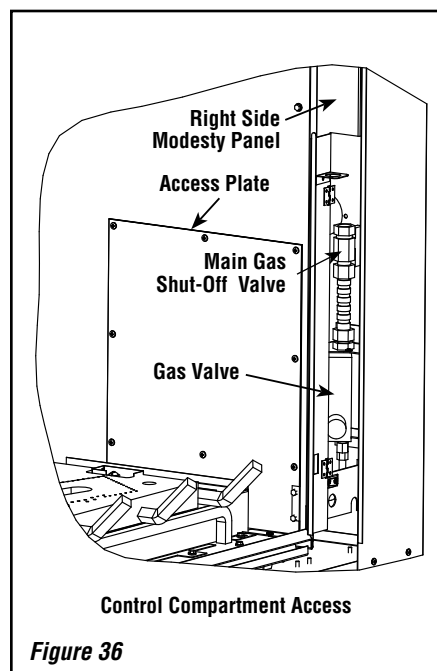

TEST ALL CONNECTIONS FOR GAS LEAKS (FACTORY AND FIELD):



Turn on gas supply and test for gas leaks using a gas leak test solution (also referred to as bubble leak solution). **NOTE:** Using a soapy water solution is an effective leak test solution but it is not recommended, because the soap residue that is left on the pipes/fittings can result in corrosion over time.

- Light the appliance (refer to the lighting instructions label in control compartment or in the Care and Operation Instructions manual).
- Brush all joints and connections with the gas leak test solution to check for leaks. If bubbles are formed, or gas odor is detected, turn the receiver or remote control to the "OFF" position. Either tighten or refasten the leaking connection, then retest as described above.
- When the gas lines are tested and leak free be sure to rinse off the leak testing solution.
- Reinstall the access plate, making certain the gasket has not been damaged.

Step 8. VERIFY APPLIANCE OPERATION

Turn on burner; then observe the individual tongues of flame on the burner. Make sure all ports are open and producing flame evenly across the burner. If any ports are blocked, or partially blocked, clean out the ports.

With gas line installed run initial system check-out before closing up the front of the unit. Follow the pilot lighting instructions provided.

NOTE: Lighting Instructions are also found on the literature tag tied to the bracket above the gas valve. To access the tag, reach into the right side opening.

When first lighting the appliance, it will take a few minutes for the line to purge itself of air. Once purging is complete, the pilot and burner will light and operate as indicated in the instruction manual. Subsequent lighting of the appliance will not require such purging. Inspect the pilot flame (remove logs, if necessary, handling carefully).

Appliance Checkout

To light the burner, refer to the lighting instructions in the Care and Operation Instructions manual or the lighting label located behind right panel. Ensure the igniter lights the pilot. The pilot flame should engulf the flame sensor as shown in **Figure 38**.

Step 7. INSTALL FIREBOX LINER PANELS

Install the ceramic or porcelain liner panels per the instructions provided in the kit (ref. document P/N 506020-46).

NOTICE: Panel liners must be installed before operating fireplace.

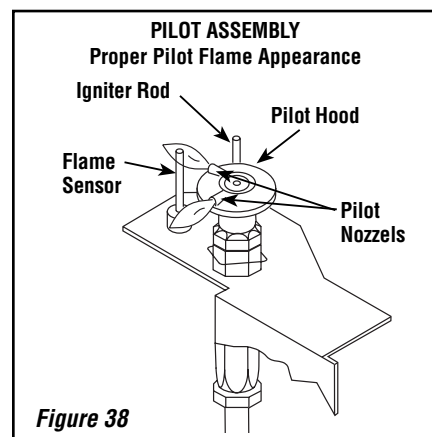

Step 9. INSTALL VOLCANIC STONE, GLOWING EMBERS, AND LOGS

9-1. Remove barrier, modesty panel, and glass door assembly from one side of fireplace. See **Page 30**.

9-2. Locate materials (log set, bag of glowing embers, and bags of volcanic stone).

NOTE: LOGS ARE FRAGILE! Handle with care to prevent breakage.

9-3. Install volcanic stone. Place some of the volcanic stone on the firebox floor around the grate (the entire bag of volcanic stone will NOT be used).

NOTE: Do NOT place volcanic stone on burner.

9-4. Prepare and install glowing embers.

NOTE: This appliance is provided with enough glowing ember material for several applications. Do NOT use the entire contents of a new bag at one time.

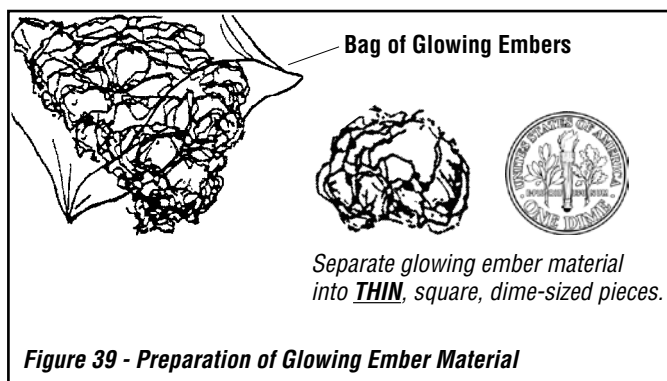


Figure 39 - Preparation of Glowing Ember Material

- Separate some of the glowing ember material into pieces **about the size and thickness of a dime** (see **Figure 39**). Keep the pieces fluffed up, not matted.

! IMPORTANT! Ember pieces must be as SMALL and THIN as a dime.

- Distribute the dime-sized pieces over all burner ports.

NOTE: To prevent flame impingement and soot, do not use more ember material than necessary.

- For best glowing effect, replace ember material annually.

NOTE: Use only catalog number H8312 Platinum Glowing Embers with this fireplace.

! WARNING

- DO NOT attempt to install the logs until the appliance installation has been completed, the gas line connected and tested for leaks, and the initial burner operation has been checked out.
- Logs get very hot and will remain hot up to one hour after gas supply is turned off. Handle only when logs are cool. Turn off all electricity to the appliance before you install volcanic stone, embers and logs.
- The size and position of the log set was engineered to give the appliance a safe, reliable and attractive flame pattern. Any attempt to use a different log set in the fireplace will void the warranty and will result in incomplete combustion, sooting, and poor flame quality.
- This appliance is not designed to burn wood. Any attempt to do so could cause irreparable damage to the appliance and prove hazardous to your safety.
- If logs are not installed according to the log installation instructions, flame impingement and improper combustion could occur and result in soot and/or excessive production of carbon monoxide (CO), a colorless, odorless, toxic gas.

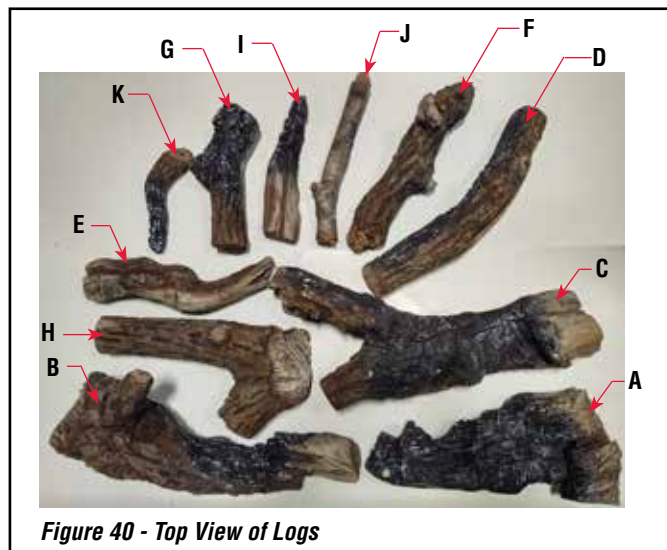


Figure 40 - Top View of Logs

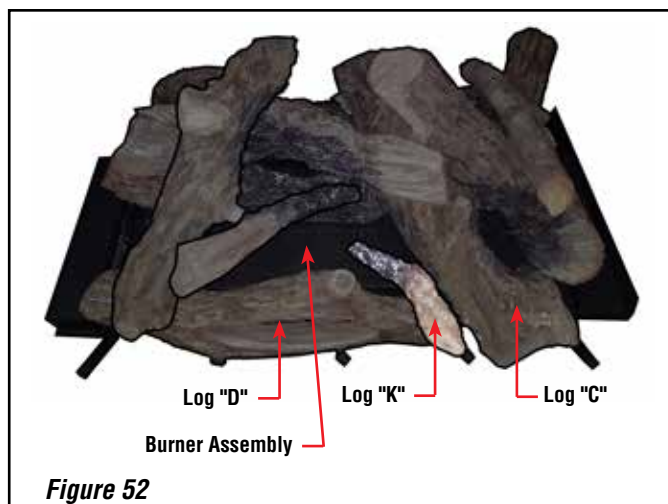
12. Place Log "F" on top of Logs "D" and "A" (see *Figure 50*).

14. Place Log "K" on top of Log "D" and in contact with Log "C". NOTE: The charred end should be resting on the burner assembly (see *Figure 52*).



15. Installation is now complete. Please NOTE that these Logs should not have a large amount of flame impingement and may require slight adjustment to Log position and/or Air Shutter position.

Step 10. INSTALL GLASS DOORS, BARRIER, AND MODESTY PANEL

⚠ WARNING

**HOT GLASS WILL CAUSE BURNS.
DO NOT TOUCH GLASS UNTIL COOLED.**

- Install only when fireplace is **OFF** and **COLD**.
- Fireplace surfaces get **EXTREMELY HOT!**
- The glass on the front of the fireplace reaches **EXTREMELY HIGH** temperatures and can cause severe burns if touched. Even after the gas is turned off, fireplace surfaces remain extremely hot.

⚠ CAUTION

RISK OF PERSONAL INJURY OR PROPERTY DAMAGE.

- Do **NOT** abuse glass doors by striking or slamming shut
- Never operate fireplace with glass door assemblies removed.

These direct-vent appliances are designed to operate only when both glass door assemblies are installed. Generally, the glass door assemblies should not be removed, except when access to components within the firebox is required.

- Securely tighten door latch screws when reinstalling glass door assemblies to prevent doors from falling out.

- Handle glass door assemblies with extreme care. Replace damaged glass door assemblies with approved replacement assemblies only.

The door assemblies on this fireplace contain ceramic glass. Handle with care to prevent damage. If the door frame or glass on either assembly becomes damaged, replace the entire glass door assembly with a manufacturer-approved replacement assembly only. Do not attempt to substitute any materials used on door assemblies or replace cracked or broken glass with any other materials.

- Only doors certified with the appliance shall be used.

Installing Glass Doors, and Modesty Panel (see Figure 53)

NOTE: These instructions do NOT apply to the Outer Glass Door provided in the Out-door Kit (for indoor/outdoor installations).

- 1) Install one of the glass doors, as follows:
 - a) Retrieve the glass door. Visually inspect the gasket on the back of the frame. Gasket surface must be clean, free of irregularities, and seated firmly.
 - b) Position the door in front of the firebox opening, with the top of the door held away from the fireplace (see **Figure 53**).
 - c) Lower the bottom of the door assembly onto the bottom door track, engaging and centering it in the base channel, and then gently swing the door up.
 - d) Using a #3 Phillips screwdriver, fasten the door frame to the door latches with the two (2) latch screws. The latches should pull forward to engage the door frame.

NOTE: Securely tighten latch screws when reinstalling glass door assembly.

- 2) Install the modesty panel on the top flange of the glass door, as follows:
 - a) Grasp the modesty panel with both hands (with the open hem facing down).
 - b) Engage it with the top flange of the glass door frame by pushing it all the way down. Make sure the installed modesty panel is firmly in place.

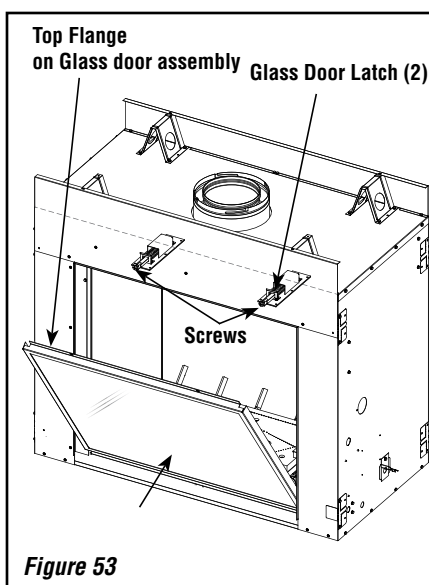

Removing Glass Doors, Barrier, and Modesty Panel (see Figure 53)

- 1) Remove Barrier (see Notice, Page 36)

This fireplace comes with a barrier to reduce the likelihood of burns from touching hot glass. If the barrier is damaged, the fireplace should be turned off immediately and the fireplace must not be operated until a new, approved factory barrier for this unit is installed.

To remove barrier follow these steps.

- a. Lift barrier up by the frame at the top.
- b. Remove lower filler piece by pulling down off of the barrier.
- c. Lower barrier and push barrier to left to release right side.
- d. Pull the right side out of fireplace.
- e. Remove barrier.
- f. Install the new, approved factory barrier with flat side of barrier toward firebox (if appropriate)

- 2) Remove the modesty panel from the top flange of the glass door by firmly pulling up on it with both hands until it is disengaged.

- 3) Remove one of the glass doors, as follows:

- a) See **Figure 53**. While holding the top of the glass door frame in place, use a #3 Phillips screwdriver to remove the two (2) screws securing the door frame to the two (2) door latches.
- b) Carefully tilt the top of the glass door frame away from the unit (as shown in **Figure 53**), and then lift the door assembly up and out of the lower track.
- c) Carefully place the glass door assembly on a padded surface in a safe location to prevent damage.

Step 11. BURNER ADJUSTMENTS

Flame Appearance and Sooting

Proper flame appearance is a flame that is blue at the base and becomes yellowish-orange in the body of the flame. When the appliance is first lit, the entire flame may be blue and will gradually turn yellowish-orange during the first 30 minutes of operation. After 30 minutes of operation, if the flame is blue, or if the flame is orange with evidence of sooting (black tip), the air shutter opening may need to be adjusted.

If the air shutter opening is closed too far, sooting may develop. Sooting is indicated by black puffs developing at the tips of very long orange flames. Sooting results in black deposits forming on the logs, appliance inside surfaces and on exterior surfaces adjacent to the vent termination.

Sooting is caused by incomplete combustion in the flames and lack of combustion air entering the air shutter opening. To achieve a warm yellowish-orange flame with an orange body that does not soot, the shutter opening must be adjusted between these two extremes.

Air Shutter Adjustment Guidelines

- If there is smoke or soot present, first check the log set positioning to ensure that the flames are not impinging on any of the logs. If the log set is properly positioned and a sooting condition still exists, then the air shutter opening should be increased.
- The more offsets in the vent system, the larger the air shutter opening will need to be.
- An appliance operated with the air shutter opened too far, may have flames that appear blue and transparent. These weak, blue and transparent flames are termed anemic.

The following chart is provided to aid you in achieving the correct air shutter adjustment for your installation.

Air Shutter Adjustment Guidelines:		
Amount of Primary Air	Flame Color	Air Shutter Adjustment
If air shutter is closed too far →	Flame will be orange →	Air shutter gap should be increased
If air shutter is open too far →	Flame will be blue →	Air shutter gap should be decreased

Burner Air Shutter Adjustment Procedure

⚠ WARNING

1. Light the appliance (follow lighting procedure in *Care and Operation Instructions* or on lighting label in control compartment).

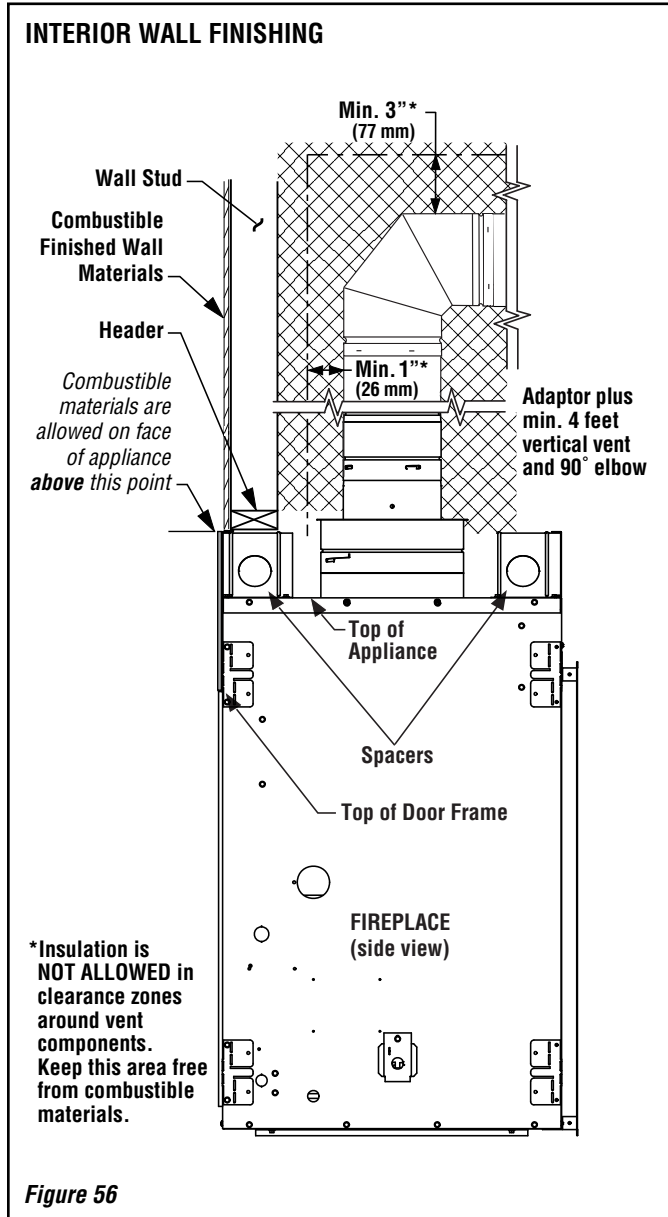


Figure 55 - Burner Flame Appearance - Opposite Control Side

 2. Allow the burner to operate for at least 30 minutes while continuously observing the flame to ensure that the proper flame appearance has been achieved (see **Figures 54 and 55**).
 3. Adjust the air shutter by:
 - a. Cooling unit completely
 - b. AFTER unit is cooled completely, remove door.
 - c. Adjust setting by rotating the air shutter that is located on the right side of burner assembly.
- If the flame appears weak or sooty (as described on the previous page), adjust the air shutter to a more OPEN position until proper flame appearance is achieved.
 - If flame stays lowered blue, **incrementally** adjust the air shutter to a more CLOSED position until proper flame appearance is achieved.

NOTE: See **Figures 54 and 55** for proper burner flame appearance.

OUTDOOR BARRIER INSTALLATION INSTRUCTIONS

NOTE: This procedure requires two people.

- Step 1. If the fireplace is on, turn it OFF. Allow it to cool completely. **BEFORE CONTINUING, FIREPLACE MUST BE OFF AND COLD!**
- Step 2. Remove the two existing screws from the top of the Front Glass Panel.
NOTE: After removing screws, one person must hold the glass panel in place (to prevent it from falling forward and breaking), while another person completes the installation.
- Step 3. Insert the back lip of each Mounting Bracket (without the hole) under the bottom edge of the Glass Panel.
- Step 4. Attach one Spring Nut Clip (with straight edge facing front and down) to the front lip of each Mounting Bracket, and then align the holes.
- Step 5. Slide the openings in the bottom edge of the Safety Guard over the Spring Nut Clips.
- Step 6. Align the holes in the top of the Outdoor Barrier with the holes in the top of the Front Glass Panel. Use a Phillips screwdriver to replace the two screws previously removed.
Align the holes in the lower front of the Outdoor Barrier with the holes in the Clips and Brackets. Use a Phillips screwdriver to install the two supplied Washer Screws.

STEP 12. INSTALLER INSTRUCTIONS - ATTACHING SAFETY IN OPERATION WARNINGS

It is the installer's responsibility to ensure these warnings are properly affixed during installation. These warning labels are a critical step in informing consumers of safe operation of this appliance.

ATTACHING SAFETY IN OPERATION WARNINGS

To properly complete the installation of this fireplace, locate the multi-lingual adhesive labels provided with the Care and Operation Instructions and proceed as follows:

1. Locate the wall receiver that controls the fireplace (verify the switch operates the fireplace by turning it on and off). Clean the wall receiver plate thoroughly to remove any dust and oils. Affix the label to the surface of the plate of the wall receiver that controls the fireplace (**Figure A**). Choose the language primarily spoken in the home. If unknown, affix the English language label.
2. Locate the remote control transmitter and clean it thoroughly to remove any dust and oils. Affix the label to the surface of handheld transmitter (**Figure B**). Choose the language primarily spoken in the home. If unknown, affix the English language label.
3. If you are unable to locate the labels, please call Innovative Hearth Products or your nearest Innovative Hearth Products dealer to receive additional safety instruction labels free of charge.

GENERAL INFORMATION

The fireplace models covered in this manual are direct-vent, sealed combustion gas fireplaces designed for residential application. Direct-vent appliances operate with the combustion chamber completely isolated from the indoor environment.

All air for combustion is brought in from the outside, and exhaust gases are vented through the same direct-vent, coaxial (intake/exhaust) vent system.

These appliances are designed to operate on natural only. The system is switchable between standing and intermittent pilot modes. External electrical power is required to operate these units.

These models come standard with a remotely modulated gas valve. The included transmitter remotely controls flame appearance and heat output (manual gas valve adjustment is not possible).

These appliances comply with National Safety Standards and are tested and listed by PFS TECO (Report No. F14-107) to ANSI Z21.88 (in Canada, CSA-2.33), and CAN/CGA-2.17-M91 (CSA P4.1) in both USA and Canada, as a vented gas fireplace.

The installation must conform to local codes or, in the absence of local codes, with the National Fuel Gas Code, ANSI Z223.1/NFPA 54 - latest edition, or the Natural Gas and Propane Installation Code, CAN/CGA-B149.1 - latest edition. The appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the National Electrical Code, ANSI/NFPA 70 - latest edition, or the Canadian Electrical Code, CSA C22.1 - latest edition.

Gas Pressure Requirements (All Models)

Test gauge connections are provided on the front of the gas control valve, identified IN for the inlet and OUT for the manifold side (see **Table 2** on **Page 6**). The control valve has a 3/8" (10 mm) NPT thread inlet and outlet side of the valve.

The appliance and its appliance main gas valve must be disconnected from the gas supply piping system during any pressure testing of that system at test pressures **in excess of** 1/2 psi (3.5 kPa).

The appliance must be isolated from the gas supply piping system by closing its equipment shutoff valve during any pressure testing of the gas supply piping system at test pressures **equal to or less than** 1/2 psi (3.5 kPa).

Orifice Sizes:

Sea Level to High Altitude (All Models)

These appliances are tested and approved for installations at elevations of 0–4500 feet (0–1372 meters) above sea level using the standard burner orifice sizes.

For higher elevations, contact your gas supplier or qualified service technician.

Deration

At the time of installation, it must be determined if the appliance needs to be derated. Contact your local gas supplier for deration requirements for your area.

At higher elevations, the amount of BTU fuel value delivered must be reduced by either using gas that has been derated by the gas company or by changing the burner orifice to a smaller size as regulated by the local authorities having jurisdiction and by the (USA) National Fuel Gas Code NFPA 54/ANSI Z223.1 - latest edition or, in Canada, the CAN/CGA-B149.1 codes - latest edition.

Burn-in Period

During the first few fires of this appliance there will be some odor due to the curing of the paint and burning off of lubricants used in the manufacturing process. Depending on your use, the burn-in period may take a few hours or a few days.

KEEP YOUR HOUSE WELL VENTILATED DURING THE CURING PROCESS. THE ODOR AND HAZE EMITTED DURING THE CURING PROCESS CAN BE QUITE NOTICEABLE AND MAY SET OFF A SMOKE DETECTOR.

NOTICE: A white film may develop on the glass enclosure panel during the first few fires as part of the burn-in process.

The first few times you use the fireplace, clean the glass after each use (AFTER THE GLASS HAS COMPLETELY COOLED); otherwise, the white film will bake onto the glass and become difficult to remove.

See glass cleaning instructions on **Page 44**.

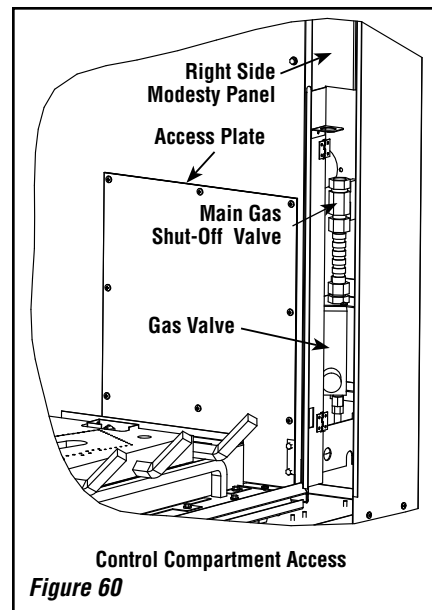

Gas Controls

The gas controls and standard controls for appliance operation are located on the right side of the appliance (when facing the control side), as shown in **Figure 60**.



Appliance Operation

Familiarize yourself with the gas control valve that your appliance uses. Refer to **Figure 60** for access to the gas control valve.

To light the appliance, refer to the detailed lighting instructions (see **Pages 47 and 48**). The appliance lighting instructions may also be found on the pull out lighting instruction labels attached to the gas control valve.

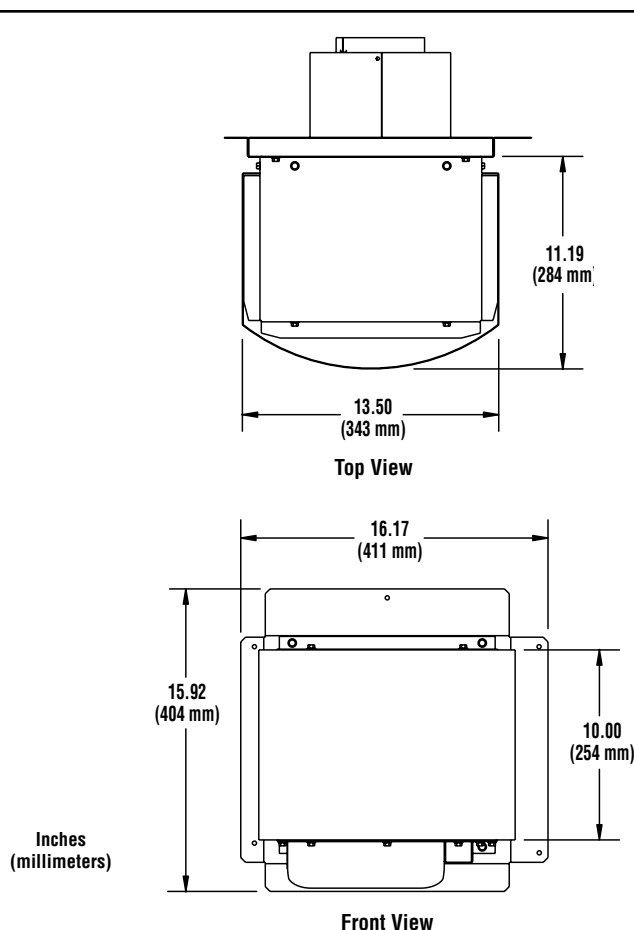


Figure 61 - Power Vent Termination Specifications

These appliances are installed with a power vent termination that has an exhaust blower that expels the exhaust gases from the venting system (see **Figure 61, at right**, and "Purge Cycle," **below**).

PURGE CYCLE

This is a power-vented fireplace that requires household electrical power to operate. When the fireplace is turned OFF, the exhaust blower will continue to operate for up to two minutes, to purge exhaust gases from the venting system. This system will not operate during a power outage.

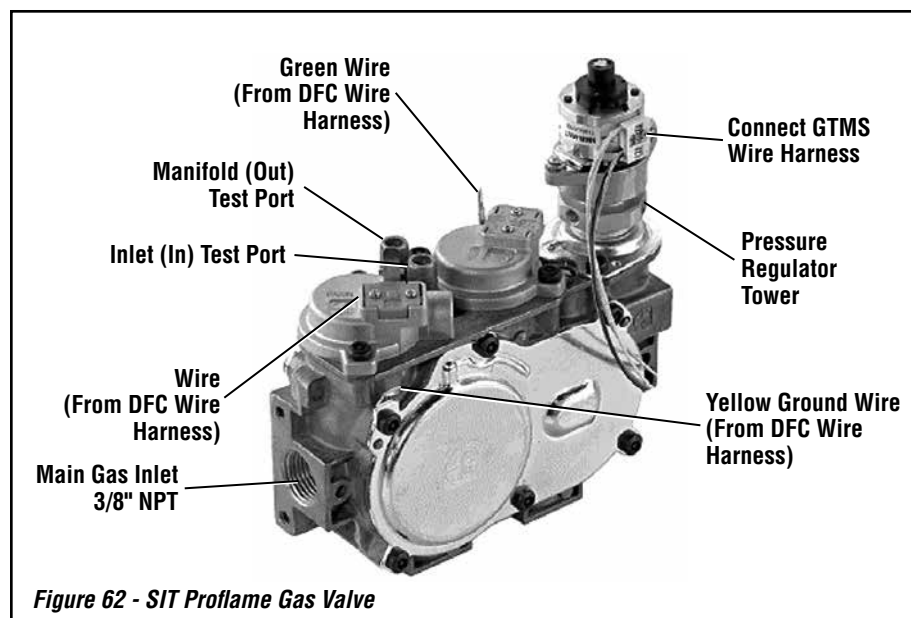


Figure 62 - SIT Proflame Gas Valve

Remote Control System

The Remote Control System allows you to command the functions of your fireplace from the comfort of your chair. It is configured to control the On/Off primary burner operation and flame levels (through six levels) and provide On/Off and Smart control of this appliance.

The receiver connects directly to the gas valve, stepper motor with an umbilical cord wiring harness (see wiring diagram on **Page 45**).

The Receiver is powered by 4 AA type batteries, located within.

The Receiver accepts commands via radio frequency from the Transmitter and does not require line-of-sight operation.

The Receiver three-position slider switch can be set to one of three positions: ON (Manual Override), REMOTE (Remote Control), or OFF.

Initializing the System for the First Time

Install the 4 AA batteries into the receiver battery bay (behind the wall switch plate).

NOTE: Install the batteries into the battery bay as indicated on the battery cover. Ensure that batteries are installed with proper polarity (+/-).

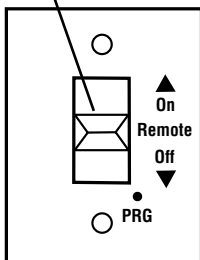


Figure 63 - Receiver

Place the three-position slider switch in the "Remote" position (see **Figure 63, next page**). Using the end of a paper clip, or other similar object, insert the end of the paper clip into the hole marked "PRG" on the Receiver front cover. The Receiver will "beep" three (3) times to indicate that it is ready to synchronize with a Transmitter.

Install the 3 AAA type batteries in the Transmitter battery bay, located on the base of the Transmitter. With the batteries already installed in the Transmitter, push the ON button. The Receiver will "beep" four times to indicate the Transmitter's command is accepted and sets to the particular code of that Transmitter. The system is now initialized.

Low Battery Power Detection

The life span of the Receiver batteries depends on various factors: quality of the batteries used, the number of ignitions of the appliance, the number of changes to the room temperature set point, etc.

When the Receiver batteries are low, no "beep" will be emitted from the Receiver when it receives an ON/OFF command from the Transmitter. This is an alert for a low battery condition for the Receiver. When the batteries are replaced the "beep" will be emitted from the Receiver when the ON/OFF key is pressed (See "Initializing the System for the First Time," **at left**).

When the transmitter batteries are low, a battery icon will appear on the LCD display of the transmitter before all battery power is lost. When the batteries are replaced this icon will disappear.

WARNING

Fire Hazard. Risk of severe injury or death. The Receiver causes ignition of the appliance. The appliance can turn on suddenly. Keep away from the appliance burner when operating the Remote Control System or when activating manual bypass of the Remote Control System.

CAUTION: Property damage hazard. Excessive heat can cause property damage. The appliance can stay lit for many hours. Turn off the appliance if it is not going to be attended for any length of time. Always place the Transmitter where children can not reach it.

Temperature Indicator Display

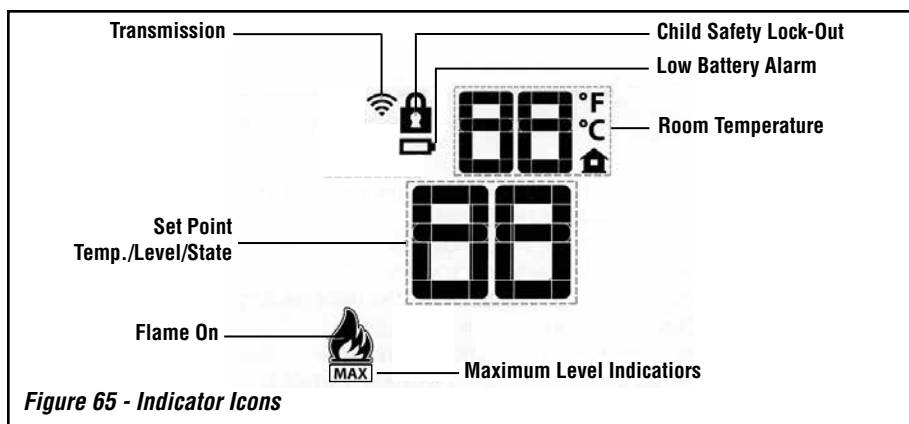


Figure 65 - Indicator Icons

With the system in the "OFF" position, press the Room Temperature Key and the Mode Key at the same time (see **Figure 64, next page**). Look at the LCD screen on the Transmitter to verify that a C or F is visible to the right of the Room Temperature display (see **Figure 65, next page**).

Turn ON the Appliance

With the receiver switch in the "Remote" position, press the ON/OFF Key on the Transmitter. The Transmitter display will show all active icons on the screen. At the same time, the Receiver connects to the gas valve coil and the appliance main burner turns on. A single "beep" from the Receiver will confirm reception of the command.

Turn OFF the Appliance

Press the ON/OFF Key on the Transmitter. The Transmitter LCD display will only show the room temperature and Icon. At the same time, the Receiver disconnects the gas valve coil and the appliance burner turns off. A single "beep" from the Receiver confirms reception of the command.

Remote Flame Control

The system has six (6) flame levels. See **Figure 66 (next page)** for an example. With the system on, and the flame level at the maximum in the appliance, pressing the DOWN Arrow Key once will reduce the flame height by one step until the flame is turned off.

The UP Arrow Key will increase the flame height each time it is pressed. If the Up Arrow Key is pressed while the system is on but the flame is off, the flame will come on in the high position (see **Figure 67, next page**). A single "beep" will confirm reception of the command.

Key Lock

This function will lock the keys to prevent unsupervised operation. To activate this function, press the MODE and UP keys at the same time. To deactivate this function, press the MODE and UP keys at the same time.

Manual Bypass of the Remote System

If the batteries of the Receiver or Transmitter are low or depleted, the appliance can be turned on manually by sliding the three position slider switch to the ON position. This will bypass the remote control feature of the system and the appliance main burner will come on if the gas valve is in the "ON" position.

Figure 64 - Remote Transmitter

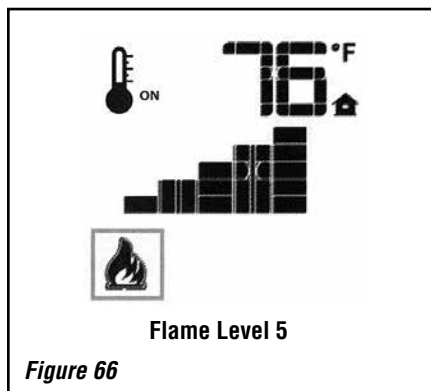

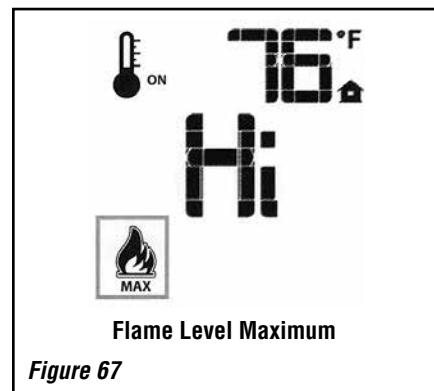

POWER VENT APPLIANCE OPERATING INSTRUCTIONS

To turn ON the Appliance:

Using the Receiver: Manually slide the three-position slider to the "ON" position.

Using the Remote Transmitter: Manually slide the three-position slider on the Receiver to the "ON" position, and then press the ON/OFF key on the Remote Transmitter.

The blower should start immediately. The igniter will start sparking, and then the pilot will light. After a few seconds, the burner should light.

To turn OFF the Appliance:

Using the Receiver: Manually slide the three-position slider to the "OFF" position.

Using the Remote Transmitter: Press the ON/OFF key.

The burner and pilot should turn off immediately. The blower will continue to run for about 90 seconds and then stop.

MAINTENANCE

(See Maintenance Schedule and Instructions, Page 49)

Refer to the maintenance schedule for maintenance tasks, procedures, frequency and by whom they should be performed. Always verify proper operation of the appliance after servicing.



WARNING

Turn off gas and electrical power to the fireplace and allow it to cool before cleaning or servicing the appliance.

CAUTION: Wear gloves and safety glasses for protection while doing required maintenance.

Verify proper operation after servicing.

Always turn OFF gas to the pilot before cleaning. Before relighting, refer to the lighting instructions in this manual. Instructions are also found on a pull-out panel located in the control compartment.

Inspect Venting System

NOTE: Prior to the first use of the fireplace and each burn season and periodically during the burn season, inspect the horizontal termination for debris such as bird nests, leaves, paper or branches.

The appliance and venting system should be thoroughly inspected before initial use and at least annually by a qualified service technician (inspection should include ensuring that exhaust or intake passages are unobstructed and vent components are properly assembled and not damaged). **Homeowner must contact a qualified service technician at once if any abnormal condition is observed.**

If the venting system is disassembled for any reason, a qualified service technician should follow vent installation instructions for proper reassembly and proper sealing of the venting system components. However, more frequent periodic inspections and cleanings should be performed by the homeowner.

Glass Cleaning

(For detailed glass door assembly removal/installation instructions, see Page 44).

NOTE: Clean glass after first two weeks of operation (after burn-in period is over) and then only when necessary and **ONLY WHEN THE APPLIANCE IS COOL**. Wipe surface with clean, dampened, soft cloth. Follow with dry, soft towel as desired. Take care not to scratch the glass surface.

IMPORTANT: Do not use abrasive cleaners on glass. Never clean the glass when it is hot.

Clean the glass periodically, to remove any buildup caused by the following:

- *Filmy coating (during initial use after installation).* Initial curing of the high temperature paint and burning off of lubricants used in the manufacturing process may result in a filmy coating on the glass.
- *Dusty or dirty buildup.* It is normal for condensation and fog to form on the inside of the glass when first starting the appliance. This condensation and fog will usually disappear within a few minutes; however, over time the moisture can cause lint, dust, and other airborne particles to cling to the glass surface.
- *White coating.* A white coating may form on the glass as a result of impurities and minerals in the fuel.

It is recommended that the glass be cleaned two or three times during each heating season, depending on the circumstances. The following cleaning solutions are approved for use to clean the glass:

- Non-ammonia based household cleaner
- 50% white vinegar and 50% water
- Gas fireplace/stove glass cleaner

Inspect Glass Gasket

Visually inspect the gasket on the backside of the glass enclosure panels. The gasket surface must be clean, free of irregularities and seated firmly.

Clean Control Compartment

Keep control compartment clean by vacuuming or brushing at least twice a year. More frequent cleaning may be required due to excessive lint from carpeting, bedding materials, etc. It is important that control compartments, burners and circulating air passageways of the appliance be kept clean.

Clean Logs and Burner

Carefully remove the logs (use care when handling the fiber logs, as they become quite fragile after curing). Vacuum out any foreign matter (lint, carbon, etc.) on the burner. Ensure the burner ports are "open." Remove any carbon deposits from the under side of the logs using a vacuum cleaner, or a soft bristled brush (i.e. paint brush).

NOTE: Improper positioning of logs can create carbon build-up and will alter the performance of the appliance.

Replacing Logs

If the logs become damaged by accident or improper handling and need replacement, use only the proper replacement logs from manufacturer (see Pages 45 and 57 for ordering information).

Reinstall Embers, Volcanic Stone, and Logs

Carefully follow placement instructions on Pages 27–29. All logs should fit onto corresponding pins and/or log stoppers. This will ensure a proper flame and safe combustion.

Inspect Wiring

Refer to wiring diagram on Page 25.

CAUTION: Label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation. Verify proper operation after servicing.

Inspect and clean all wire connections. Ensure that there is no melting or damage. Inspection should include terminals at the valve.

Inspect Burner Flame and Pilot Flame Appearance

Periodically do a visual check of the burner flame and the pilot flame. Ensure that the burner flame appearance resembles the flame shown in Figures 54 and 55 and as described in Flame Appearance and Sooting on Page 31. Refer to Figure 38 on Page 26 for more information about the pilot flame appearance. Contact a qualified service technician at once if any abnormal condition is observed.

Small Area Paint Touch-up

Only use a factory supplied paint kit for touch-ups. Paint is available at your local Innovative Hearth Products dealer. Never attempt to paint a hot fireplace.

If the surface later becomes stained or marred, it may be lightly sanded and touched up with spray paint.

REMOVAL AND INSTALLATION OF GLASS DOORS, BARRIER, AND MODESTY PANEL

Removing Glass Doors, Barrier, and Modesty Panel (see Figure 68)

- 1) Remove the barrier, as follows:
 - a) Lift barrier up by the frame at the top.
 - b) Remove lower filler piece by pulling down off of the barrier.
 - c) Lower barrier and push barrier to left to release right side. Remove barrier and set aside for reinstallation
- 2) Remove the modesty panel from the top flange of the glass door by firmly pulling up on it with both hands until it is disengaged.
- 3) Remove one of the glass doors, as follows:
 - a) See **Figure 68**. While holding the top of the glass door frame in place, use a #3 Phillips screwdriver to remove the two (2) screws securing the door frame to the two (2) door latches.
 - b) Carefully tilt the top of the glass door frame away from the unit (as shown in **Figure 68**), and then lift the door assembly up and out of the lower track.
 - c) Carefully place the glass door assembly on a padded surface in a safe location to prevent damage.

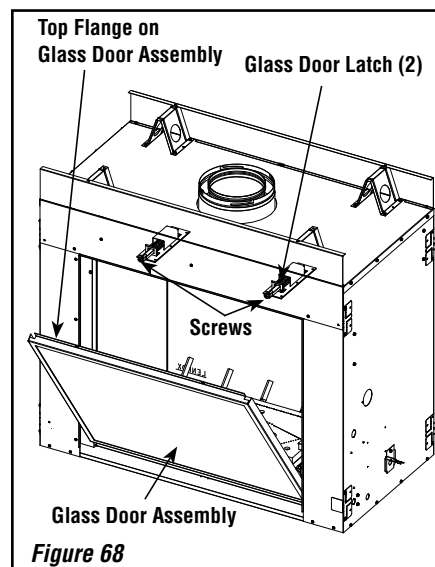

Installing Glass Doors, Barrier, and Modesty Panel (see Figure 68)

 - c) Lower the bottom of the door assembly onto the bottom door track, engaging and centering it in the base channel, and then gently swing the door up.
 - d) Using a #3 Phillips screwdriver, fasten the door frame to the door latches with the two (2) latch screws. The latches should pull forward to engage the door frame.

NOTE: Securely tighten latch screws when reinstalling glass door assembly.

- 2) Install the modesty panel on the top flange of the glass door, as follows:
 - a) Grasp the modesty panel with both hands (with the open hem facing down).
 - b) Engage it with the top flange of the glass door frame by pushing it all the way down. Make sure the installed modesty panel is firmly in place.
- 3) Install the barrier, as follows:
 - a) Slide the barrier, flat side toward the fireplace, into the right barrier bracket with gap below.
 - b) Reinsert the lower filler piece by sliding the tab behind the barrier.
 - c) Center the barrier between the left and right barrier brackets and lower the barrier until the lower filler piece and barrier are flush with the bottom of the glass door.

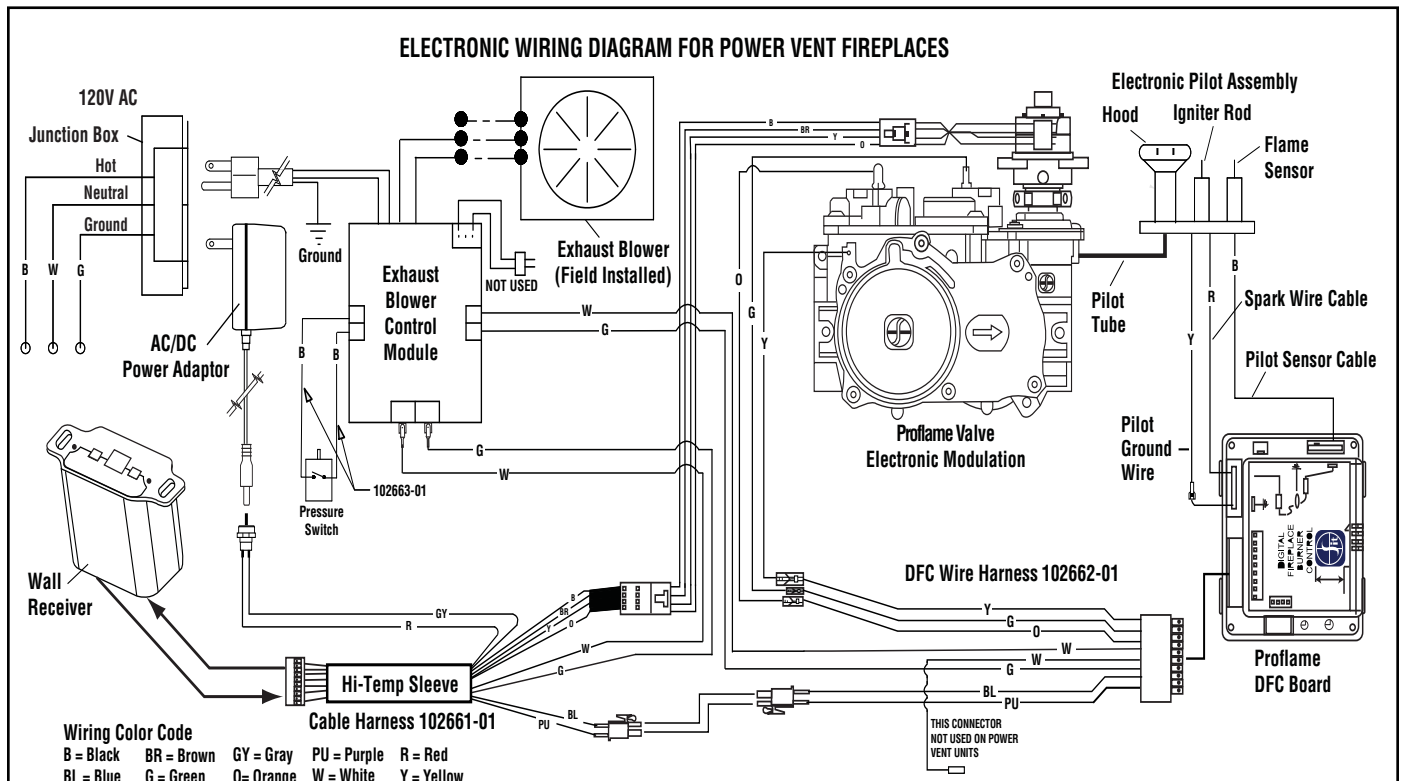


Figure 69 - Electronic Wiring Diagram

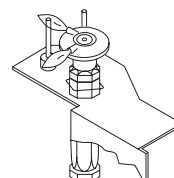
Electronic Gas Control Valve - SIT Proflame



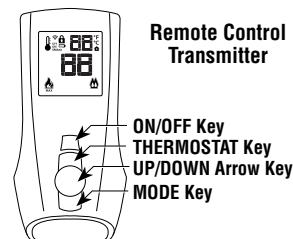

Inspect/Clean Pilot and Burner	Qualified Service Technician	Refer to Figure 38 on Page 26 . Remove any surface build-up on pilot and burner assembly. Wipe the pilot nozzles, igniter/flame rod and hood. Ensure the pilot flame engulfs the flame sensor as shown.
Check Vent System	Qualified Service Technician	Inspect the vent system at top and base (within the firebox) for signs of blockage or obstruction. Look for any signs of dislocation or deterioration of the vent components. Reconnect or replace, as necessary. NOTE: Excessive condensation can cause corrosion of caps, pipe and fittings (excessive condensation can be caused by long lateral runs, too many elbows and/or exterior portions of the system being exposed to cold weather). Also inspect wall straps or plumbers's tape to ensure it is secure and in place.

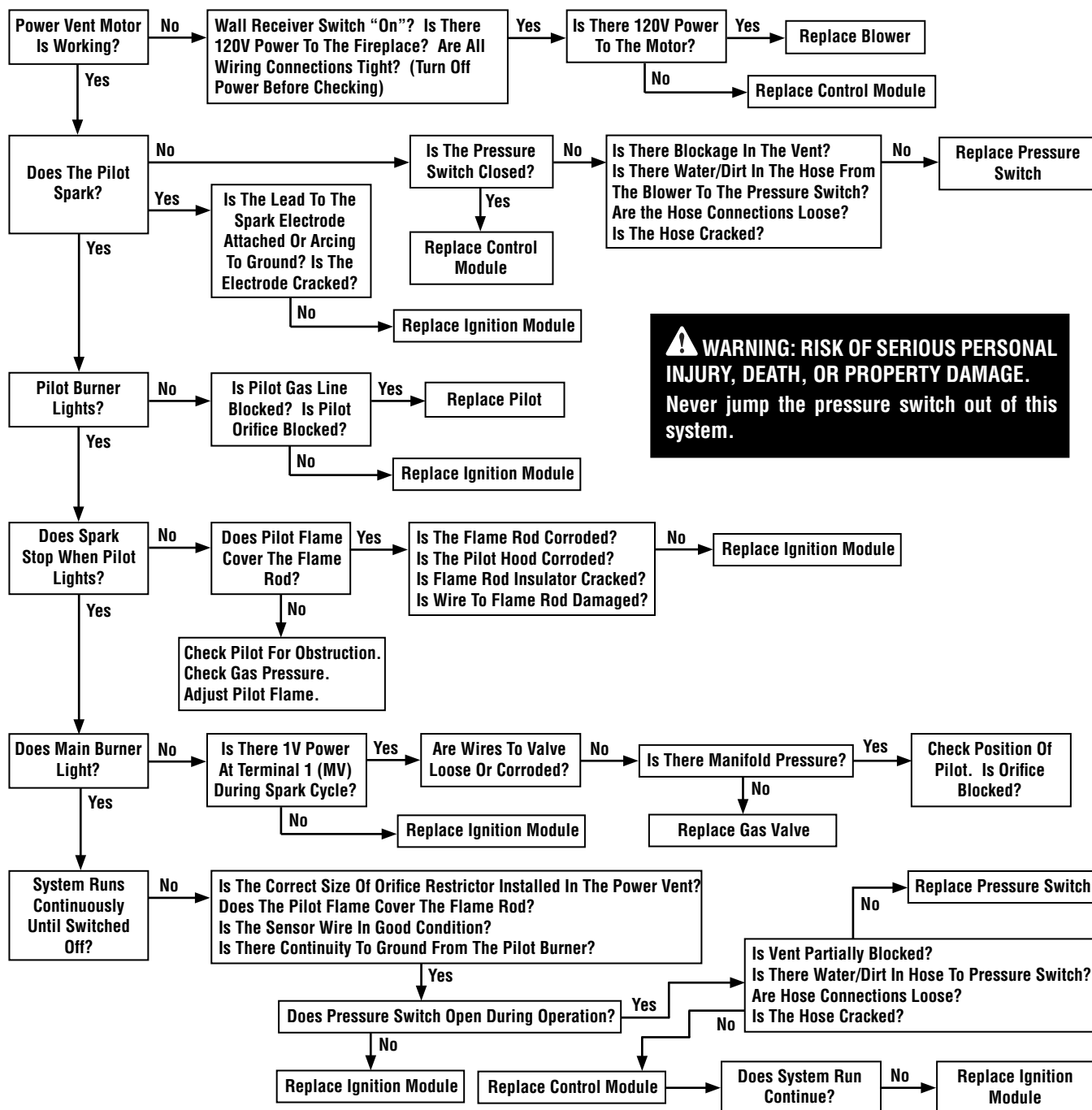

4. If this is the first time the unit has been fired, check the unit wiring against the wiring diagram before performing any troubleshooting.

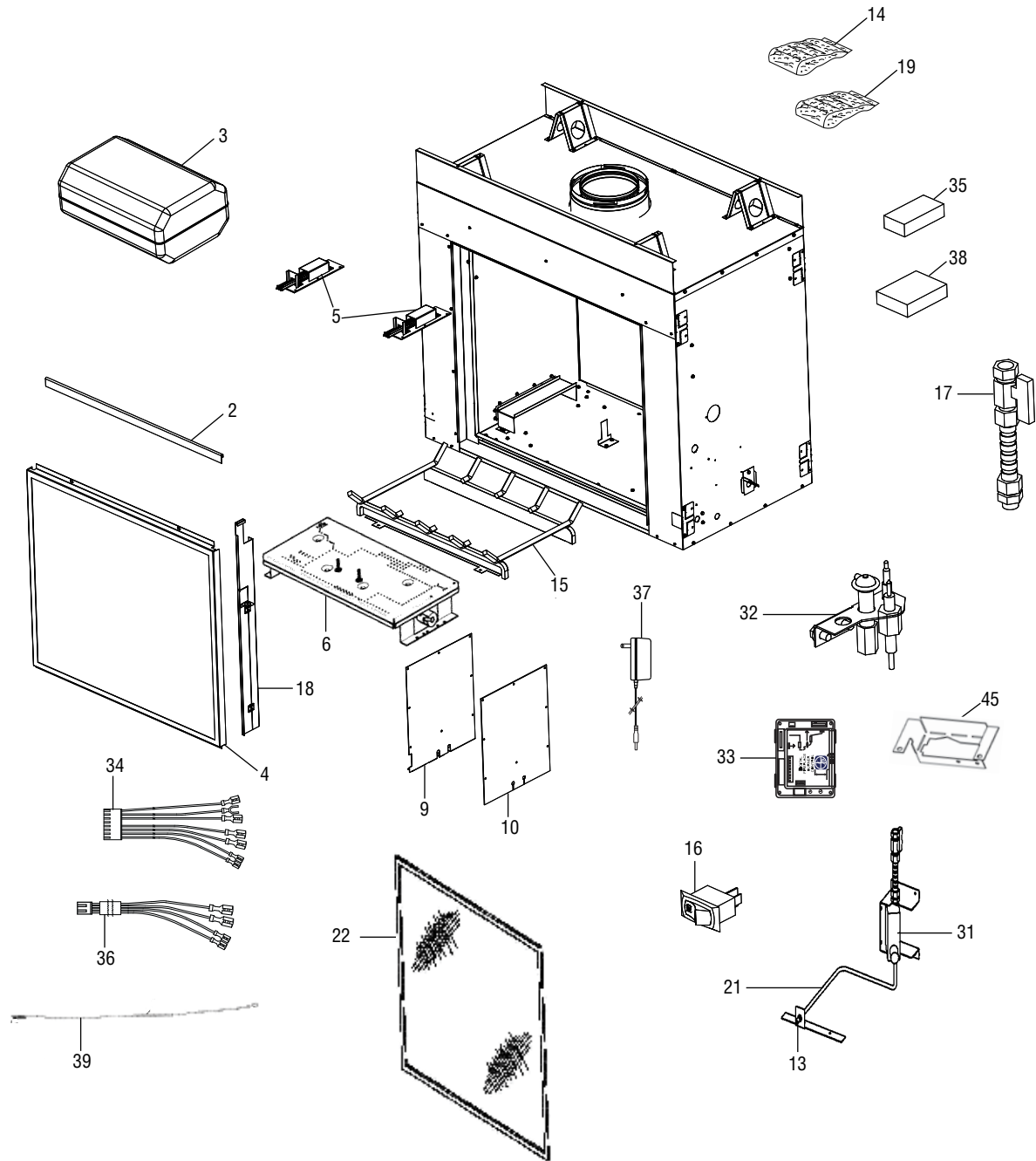

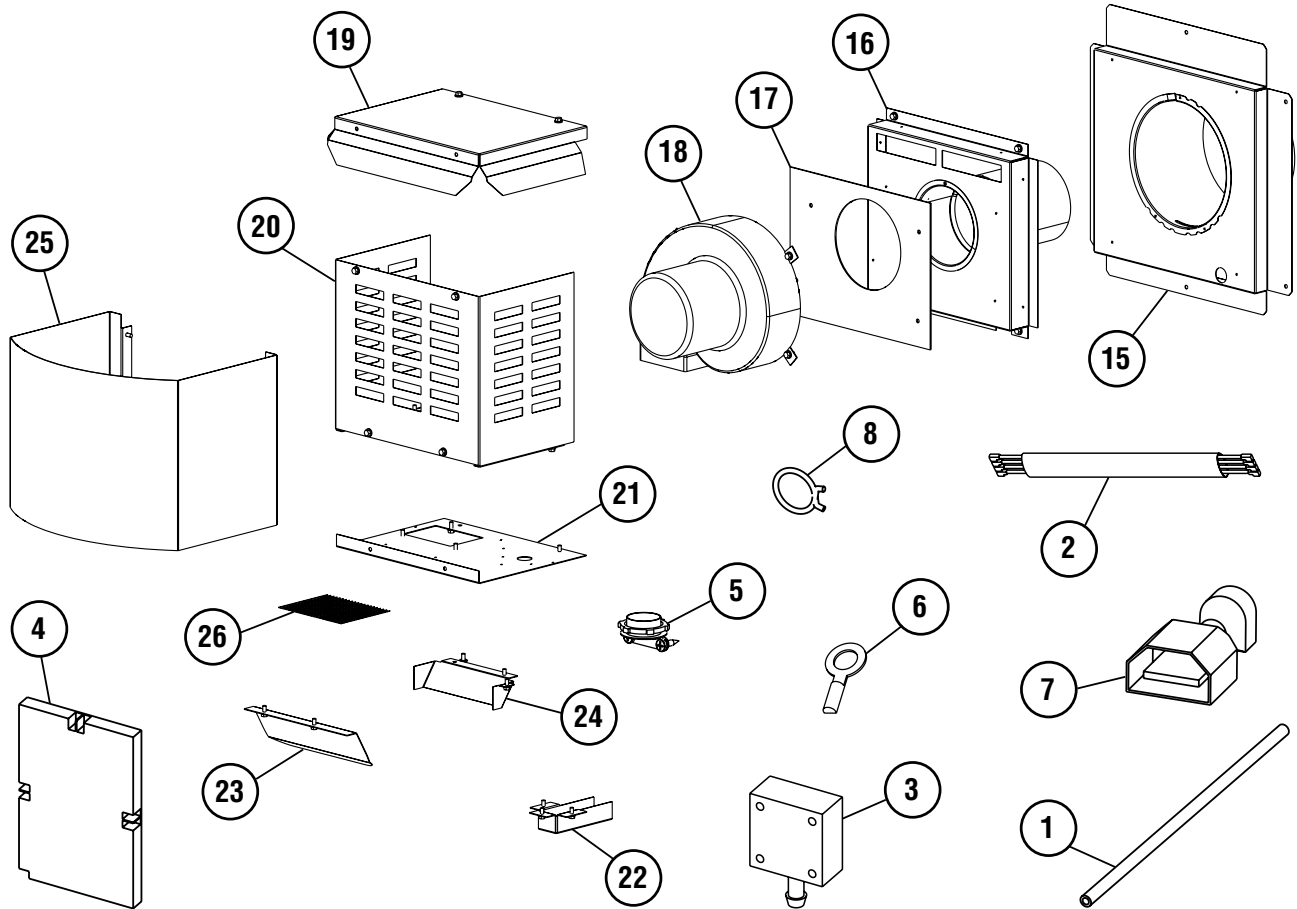

20 Year Limited Warranty

THE WARRANTY

Innovative Hearth Products ("IHP") 20 Year Limited Warranty warrants your Superior® Brand gas fireplace, Stove or Insert ("Product") to be free from defects in materials and workmanship at the time of manufacture. The product body, firebox and barrier carry the 20 Year Limited Warranty. Ceramic glass carries the 20 Year Limited Warranty against thermal breakage only. After installation, if covered components manufactured by IHP are found to be defective in materials or workmanship during the 20 Year Limited Warranty period and while the Product remains at the site of the original installation, IHP will, at its option, repair or replace the covered components. If repair or replacement is not commercially practical, IHP will, at its option, refund the purchase price or wholesale price of the IHP product, whichever is applicable. IHP will also pay IHP prevailing labor rates, as determined in its sole discretion, incurred in repairing or replacing such components for up to five years. THERE ARE EXCLUSIONS AND LIMITATIONS to this 20 Year Limited Warranty as described herein.

COVERAGE COMMENCEMENT DATE

Warranty coverage begins on the date of purchase. In the case of new home construction, warranty coverage begins on the date of first occupancy of the dwelling or six months after the sale of the Product by an independent IHP dealer/distributor, whichever occurs earlier. The warranty shall commence no later than 24 months following the date of product shipment from IHP, regardless of the installation or occupancy date.

EXCLUSIONS AND LIMITATIONS

This 20 Year Limited Warranty applies only if the Product is installed in the United States or Canada and only if operated and maintained in accordance with the printed instructions accompanying the Product and in compliance with all applicable installation and building codes and good trade practices.

This warranty is non-transferable and extends to the original owner only. The Product must be purchased through a listed supplier of IHP and proof of purchase must be provided. The product body, firebox and barrier carry the 20 Year Limited Warranty from the date of installation. Vent components, trim components and paint are excluded from this 20 Year Limited Warranty. The following do not carry the 20 Year Limited Warranty but are warranted as follows:

Burner – Repair or replacement for one year from the date of installation
Gas components – Repair or replacement for one year from the date of installation
Gaskets – Repair or replacement for one year from the date of installation
Logs – Replacement for one year from the date of installation against thermal breakage only
Optional blowers & remote controls – Repair or replacement for one year from the date of installation
Optional glass doors – Repair or replacement for 90 days from the date of installation
Tempered glass – Replacement for one year from the date of installation
Labor coverage – Prevailing IHP labor rates apply for the warranty period of the component

Parts not otherwise listed carry a 90 day warranty from the date of installation.

Whenever practicable, IHP will provide replacement parts, if available, for a period of 10 years from the last date of manufacture of the Product.

IHP will not be responsible for: (a) damages caused by normal wear and tear, accident, riot, fire, flood or acts of God; (b) damages caused by abuse, negligence, misuse, or unauthorized alteration or repair of the Product affecting its stability or performance (The Product must be subjected to normal use. The Product is designed to burn either natural or propane gas only. Burning conventional fuels such as wood, coal or any other solid fuel will cause damage to the Product, will produce excessive temperatures and could result in a fire hazard.); (c) damages caused by failing to provide proper maintenance and service in accordance with the instructions provided with the Product; (d) damages, repairs or inefficiency resulting from faulty installation or application of the Product.

IHP is not responsible for inadequate fireplace system draft caused by air conditioning and heating systems, mechanical ventilation systems, or general construction conditions which may generate negative pressure in the room in which the appliance is installed. Additionally IHP assumes no responsibility for drafting conditions caused by venting configurations, adjoining trees or buildings, adverse wind conditions or unusual environmental factors and conditions that affect the operation of the unit.

This 20 Year Limited Warranty covers only parts and labor as provided herein. In no case shall IHP be responsible for materials, components or construction, which are not manufactured or supplied by IHP or for the labor necessary to install, repair or remove such materials, components or construction. Additional utility bills incurred due to any malfunction or defect in equipment are not covered by this warranty. All replacement or repair components will be shipped F.O.B. from the nearest stocking IHP factory.

LIMITATION ON LIABILITY

It is expressly agreed and understood that IHP's sole obligation and the purchaser's exclusive remedy under this warranty, under any other warranty, expressed or implied, or in contract, tort or otherwise, shall be limited to replacement, repair, or refund, as specified herein.

In no event shall IHP be liable for any incidental or consequential damages caused by defects in the Product, whether such damage occurs or is discovered before or after repair or replacement, and whether such damage is caused by IHP's negligence. IHP has not made and does not make any representation or warranty of fitness for a particular use or purpose, and there is no implied condition of fitness for a particular use or purpose.

IHP makes no expressed warranties except as stated in this 20 Year Limited Warranty. The duration of any implied warranty is limited to the duration of this expressed warranty.

No one is authorized to change this 20 Year Limited Warranty or to create for IHP any other obligation or liability in connection with the Product. Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above limitations or exclusions may not apply to you. The provisions of this 20 Year Limited Warranty are in addition to and not a modification of or subtraction from any statutory warranties and other rights and remedies provided by law.

INVESTIGATION OF CLAIMS AGAINST WARRANTY

IHP reserves the right to investigate any and all claims against this 20 Year Limited Warranty and to decide, in its sole discretion, upon the method of settlement.

To receive the benefits and advantages described in this 20 Year Limited Warranty, the appliance must be installed and repaired by a licensed contractor approved by IHP.

Contact IHP at the address provided herein to obtain a listing of approved dealers/distributors. **IHP shall in no event be responsible for any warranty work done by a contractor that is not approved without first obtaining IHP's prior written consent.**

HOW TO REGISTER A CLAIM AGAINST WARRANTY

If you cannot locate the dealer/distributor, then you must notify IHP in writing. IHP must be notified of the claimed defect in writing within 90 days of the date of failure.
